Dear Mr. Fensterwald:

Reference is made to your Freedom of Information-Privacy Acts (FOIPA) requests, on behalf of your clients Mr. J. Gary Shaw of Cleburne, Texas, and Mr. Mark Allen of Washington, D.C., which are discussed below. All of these requests are at issue in the United States District Court (USDC) for the District of Columbia in Civil Action (CA) 82-2109, one of the cases consolidated with CA 82-1602. This letter is to advise you of the final disposition of each request, at issue in this lawsuit, as reached by the Federal Bureau of Investigation (FBI).

FOIPA request to New Orleans (NO);
Anti-Communist League of Caribbean
during period 1960-65.

By letter dated March 29, 1982, from the NO field office, you were advised that a search of the indices in the NO office failed to locate any information indentifiable with the subject of your request.

FOIPA request to NO; Maurice Brooks
Gatlin

By letter dated August 23, 1982, from the NO office, you were advised that the NO file pertaining to Mr. Gatlin had been destroyed and that your request was forwarded to FBI Headquarters (HQ) for handling. FBIHQ is processing those files pertaining to Mr. Gatlin, which are maintained at FBIHQ, as well as those files which are maintained in FBI field offices, other than NO. All processing is being handled under FOIPA request number 225,237. In view of these facts, your

request, directed to the NO office, has been placed in a closed status. The above information was previously furnished to you by FBIHQ letter dated January 18, 1983.

FOIPA request to NO; Existence of
Lee Harvey Oswald imposter.

By letter dated July 8, 1982, from the NO office of the FBI, you were informed that one "see" reference, possibly identifiable with the subject of your request, had been located in the files that had been forwarded to FBIHQ in their entirety. This reference is identical to the material being handled under FBIHQ FOIPA request number 225,428 at issue in CA 82-2110.

FOIPA request to NO; Schlumberger
Well Services during period 1959-64.

By letter dated April 5, 1982, from the NO field office, you were advised that a search of the indices in the NO office failed to locate any information identifiable with the subject of your request.

FOIPA request to NO; Jerry Milton
Brooks.

A search of the indices of the NO office of the FBI located one "see" reference, identifiable with the subject of your request, located in the files that have been forwarded to FBIHQ in their entirety. A review of this reference indicates that the serial is identical to material previously handled under FBIHQ FOIPA request number 225,558. Enclosed is material which will assist you in identifying this document.

FOIPA request to NO; Hugh Ward.

By letter dated April 5, 1982, from the NO field office, you were advised that a search of the indices in the NO office failed to locate any information identifiable with the subject of your request.

FOIPA request to NO; Jacques Roy.

Based on the information furnished by you, a search of the indices in the NO office failed to locate any information, relative to the John Kennedy assassination, identifiable with the subject of your request.

FOIPA request to Miami (MM); Alpha-66
during period 1960-64.

By letter dated June 7, 1982, from the MM office of the FBI, you were advised that a search of the indices in the MM office failed to locate any information identifiable with the subject of request. The indices search was limited to the specific time frame as stated in your request letter.

FOIPA request to MM; Miqueal Casas Saez.

Based on the information furnished by you, a search of the indices in the MM office failed to locate any information, relative to the John Kennedy assassination, identifiable with the subject of your request.

FOIPA request to New York (NY);
Spas T. Raikin.

A search of the indices of the NY office of the FBI located one "see" reference, identifiable with the subject of your request. This reference was forwarded to FBIHQ for handling by the NY office on January 24, 1983. A review of this reference indicates that the serial is identical to material previously handled under FBIHQ FOIPA request number 226,387 and furnished to you by FBIHQ letter dated February 9, 1983. Enclosed is material which will assist you in identifying this document.

FOIPA request to NY; Gloria Orsony.

Based on the information furnished by you, a search of the indices in the NY office failed to locate any information, relative to the John Kennedy assassination, identifiable with the subject of your request.

FOIPA request to Houston (HO);
Gloria Orsony.

Based on the information furnished by you, a search of the indices in the HO office failed to locate any information, relative to the John Kennedy assassination, identifiable with the subject of your request.


FOIPA request to HO; Schlumberger
Well Services during period 1959-64.

By letter dated April 1, 1982, from the HO field office, you were advised that a search of the indices in the HO office failed to locate any information identifiable with the subject of your request.

As discussed at the last status hearing before Judge Greene, on January 5, 1983, the FBI is to notify the Court and yourself when all requests in a particular civil action are placed in a closed status. Based on our review as well as the above-stated facts, all requests in CA 82-2109 have been placed in a closed status. This letter constitutes notification to you and a copy will promptly be filed with the Court. It is requested that you advise the FBI as to the extent to which a Vaughn affidavit will be needed for any of the requests in CA 82-2109.
