1. 100-10461-1066

This is listed as a referral on the Oswald Dallas Referrals worksheet. The Cross-Reference worksheet and the original worksheet (volume 12) have actual pages: 1, released pages: 1, under claims to exemption they state: "par 2 referral CIA." However, there is no document given in Dallas as serial 1066 nor is there any cross-reference as to where it can be found.

2. 100-10461-2502

Referral worksheet has 2 pages as actual number, blank released, referral to INS. The original and C-R worksheets both state that 2 pages were released with paragraphs 4 & 5 on page 2 referred to INS.

3. 100-10461-3563

The Referral worksheet gives the exemption claimed as previously processed. The cross-reference worksheet gives the serial as 105-82555-2074. This is a referral to CIA.

4. 100-10461-3154, 3155

Referral worksheet gives these as

previously processed. The C-R worksheet indicates that they are 105-82555-1864. This is a referral to the CIA.

5. 100-10461-3564

Referral worksheet states previously processed. The C-R worksheet indicate 105-82555-2809, a referral to the CIA

6. 100-10461-3607

~~Referral worksheet indicates previously processed. The C-R worksheet indicate 62-109060-2074 which has to be an incorrect citing since the description and date and number of pages do not agree. Should probably be 2034~~

6. 100-10461-4040

Referral worksheet indicates previously processed. The C-R worksheet indicate it is 105-82555-2767. This is a CIA Referral. HQ worksheet states 2 pages actual, 2 pages released, and a notation under "Exemptions used" column reads: "CIA". This was not provided and is an outstanding CIA referral.

The original ~~and CR~~ worksheets have this as a DOJ referral. The C-R worksheet states that these are 105-82555-2498. Ser. 2498 was never a referral and was released w/out excisions. The Dallas Referral worksheet lists these serials as previously processed, still withheld, when they are not.

8. 100-10461-4869

Referral worksheet indicates both pages were withheld, which they were not. Only certain paragraphs ~~which~~ <sup>were</sup> referred to the CIA.

9. 100-10461-4967

Referral worksheet indicates all 5 pages were withheld which is not the case. 5 pages were provided, and according to the original worksheets only paragraph 1, page 4 was referred to the CIA.

10. 100-10461-5436

Referral worksheet indicates this document is a referral to State Dept. CR worksheet reads:

"Referral: Naval Investigative Service

"Referral: CIA"

11. 100-10461-5437, 5438

a) C-R worksheet indicates documents <sup>are 1 page</sup> ~~to~~ <sup>2 pages</sup> ~~(page~~ (0), released, under column "Exemptions claimed it reads: "Referral: CIA (for information) <sup>(5437)</sup>"

It also indicates that these serials are 105-82555-3262. <sup>b)</sup> The worksheet for that serial <sup>(3262)</sup> states it is 4 pages, (0) released with various confusing claims to exemption including: b-1, refer to ONI, DCR4.

c) The worksheet for HQ referrals-105-82555 reads "4 pages, (0) released, CIA NIS 5-9-78 NONE"

d) the worksheet for Dallas Referrals reads "previously processed."

12. 100-10461-5588

C-R worksheet indicates this was a Referral to the State Dept and indicates it is 105-82555-NR3410. This is in the HQ files and was never referred. Referrals worksheet has them as previously processed.

13. 100-10461-5784, 5784a

These were withheld originally as referrals to National Archives. The cross-reference worksheets state that they are 105-82555-EBF-3485 <sup>with</sup> The Oswald Dallas



referrals these were provided although they were in the EBF also provided from HQ.

14. 100-10461-5785, 5786

These were never referrals, even originally, and are listed on the original + C-R worksheet as previously processed. ~~These~~ C-R worksheet also indicates they ~~are~~ ~~located~~ <sup>are</sup> located 105-82555-3485.

15. 100-10461-4418

Originally <sup>(Dallas)</sup> this was a referral to the Secret Service. It was provided by the FBI with the Dallas Referrals worksheets. The C-R worksheet indicates it is 105-82555-3960 which is also not withheld. This document was never withheld except at Dallas originally.

16. 100-10461-7323

Originally this was a referral to the CIA. The Dallas Referral worksheet indicates previously processed. The C-R worksheet indicates it is 105-82555-4527. However <sup>no</sup> page of this serial at HQ was provided, 2 are withheld under claim to b1.
