Dear Senator Johnston:

Reference is made to your communication of October 23rd to the Department of Justice in behalf of Mrs. Edward T. Miazza, a constituent. Your communication was referred to this Bureau for response and was received on November 18th.

Regarding Mrs. Miazza's inquiry concerning the files on the assassination of President Kennedy, upon completion of the Warren Report, The President's Commission on the Assassination of President John F. Kennedy sent investigative materials and documentary evidence to the National Archives and Records Service, 7th and Pennsylvania Avenue, N. W., Washington, D. C. 20408, for permanent preservation. Some of these documents are now available to the public. Any request for the available material may be forwarded to the National Archives, attention: NANC, area 6W3.

The documents which have not been made available at the National Archives are contained in investigatory files compiled for law enforcement purposes and are thereby exempt from public disclosure pursuant to the provisions of Title 5, United States Code, Section 552 (b) (7). Enclosed is a copy of the Freedom of Information Act, Reprint of Statute, Existing Regulations and Statements of Policy from Title 5, United States Code, Section 552, which may be of interest and assistance.

Because of the general nature of the inquiry concerning suits filed in the District of Columbia, we are unable to comment on the reasons for their being unsuccessful.

As requested, your enclosures are returned herewith.
