Some time ago you suggested filing against the FBI fof the Nosenko records. When you can maybe this would be a good idea, and it might be of use in the 1996 remand, given their false claims that result in the remand.

There are at least two Nosenko requests, and the second is for what was already disclosed! To Epstein. The FBI is still playing around with the basic request, if you've read the copies of appeals correspondence I've sent. Remember, they told me in 1978 they were on it. Then more recently the "Mooney" letter. But they've only recently been making referrals because only recently I received notice of one from INS.

Huff has made a mockery of the appeals function, in this matter in particular.

So maybe it would be a good idea to nudge them a bit, especially because there is so clear a record there ought be no question of your fees.

However, before filing I think it might be a good idea for me to nudge Huff once again, this time spelling out that I hold him responsible for not performing his assigned duties, and to include that for once in the complaint. I'd recount my more recent correspondence with him about this in the same letter. Tell him that if I have no choice I'll file and it clearly will be because the FBI is determined not to comply and he is determined not to do his daty. Give him, say, two week to deliver or I file suit.

But I dught not do that until you are in a position to do it. All you need, really, is copies of the correspondence, which you have and for the most part I have enough of in my office, without having to use the files in the basement.

Using Nosenko is a good choice because it requires no work of me. I want to hold such time as I'd use on it for writing.

And when we are in the seventh year of the request's acknowledgement it ought be clear enough even to a partisan judge.

Moreover, such a letter just might get the records disclosed.

So, when you have time, please let me know.

The other thing that interests me most is the personal records.

If you've heard about the local floods, and some local roads are still closed this afternoon, we are OK but I almost ran into problems yesterday on my way before daylight to my therapy. When I got to Waverly Drive and was making the right turn to go past the school oncoming traffic at the wooden bridge out lights in my eyes, so while I could see well enough to drive I could not see the emprmous puddle of whater at the very end of Waverly Drive.
