FBI B-1: I think Gary did some checking on the Bowen interest. Want to ask him?

Your 5/24: I agreed yours is a correct approach. Only because of the questions you raised did I suggest that you raise those with Jim, who has made his own study and is a lawyer. The pojt was your apparent desire to have more time, hence I suggested that along with this you could stop the clock with a pro forma appeal

A0: I do not think that I can prove beyond doubt that 0 was an agent, or as I put it, informant, But I think I can build a case that says nothing else makes sense. On "backgound" and WC. perhaps that is what I have done and plan in one more chapter. But you'll understand this better what you read what I jave done. I use the non-investigation as having a meaning, not as sloppiness.
