Dear Mr. Weisberg:

This is a partial response to your letter dated May 21, 1977 pursuant to the Freedom of Information Act for records concerning the assassination of President John F. Kennedy.

The attached documents which were found in our file numbered 129-012-3, sections 5 through 7 are being made available to you in full or in part. The documents which are being released to you in part are subject to the deletion, pursuant to 5 U.S.C. 552(b) (7) (C), of material the release of which would constitute an unwarranted invasion of the privacy of a third party. A copy of the schedule of documents which covers sections 5 through 7 is also enclosed.

As indicated on page 94 of the schedule (attached to our letter to you dated April 7, 1981), items 1871, 1872, and 1876 were referred to the International Communication Agency (formerly the United States Information Agency) for direct response to you. These documents have been returned to us. International Communication Agency has no objection to their release which are included in the attached package.

In processing your request we located file numbers for files maintained by the Civil Division which may contain pertinent records. The Civil Division has requested that we inform you that if you wish a review of those files, you direct a separate request to it. The file numbers are 78-13-29 (John J. King v. U.S.A., Civil Action No. 67-C-518, U.S. District Court of Colorado) and 78-73-131 (Marina N. Oswald Porter, et al v. U.S. Civil Action No. CA-3-2282, U.S. District Court, Northern District of Texas).

We are presently reviewing another series of file 129-012-3. The review of these series will be completed as soon as possible.

Pursuant to Department regulations, you have a right to appeal the deletions as a partial denial of your request. This appeal must be made within thirty days in writing and addressed to the Associate Attorney General (Attention: Office of Information and Privacy Act Appeals) Department of Justice, Washington, D.C. 20530. The envelope and letter should be clearly marked, "Information Appeal". If on appeal your request is denied, judicial review will thereafter be available to you in the district in which you reside or have your principal place of business or the district in which the records denied to you are situated or the District of Columbia.
