JFK assassination records up date  
Photographers and their film Hughes and WCU (Jesus Carr)  
FBI control over what would and could be known, including in HQ  
Sousa, internally, and motive for withholding  
Attached are 62-10300-456 and 707. The former relates to a completely unidentified

film I identify as the Hughes film, the letter to WCU's footage and to Jesus Carr, not fully identified in the record. He was also public relations director for the International Trade Corp.

Why the reason to Belmont memo, 456, fails to identify Hughes and reports incompletely and in fact misleadingly I leave to your own conjecture. I believe this and the extensions of what I have already told you in the Carr memo are consistent with the control within FBIHQ of what would be and could be known in HQ, including by Belvoir. These address motive for withholding. Additionally they serve to control the investigation of the nomination of the President to eliminate all not consistent with the FBI's pre-conceptions so that what was retained in the first few months, prior to any investigation, would be the unquestioned conclusions. Also motive for present withholdings.

The Hughes film does not show anyone in the window at the time the shots were fired, despite what this memo implies. It also is not the only such film. Another is the Powell film, subject of my 1968 request on the appeal of which you have not acted. Still another is one I learned about in the Dallas field office files. It shows two images in motion in that window but the FBI said it didn't even show the window. (My private information is that only recently has the FBI tried to obtain it and then refused a copy when the owner was unwilling to part with the original.)

707 confirms what I told you in my Corro-WCU appeal, that he had gone to WCU and seen the footage on their "trials right after Oswald's name was published 11/22/63." After that, at 6:30, which was pretty soon, he told the FBI, with which he was in frequent touch, that the footage you provided to the BBC was. Why the FBI omitted what else Carr said again you can conjecture about but it did omit relevant information or still withhold field office information I requested...I am aware that request have to be for existing information, which I believe there is. However, I am also trying to provide you with explanations for their withholding - with motive for withholding.
