I remember discussing this with you. I probably sent you copies of my letters but if I didn't and you'd like them, please let me know.

I think I sent you more. It is my refollection that the FBI stated that I was the "subject" of the request. To this day, by the way, I've heard nothing from the FBI in response to my FOIA request seeking the identification of the requester. At least some of the records involved were "Gregory" case records, the investigation of the late Gregory Silvermaster, who'd been "named" by the flakey Elizabeth Bentlet.

The other records involved related to the Mayhe case and constitute belated and still incomplete response to my request of 1975 for all records relating to me. These records so long withheld when it is obvious that they should have been identified from the cards when any first search was made refer to still other ecords not provided and for which no claim to exemption was made. For example, they refer to a statement the FBI prepared for my signature and to my refusal to sign it. They also include a retyped copy of the atetement I did file. And, diligent as the FBI is in clapping and filing news stories, it provided none of them. The reason is obviously they report my exoneration and Mayne's copping of a plea with "artin Dies doing the copping for him.

Is there anything I can properly do to, if I may put it this way, assist Shaheen in his inquiry? Assistance is the one thing he doesn't want. Information isn't, too.

I don't know if Jennifer is too old a fix girl to be amused by what accounts for my greater tiredness today. It is skunks. I could say "our" skunks because they are our uninvited tenants.
