Add to 18: In order to deter Plaintiff's interest and the diligence with which he mas sought this suppressed evidence, one of the higher officials of the Defendant Department of Justice lied to Plaintiff, in writing, telling him a review was then underway when, in fact, it was not.

Jim-I thing that instead of rewriting what is done to this point, we should add on Ronnie Caire and the Wasp-lit fingerprint, which I'll take up with you ll/9. I also think that the prayer for relief should include "promptness" and by having the court direct Justice to say when, where and now, citing #718-70 as need. They will whip me around if we do not. The next remaining question is, should we include Archives, even though I have not appealed there, on the ground that Justice may say they are the agency of paramount interest? I think not, but I think also the question should be addressed.
