IF NOT, STATE DISPOSITION AND IDENTIFY TRANSMITTAL COMMUNICATIONS. CONTACT ORIGINAL SOURCE OF PHOTOGRAPHS IF NECESSARY AND ATTEMPT TO DETERMINE CURRENT LOCATION.

ADVISE WHETHER OR NOT THE TWENTY PHOTOGRAPHS SOUGHT ARE THE SAME AS THOSE FLOWN TO DALLAS BY SA RUDD DECEMBER TWENTY-THREE, 1967.
