ADVISED THAT ON THE NIGHT OF MARCH TWO

MARTIN TOLD KATHERINE FORD THAT MC KENZIE WANTS TO TAKE MARINA'S CASE TO COURT. MARTIN TOLD MC KENZIE THAT MRS. MARTIN HAD BEEN LIKE A SERVANT TO MARINA (WHEN MARINA LIVED WITH MARTINS). MRS. FORD WAS OF OPINION THAT MRS. MARTIN MUST HAVE NOTICED "SOMETHING WAS GOING ON" BUT BECAUSE OF THE MONEY INVOLVED THOUGHT SHE "WOULD LET HIM PLAY." MARINA AGREED, TELLING MRS. FORD "ONE HAS TO BE A FOOL NOT TO NOTICE SOMETHING." MARINA WANTS TO TAKE THE CASE TO COURT. MARINA SAID MCKENZIE TOLD HER MARTIN WANTED TO TELL THE COMMISSION WHAT HAPPENED IN WASHINGTON, BUT WARREN DID NOT EVEN WANT TO HEAR ABOUT IT AND DOES NOT WANT IT TO BE IN THE REPORT. WARREN TOLD MARTIN, ACCORDING TO MARINA, THAT THIS DOES NOT PERTAIN TO THE CASE AND FOR HIM TO BE SILENT ABOUT IT. MRS. FORD THINKS THORNE AND MARTIN MAY HOLD THIS OVER MARINA'S HEAD AS A THREAT. MARINA SAID IF MARTIN SPEAKS IN COURT EVERYONE WILL FIND OUT WHAT KIND OF A MAN HE IS. MRS. FORD IS OF THE OPINION THORNE RATHER THAN MARTIN MAY DISCLOSE WHAT HAPPENED IN

LATER ON NIGHT OF MARCH TWO LAST MARINA CONTACTED KATHERINE FORD STATING SHE MIGHT LIKE TO CONTACT GEORGE BOUHE (RETIRED ACCOUNTANT PREVIOUSLY INTERVIEWED IN THIS INVESTIGATION). MARINA SEEMED CONCERNED, AND ASKED MRS. FORD NOT TO RESENT THIS AND NOT TO THINK SHE WILL BE ASKING BOUHE FOR ADVICE BUT INDICATED SHE IS LONELY. SHE STATED BOUHE MIGHT VISIT HER.

INFORMANT ADVISED MARINA CONTACTED BOUHE AND INVITED HIM OUT FOR A CUP OF TEA. BOUHE DECLINED, STATING IT WAS TOO LATE AND THIS WAS NO TIME FOR MEN TO COME TO SEE MARINA. BOUHE INDICATED MRS. FORD IS VERY ANGRY WITH HIM. MARINA TOLD BOUHE SHE THINKS THERE WILL BE A COURT SUIT, AND MENTIONED THAT THORNE AND LEECH ARE ASKING FORTY THOUSAND DOLLARS AND MARTIN IS ASKING TWENTY THOUSAND DOLLARS. BOUHE ASKED IF DECLAN FORD IS HER MANAGER, AND MARINA ADVISED SHE HAS NO OFFICIAL MANAGER BUT MAY USE FORD AS ONE. MARINA SAID SHE TOLD MCKENZIE HE IS EXPENSIVE, AND MCKENZIE TOLD HER THE ONLY REASON HE SITS IN DURING FBI INTERVIEWS IS TO LEARN MORE DETAILS WHICH MAY BE OF HELP TO HIM IN THE FIGHT WITH MARTIN. MARINA THINKS THORNE WOULD PREFER A SETTLEMENT. SHE THINKS MARTIN USED HER MONEY TO FEED HIS FAMILY DURING HIS UNEMPLOYMENT PERIOD. BOUHE MENTIONED HE IS NOT WORKING NOW AND IS RETIRED BUT HAS TWELVE CLIENTS COMPRISED OF BANKERS, LAWYERS,

AND GEOLOGISTS. HE IS SIXTY YEARS OF AGE AND DOES HIS WORK AT HOME. MARINA INDICATED THAT ANNA RAY WOULD BE OVER ON THE MORNING OF MAR THREE SIXTYFOUR, FOR A VISIT. MARINA THINKS DECLAN FORD IS HONEST AND A GOOD BUSINESSMAN. BOUHE INDICATED IT IS STRANGE THAT THE FORDS APPEAR TO BE ANGRY WITH HIM. INFORMANT SAID MARINA WOULD NOT GIVE BOUHE HER PHONE NUMBER, AND BOUHE TOLD HER HE DID NOT WANT TO MEET WITH HER IN THE PRESENCE OF THE FORDS. BOUHE THEN MENTIONED LEVINE, WHO WRITES FOR MEREDITH PRESS, AND SAID HE WOULD TRY TO VISIT MARINA MARCH THREE.

INFORMANT SAID HE LEARNED LATER MRS. FORD CONTACTED MARINA AGAIN MARCH TWO, AND WAS APPARENTLY UPSET WITH MARINA BECAUSE OF MARINA'S CONTACT WITH BOUHE. MARINA ASSURED MRS. FORD SHE DOES NOT INTEND TO TAKE BOUHE'S ADVICE. MRS. FORD APPEARED VERY INTERESTED IN MARINA'S DISCUSSION WITH BOUHE. MARINA WAS TROUBLED THAT MRS. FORD WAS UPSET BECAUSE OF BOUHE. MRS. FORD REMINDED MARINA THAT SHE HAD PROMISED NOT TO TALK WITH BOUHE WITHOUT A THIRD PARTY PRESENT. MRS. FORD SAID DECLAN FEELS HE CANNOT GIVE MARINA ADVICE SINCE A BIT LATER SOMEONE ELSE GIVES HER OTHER ADVICE. MARINA SAID SHE WILL LISTEN TO NO ONE EXCEPT DECLAN, AND SHE WANTS DECLAN TO BE HER MANAGER. SHE POINTED OUT TO MRS. FORD THAT THE FACT DECLAN WILL BE HER MANAGER DOES NOT MEAN SHE CANNOT SPEAK TO ANYONE ELSE. MRS. FORD SAID THAT LEVINE GIVES IMPRESSIONS THAT THEY HAVE SOME SORT OF ORAL UNDERSTANDING FOR MARINA'S WRITING. MARINA BELIEVES SHE DOES NOT WANT LEVINE

TO HANDLE HER WORK. MARINA GAVE MRS. FORD HER WORD SHE WILL NOT SIGN ANY CONTRACTS WITHOUT DECLAN FORD. SHE ADDED SHE DOES NOT INTEND TO HAVE ANY DISCUSSIONS WITH LEVINE ANY MORE. MARINA TOLD MRS. FORD SHE ASSURED MC KENZIE SHE TRUSTS HIM AND WANTS TO RETAIN HIM AS HER ATTORNEY.

INFORMANT SAID THAT LATER ON MAR TWO MARINA AGAIN CONTACTED GEORGE BOUHE AND TOLD BOUHE NOT TO GIVE LEVINE HER ADDRESS, THAT SHE DOES NOT WANT LEVINE BOTHERING HER.

INFORMANT ADVISED THAT LATER ON THE NIGHT OF MAR TWO DECLAN FORD VISITED MARINA AT HER RESIDENCE.

INFORMANT STATED DECLAN FORD CONTACTED ILYA MAMANCOV IN RICHARDSON, TEXAS, (MAMANCOV PREVIOUSLY INTERVIEWED). FORD ASKED IF ILYA WAS CALLED AS A TRANSLATOR FOR MARINA DURING THE EARLY DAYS OF THE INVESTIGATION. ILYA SAID HE WAS THERE THE FIRST DAY, FRIDAY NIGHT AFTER THE ASSASSINATION. FORD WAS INTERESTED IF ILYA HAD EVER TRANSLATED CONTRACTS BETWEEN MARTIN AND MARINA. ILYA SAID MARTIN TOLD HIM SHE UNDERSTANDS ENGLISH PRETTY WELL AND UNDERSTANDS SHE DOES NOT NEED A TRANSLATOR. ILYA SAID HE DOES NOT BELIEVE MARINA KNOWS ENGLISH THAT WELL. INFORMANT STATED FORD APPEARED TO BE PREPARING A DEFENSE FOR MARINA IN THAT ILYA HAD OFFERED HIS SERVICES AS A TRANSLATOR FOR MARINA BUT MARTIN HAD TURNED THIS SERVICE DOWN.

INFORMANT ADVISED MARINA SPEAKS VERY LITTLE ENGLISH BUT APPARENTLY IS ABLE TO UNDERSTAND AND COMMUNICATE WELL ENOUGH TO GET ALONG WITH ENGLISH CONVERSATIONS. HE POINTED OUT THAT ALL CONVERSATIONS BETWEEN MRS. FORD, BOUHE, AND MARINA ARE IN THE RUSSIAN LANGUAGE.

ON MORNING OF MAR THREE LAST, AGENTS OBSERVED WHITE MALE, WHITE FEMALE, AND SMALL CHILD, DRIVING CAR REGISTERED TO POLLOCK RAY, VISITING MARINA AT HER RESIDENCE.

ROBERT OSWALD WITH WHITE FEMALE AND CHILD OBSERVED BY AGENTS VISITING MARINA AT HER RESIDENCE FROM SIX THIRTYNINE PM TO EIGHT ;THIRTYTHREE PM ON MARCH THREE LAST.
