We received information from Mrs. Pill Randle, 2030 V. 5th. Inving, Texas, BL3 8965 that her brother, Buell Wesley Fraster, w/m/19, same address, took Lee Gawald to work on the morning of the murder and that she saw Oswald nut a long package in the tack seat of her brother's 195h black chevrolet, h door, 1963, Texas license VK 3926. (See her affidavit.) She said her brother wasn't home but visiting their ster-father, Dave Villiams, at Farkland Hospital. We checked with Farkland Hospital, but they didn't have a law Williams there. We finally located have Williams at the Irving Professional Center, Room #30. Ret. Rose contacted het. Wohn A. McCabe of the Irving, F. D. and asked him to check there for Frasier. Det. McCabe called us back stating he had the boy at the Irving Professional Center and searched Frasier and accompanied by McCabe went to the Irving Professional Center and searched Frasier's 195h black Chev., Texas license VK 3926. We found nothing of importance. We then went to 2h39 W. 5th with Frasier and he showed us where he kept his 303 cal. rifle and box of ammunition (see property room invoice). Frasier's sister, Mrs. Randle, came to the location and we brought Frasier and Mrs. Randle to the homicide office. Afficavit was taken from Mrs. Randle. Frasier was interrogated and run on the polygraph with negative results. Affidavit was then taken from Frazier. Frasier and his sister were then returned to Irving on 11-22-63.
