In the garage Marina Oswald pointed out a blanket that Lee Oswald kept his rifle in. Flanket was released to FBI and taken to Vashington. Mr. Michael Paine arrived while we were there. Michael Paine, Ruth Paine and Marina Mawald were brought to the Homicide Office and affidavits were taken from them.
