However, when she answered the phone, the other party hung up. A few minutes later, her door bell rang. She answered the door, but did not see anyons. She tried to open the acreen, but the latch on the outside had been turned to prevent the screen from opening. She went to the back door and discovered that some one had placed a ladder against the screen door, and she could not open it. Radio Patrol has been assigned to keep a close watch on this residence.
