In the garage Maxina Oswald printed out a blanket that Lee Oswald this night in ~~the~~ blanket released to FBI & taken to Washington, Mo. ~~the~~ Michael Faine arrived while we were there. Michael Faine, Ruth and Maxina Oswald were brought to the Homicide office & affidavits were taken from them.
