ADDITIONAL DETAILS, PROGRESS OF INVESTIGATION, ETC.

In November 24, 1963, at 6:30 P.M., Det. J. R. Leavelle delivered to Captain G. M. Doughty, a lead slug removed from the body of Lee Harvey Dewald at Parkland Hospital by Dr. Tom Shires. The slug was removed in the presence of Nurse Aubrey Bue who placed the letter A on the base of the slug and gave it to Det. Leavelle.

In November 24, 1963, at 7:00 P.M., Captain J. W. Frits delivered to Capt. G. M. Doughty a Colt Cobra .38 Special revolver # 2744 LW attached to the gun in an envelope was the following:

- One .38 W&A Special live shell.
- Four .38 Special R&M-UNC live shells.
- One .38 Special R&M-UNC spent hull.

All of the above were released at 11:20 A.M., on December 30, 1963 by Lt. J. C. Day to Det. M. Johnson and Det. L. D. Montgomery, to be taken to the DPS at Austin for examination.
