Thursday, February 27, 1964 along with Detective O.J. Tarver I went to the SPA Helth Club 3883 Turtle Creek Blvd. Dallas, Texas.

We interviewed a John Merrick who lives 8920 Creek Rd. Dallas Texas. Merrick does not have a telephone. Merrick told us that he is a student at Denton, Texas studing Pre. Med, That he is working part time at this helth club to help pay expences,

He states that he met Jack Ruby at the Club and knew him because he was handing out cards to the Carrosel Club, Merrick states ~~that~~ that he took a card but that he never had time to go visit the club. Merrick also states that he is so busy that he don't have time to read the news papers or watch TV or listen to the radio. Merrick says that on one occasion there was a man with Jack Ruby and he thinks Jack introduced him as Oswald but would not be positive. However ~~XXX~~ he says when he saw a picture of Oswald in the paper that he remarked to some one that I think I have met that man some where but could not remember for some time just where it was. He later recalls that it was the man Jack ~~XX~~ introduced him too. When asked who else was there and could verify this or might remember him, Merrick could not remember any one that saw this man with Jack.

We also ~~XXX~~ talked with the manager and assistant manager of the Club they also stated they remembered Jack Ruby because of the cards that he was always passing out. They did not think that it was the proper place for him to do that, As they have a high class clientel. The assistant manager says that Jack also told him that if he ever wanted fixed up that he would fix him up with this "Jata Jata" He told him that he was not interested and besides his wife was standing close by.
