in County Criminal Court #2, Docket # 24790-B, on the DWI charge and received a \$125.00 fine, 3 days in jail and Court costs.

The indices of the Identification Bureau of the Dallas Police Department reveal that the SUBJECT, under I.D. No. E-19801, had been arrested in San Antonio, Texas 11-30-51 and charged with Vagrancy. These indices verified the provious arrest in Dallas on a charge of Driving Uhile Intexicated.

Subsequent to the arrest of JACK LECH RUBY for the murder of HARVEY LEE OSWALD, it was learned that RUBY and the SUBJECT had been involved in a fight in the Burgundy Room of the Adolphus Hotel on the night of 2-12-63. The SUBJECT made a complaint to the Police Department, NUBY was placed in jail and charged with Simple Assault. On 2-27-63, RUBY was found not guilty in City Court and a cash bond he had posted was returned to him. The SUBJECT apparently failed to appear. On 1-7-64 and 1-8-64, an attempt was made by the undersigned officer to contact the SUBJECT by telephone at DA 1-2917 at 8546 Forest Hills Blvd. Each time the caller was told that the SUBJECT was out of the City. On 1-9-64, the SUBJECT returned the telephone calls and inquired as to the reason an interview was desired. Upon being told that the reason pertained to the fight he and RUBY had been involved in, the SUBJECT stated that he was ill and did not feel like talking about the incident. Upon request for a personal interview. he stated that he had been interviewed by the Foderal Bureau of Investigation Agents and by the U. S. Secret Service Agents and had given a statement to each of them and that he had no desire to speak of the incident again. He stated that he was too ill to do any more talking about it.

Confidential Informant T-4 reported that a statement had been taken from the SUBJECT to the effect that JACK LEON RUBY had struck him for no apparent reason and had caused serious injury to an eye. That the SUBJECT had made an attempt at making a complaint against Dotective J. B. TONEY, the officer who arrested RUBY. He alleged that Detective Toncy had telephoned him and had tried to persuade him to drop the charges against Ruby. T-4 stated that Detoctive Toney had made an answer to these allegations to the effect that he had called the SUBJECT and had told the SUBJECT that the only charges that could be filed, would be charges of simple assault and that the charges would be filed in City Court # 4. T-4 was of the opinion that the SUBJECT was the type that 'hated law enforcement officers' and did not hesitate to attempt to embroil a detective in a complaint. T-4 stated that a report from RUBY and his witness, who is unknown, indicated that the SUBJECT and unknown persons were at a table in the Burgundy room on the night of 2-12-63 and that JACK LEON RUBY and a very good looking blond female companion had passed the SUBJECT'3 table. The SUBJECT had made a ribald 'off-color' remark about the female companion and RUBY proceeded to 'whip' the SUBJECT which caused the SUBJECT pain and embarrassment. RUBY and the SUBJECT were escorted to the office of the Burgundy Room Manager and detectives were called.
