The caller was a male voice on the telephone and informed her that she would be better off if she kept her mouth shut. Hrs. Tice also received another phone call about 1:30 AM, July 22, 1964. However, when she answered the phone, the other party hung up. A few minutes later, her door bell rang. She answered the door, but did not see anyone. She tried to open the screen, but the latch on the outside had been turned to prevent the screen from epening. She went to the back door and discovered that some one had placed a ladder against the screen door, and she could not open it. Radio Patrol has been assigned to keep a close watch on this residence. watch on this residence.
