We received information from Mrs Bill Randle 2439 W 5TH, Irving, Texas BL-3-8965 that her brother, Buell Wesley Frazier W-9-19 same address, took Lee Oswald to work on the morning of the murder & that she saw Oswald put a long package in the back seat of her brother's 1954 Black Chev 4 dr 1963 Tex Lic # VK 3926 (See her affidavit). She said her brother wasn't home but visiting <sup>with</sup> their father Dave Williams at Parkland Hospital. We checked with Parkland Hospital but they didn't have a Dave Williams there. We finally located Dave Williams at the Irving Professional Center, Room #30. Det. Rose contacted Det. John A. McCabe of the Irving P.D. & asked him to check there for Frazier. Det. McCabe called us back stating he had the boy at the Irving P.D. We went there immediately and got Frazier & accompanied by Mr. Clark went to the Irving Professional Center and searched Frazier ~~in~~ 1954 Red Chev Sepia VK 3926. We found nothing of importance. We then went to 2439 W 5th with Frazier she showed us where he kept his 503 Cal rifle & his ammo (see property room invoice). Frazier's sister, Mrs Randle came to the location & we brought Frazier & Mrs Randle to the homicide office.
