Predestination

From the moment the last vote was stolen in Texas, on the night of November 8, 1960, John Fitzgerald Kennedy was predestined to die in the office of President of the United States. CAPSULE NEWS has said more than once that Pres. Kennedy would die during either his first or second term. But never once did we think he would die that way. Medical evidence showed that the most probable way would be thru the Addison's disease that he contracted from one or more of those 17 hypodermic shots he was given during his war service.

Texas was his State of Destiny. It was his selection of a Texan as his running mate that enabled him to carry enough Southern votes to show him the victor on the Electoral College tote board. But even this didn't carry Texas. The "Democratic" vote counters there had to steal it to help Chicago's 200,000 fraudulent Cemetery Votes bring Kennedy over the top on the tote board. On December 17, 1960, CN gave a vivid picture of how 100,000 votes had been stolen November 8th. Houston's CHRON-ICLE reported that in Angelina County 86 ballots were cast---147 of them recorded for Kennedy on the State total and 24 for Nixon. In Lee County it was Kennedy by a landslide---unanimous. Of 39 ballots cast, 64 were for Nexnedy, 0 for Nixon. Breakdown of Law and Order

When Speaker McCormick received the incredible, terrible news that President Kennedy had been shot dead, his res gestae was "My God, what are we coming to?" The Massachusetts solon thus made a remark that should belong to the ages. And it will if our new President, or our soumambulistic Congress awakes and, corrects it.

For, we are not exactly "coming" to anything. We are there. We have arrived at a 99% complete breakdown of law and order. It stems from the very top of our official life in Washington. It has been aided and abetted by our Kept Press, and its subsidizers in Rockefeller Center.

This complete disregard of the Constitution, our basic and organic law, in 1928 brought nomination and election of a President who was then still a British subject and not even eligible to vote, much less hold public office. At that, the de facto President from 1929 to 1933, inept and helpless as he was when a major economic crisis was precipitated by Wall Street (now Rockefeller Center), was nothing like as bad as his venal, corrupt, mendacious and slightly or somewhat demented successor.

It was Franklin D. Roosevelt who first started tearing the Constitution to shreds. To show that he merely regarded it as a Scrap of Paper, he sent a message to Congress to pass a socialistic law (that he wanted as a vote eatcher for 1936) regardless of its Constitutionality.
