About a menth are, I not bee Marvey Osmald at work. I saw that he was a now man, and I walked up to him and acked him if he was bee. I figured he must be Lee as my sister had told me about him. I asked him if he would like to ride back and forth with me as I knew his wife lived with Buth Poins near my house, and he soid he would, Dut only on week ends so he had on apartment of his own in Oak Cliff. After that every Friday evening Lee would rice home with we and then rice back to work with me on Menday marning. He has only rode home from work with me on Fridays, but yesterday morning, Thursday, November 21, 1963, Lee told no that he wanted to ride home with me that evening. I was surgrised, and I asked him if he was noing home with me Friday also, and he said, "No". He told no that he was roing home to get come curtain reds. Thursday afternion Lee rade to Irving with me to Eath Palme's house, where his wife is staying. I let him out of my car in front of Ruth's Pouss, then I went on. This morning, Pricey, Movember 22, 1963, I got up between 6:00 - 6:30 At, and got ready to go to work, and then sit down to eat treakfast, shout 7:15 M, me, my mother, and my two little neices were at the table, and my sister was at the sink. By mother looked up and said, "kho is that looking in the window?" I looked up and said, "What's Le." I got up and finished getting ready and got my lunch and went to the door and not Lee on the ear port. We then valked to my car, it was ranked backed up at the side of the ear port. Fefore I got in the car, I glorced in the book sect, and saw a big sack. It must have been about 2' long, and the top of the sack was sort of folded up, and the rost of the sack had been kind of folded under.
