Charged in Burglary

Aracacha, whose name has been linked with the Kennedy assassination probe in New Orleans, Thursday was charged with simple burglary in Houma.

Sheriff Bill Decker received a report from Terrebonne Parish Atty. Wilmore Broussard that the charge is in connection with the burglary of a munitions warehouse at Houma in 1961. Aracacha voluntarily went to the sheriff's office here and posted \$1,000 bond set by Justice of the Peace Charlie T. DeLoach. Louisiana authorities had arrested Aracacha on a charge of burglary in the week, Aracacha was charged with conspiracy to commit burglary at Houma. That warrant came from Orleans Dist. Atty. Garrison who claims the assassination of President Kennedy was plotted in his city.

Aracacha has said he is awaiting extradition on the charge and there were no other charges. He would do the same on the burglary allegation. Aracacha, who has lived in New Orleans since 1963 and works with a division of an aircraft manufacturing firm, said he knew nothing pertinent he could tell Orleans officials. He said he had absolutely nothing to do with any plot to assassinate the President.

The New Orleans charges against Ferrie and Gordon were named along with Aracacha in a conspiracy to commit simple burglary.

The alleged plot of naturalized citizen Garrison claimed the plot figured into his assassination "plot."

Aracacha also was named in the New Orleans charges.

Clay L. Shaw, a retired police officer, was charged with conspiracy to murder President Kennedy.

William J. Driver, administrator of the state's office, was ordered in the subpoena to have the file on Shaw ready to be produced in criminal court here April 24.

EXCEPT FOR the subpoena, a matter of public record, Garrison's controversial probe was kept secret way, trailed by rumors and enriched by an odd string of events involving the Louisiana governor's office.

In Baton Rouge, Thomas Burbank, superintendent of state police, said his department bought "anti-bugging" electronic gear from Gordon Nove — a man Dist. Atty. Garrison is trying to pry out of Ohio for questioning in the probe.

Burbank said the equipment was purchased from a New Orleans firm headed by Novel for a 1965 report that the governor's office was being "bugged" with hidden microphones.

"We never did find any equipment in the office," said Burbank.

Garrison and his aides were taken to state beyond Garrison's legal reach, after an appeal before the grand jury on the alleged conspiracy, President John F. Kennedy.

"A police state inquiry," he said, in condemning the investigation. He was arrested near Columbus, Ohio Saturday on warrants returned from a burglary conspiracy filed by Garrison, under \$10,000 bond. He said he will fight the charges.

The 1961 burglary involved a cache of explosives from a storage bunker in New Orleans, La. Its connection with the alleged assassination, if any, is unclear.

TON P. MARTEN, a student at the University of South Louisiana, posted a perjury indictment on his testimony to the grand jury March 29 on the burglary.

Marten told reporters easily that he lived with W. Ferrie for a period and was certain that Ferrie had Lee Harvey Oswald in the apartment.

Garrison said Shaw, and other names, were taken to state beyond Garrison's legal reach, after an appeal before the grand jury on the alleged conspiracy, President John F. Kennedy.

Records in the Louisiana secretary of state's office of the Electronics Systems Laboratory as filing papers July 1966 listing Novel among the operators.

Novel, an Andrews, was indicted on a perjury charge before the grand jury in the New Orleans charges.
