Mr. West said last week that both men joined Roscoe White an the grassty knoll near Dealey Plaza on Nov. 22, 1963, as part of a ieint aperation between the CIA and

As a trainee at the Dallas Police Academy, Sgt. Doa Young said he was seated next ta Roscoe White, and the twa quickly became friends, playing dominoes at lunch and during breaks.

"I can remember Roscoe just like it was yesterday, and to me, this whole thing is ridiculous," Sgt. Young said. "He was a very outgoing guy, very likable, no problems. It's just hard for me to believe something like this."

After the assassination, Dallas police Officer Maurice McDonald — a locker mate af Officer Tippti's — arrested Lee Harvey Oswald in the Texas Theater in Oak Cliff.
