

Dear Congressman Collier,

Being a member of your district, and having recieved help from you in the past, I once again ask for help but now as a political science major I need some specific answers and you are my only resort who will give me an answer.

First of all in listening to some of the opposition shown to the Warren Report and especially to the questions being raised by Mr. Garrision, of New Orleans, I would like to know why this opposition over such a serious issue, as the assassination of an American president which concerns the welfare of two hundred million Americans and the state of world affairs is not taken to heed.

Obviously, the members of the Warren Commission being men of high political and public esteem are respected for their investigations and conclusions of the assassination. However, if some factual opposition is raised concerning the validity of this report, why isn't this opposition itself investigated in an attempt to find the REAL TRUTH.

Also I would like to know how the president got the authority to put all the materials concerning the assassination in the Archives until a year so far distant that it will be irrelevant to anyone but historians. And why does he hide the facts that we citizens have a right to know.

It seems to me that some of the members of the House and Senate, who so radically oppose the Administration on almost every issue have suddenly become silent.
