

Your letter to President Ford concerning the assassination of President Kennedy has been referred to me. You suggest that a special investigating team be appointed and headed by Mr. Hugh McDonald, author of Appointment in Dallas.

As you may know, when President Ford was questioned by the press as to whether he felt it would be in the national interest to re-open the assassination investigation he pointed out that as a member of the Warren Commission he knew a good deal about the Hearings and the Report. He then stated that a staff member had advised him that while no new evidence has come up, there are some new developments -- not evidence but new developments -- that might justify a new investigation to lay aside any doubts to which those developments might have given rise. He then said:

If those particular developments could be fully investigated without re-opening the whole matter that took us (the Warren Commission) 10 months to conclude, I think some responsible group or organization ought to do so but not to re-open all of the other aspects because I think they were thoroughly covered by the Warren Commission.

When asked whether he would appoint, for instance, a task force from the Department of Justice to look into the new developments or if he would rather have it done by an independent organization, the President said that in light of his former membership on the Warren Commission it might be better to have it done by somebody not appointed by him.

Thank you for expressing your opinions on this matter. I regret that we cannot be of assistance.

Mr. President:

I am a high school senior, with a
history of investigating occurrences of
American Presidents. The occurrence that
I am particularly interested in is the one
of President John F. Kennedy on November 23,
1963.

I have read and heard much information
on that day in Dallas, both for and against the
Warren Report's conclusions.

A couple of months ago I watched "The
American Assassin" on CBS. They investigated
the evidence and agreed with the Warren Report
that all shots came from the motorcade's rear,
but they were undecided on whether there was
more than one assassin and whether there was
a conspiracy or not behind JFK's death.
Recently Hugh C. McDonald, former-CIA contract
agent and Chief of Detectives of the Los Angeles County
Sheriff's Office and Head of Security for presidential
candidate Barry Goldwater, wrote a book entitled,
Department in Dallas. In this book McDonald
tells how he talked to John Kennedy's wife

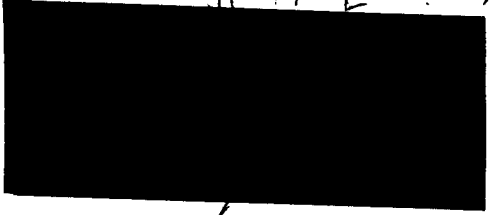

McDonald is one of best criminal investigators
I have ever heard and he has an accurate description
of JFK's killer. (McDonald is the inventor of the
steak. Not Model II which is widely used by police
departments.)

My advice is if I were you I would opposite
a special investigating team, not the CIA or FBI because
of their possible involvement in the assassination. The
team should be headed by Hugh McDonald because
of his knowledge of the case. I believe that McDonald
and some top criminologists could find "beats"
(McDonald's name for Kennedy's assassin) again and
possibly solve the Kennedy case once and for all.
I believe that McDonald could find the facts
if given the chance. All he needs is the support of
you and your associates. I go along with McDonald
100%. In the last sentence of his book he says "I
know nobody among our elected officials who will stand
up and say, 'let's have the facts!'"

INFORMATION CONCERNING MR. LEE HARVEY OSWELL THIS INFORMATION SHOULD BE TURNED OVER TOO THE WARREN COMMISSION AND THE SECRET SERVICE.

THIS INFORMATION HAS BEEN WITH HELD SINCE THE ASSASSINATION OF PRESIDENT JOHN F. KENNEDY. THERE IS A 165 FEET OF COLOR FILM SHOWING WHO WAS THE ASSASSIN AND WHO WAS INVOLVED IN THE ASSASSINATION.

- (1) THE F.B.I. WAS INVOLVED IN THE ASSASSINATION
- (2) THE C.I.A. WAS INVOLVED TOO.
- (3) IN 1963 PRESIDENT JOHN F. KENNEDY WAS ASSASSINATED BY A C.I.A. AGENT NAMED MINT DAVIS UNDER COVER NAME HIS SERIAL NO. WAS 28217458-B.

In Dallas, Texas, Mr. Oswell was on the 2nd floor of building 2 blocks from Motor Cade. On 1st floor was 2 F.B.I. agents and 1 C.I.A. agent, when the President was shot.

His head went backwards and forwards and another bullet went through front seat hitting another man. A newspaper man went to the building where the second F.B.I. man and one C.I.A. man was. And he asked one man where the telephone was. So he directed him to another man and he directed the news man to a nearby office. The news man noticed on the telephone that the first 2 ~~wires~~ lines were being used so he had to use the third ~~wiring~~ lines and he made an outside telephone call.

Just before he made the outside call he pushed the Button on the 2 nd ~~wiring~~ line and listened to a confidential conversation and I know what was said on that phone line 1 and 2. But he never told a person what that conversation was about but he told me.

But outside of him and I ~~was~~ we are the only two that know what went on in that conversation. A little while after the assassination of President John F. Kennedy the Dallas Police Department received a telephone call that there was a disturbance in a movie theater. After that, Lee Harvey Oswald was apprehended. If it wasn't for the Dallas Police Department ~~receiving~~ getting to the disturbance at the theater, Lee

Harvey Oswald would have been a dead duck. This F.B.I. agent told Lee Harvey Oswald to meet him at the theater and he would give him some money so he could go and buy a car. But Mr. Oswald did not have a drivers license in the state of Texas nor in the U.S.A.

Mr. Hoover who is now deceased, God bless his sole, knew something about the Assassination and he knew something else to. When the Warren Commission wanted to ask Mr. Hoover some questions they found there was no way to pump any information out of him.

I have color 16 MM film and also video tape showing the actual assassination. Showing who the two F.B.I. agents were and who was the one C.I.A. agent was in the building where the news paper man was when he wanted to use the phone.

I have additional information to. But Mr. President if you send any Secret Service men to talk to me about this ^{matters} ~~pleases~~ send a letter that these men will keep this information confidential. And if you want the film and video tape that I have in my possession you must write me a direct letter and tell me the two individuals who are coming to get it and what date they will arrive and they must use the words "God Bless America, 1948."

Now these film and tapes are in a vault inside a safety deposit box in the State of California. It is also my request, when these men come to see me, that they must talk to me in a secret area so no one can find out in this Federal Institution. I request protection and confidentiality during the period I am questioned about this matter and I want you guarantee this matter and I want your guarantee in writing, that I will receive this. There are many questions in this ² page letter that are unanswered and there is not one question that I cannot answer pertaining to this letter that I cannot answer and pertaining to other questions that I have knowledge to. Will wait for a return answer.
