



Your letter to President Ford concerning the assassination of President Elennedy has been referred to me. You suggest that a special investigating team be appointed and headed by Mr. Hugh McDonald, author of Appointment in Dallas.

As you may know, when President Ford was questioned by the press as to whether he felt it would be in the national interest to re-open the assassination investigation he pointed out that as a member of the Warren Commission he knew a good deal about the Hearings and the Report. He then stated that a staff member had advised him that while no new evidence has come up, there are some new developments — not evidence but new developments — that might justify a new investigation to lay aside any doubts to which those developments might have given rise. He then said:

If those particular developments could be fully investigated without re-opening the whole matter that took us (the Warren Commission) 10 months to conclude, I think some responsible group or organization ought to do so but not to re-open all of the other aspects because I think they were thoroughly covered by the Warren Commission.

When asked whether he would appoint, for instance, a task force from the Department of Justice to look into the new developments or if he would rather have it done by an independent organization, the President said that in light of his former membership on the Warren Commission it might be better to have it done by somebody not appointed by him.

Thank you for expressing your opinions on this matter. I regret that we cannot be of assistance.


