Xerox copies of the correspondence received by this source are attached hereto.

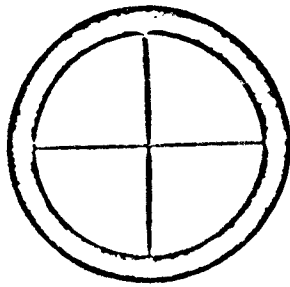

A TIME OF CRISIS

In our February issue we stated that sources within the Communist Party stated that they had advance information that the vice-presidential candidate would be Hubert Humphrey and that the Communist Party expected to have a virtual free hand after the election of a Johnson-Humphrey ticket.

Now that the first part of this prediction has come true, we should give serious consideration to the possibility that the second part may also occur.

Robert Kennedy has just announced his resignation as Attorney General. Rep. Ed Edmondson (D - Okla.) has written President Johnson urging that J. Edgar Hoover be appointed as the new Attorney General. Washington sources, however, are predicting that the job will go to Attorney, Abe Fortas, who is described as a long-time friend of Lyndon Johnson. The newspaper clipping shown in Fig. No. 1 gives an insight into the Johnson-Humphrey-Fortas triangle.

Before continuing we cannot resist commenting on the way Humphrey compared Johnson and Kennedy to Rembrandt and Picasso. Surely, a man that is intellectually qualified to be vice-President must also know that Pablo Picasso is one of the world's most notorious communists. We wonder which of the presidents he compares to Rembrandt and which to Picasso.

As for Abe Fortas, he was the attorney who defended Owen Lattimore after the latter had been identified under oath by thirteen different people as having been a communist or having been active in communist dominated organizations. Fortas, himself, has been affiliated with a number of groups listed as subversive and communist.

Fortas joined the Committee for Democratic Action in the early 1940's. This group was declared as a communist and subversive organization by Attorney General, Tom Clark.

Abe Fortas was affiliated with the National Lawyer's Guild in the 1930's which has been described by the House Committee on Un-American Activities as the foremost legal bulwark of the Communist Party.

Abe Fortas was affiliated with the Southern Conference for Human Welfare in 1947, three years after it was listed as a communist front by the HCUA. A Senate Sub-Committee agreed with the finding that this organization served "the Soviet Union and its subservient communist party in the United States".

According to a story of November 3rd, 1950 in the Daily Worker, Fortas was one of three government officials criticizing the government's security program.

In addition to acting as lawyer for Owen Lattimore, Fortas and his law partners have defended several other government workers fired as security risks, including Dorothy Bailey and Milton Friedman.

In more recent years, Fortas has been representative for Bobby Baker, the man that Johnson described as "my strong right arm".

If a man of such obvious pro-communist leanings as Abe Fortas is appointed Attorney General, it may mean the end of the FBI as the last remnant of real Americanism in the American government.

If a president, who selects men like Fortas as his personal friends and official advisers, is returned to the White House for another four years, it may end the last remnants of our Constitutional Republic.

THE SOCIALIST WORKERS PARTY

The death of Lenin caused a split in the International Communist apparatus which has not entirely healed to this day. The two groups were originally known as the "Stalinist" faction and the "Trotskyite" faction.

When Trotsky fled Russia, many thousands of his followers settled in France, England and the United States. Trotsky, of course, fled to Mexico where he was later assassinated. During the years the Stalinist faction was struggling to consolidate its dictatorial control over the peoples of the Soviet Union, the Trotskyites were building up their strength in the nations of Western Europe and North America.

Within the United States the Stalinist branch has been represented by the Communist Party, USA. The Trotskyite branch has been represented by the Socialist Workers Party.

As the Chinese communists began to show their independence, this was reflected by still another splinter group within the United States known as the Maoist organization. These people have now apparently been welcomed into the Socialist Workers Party and once again the Socialist Workers Party appears to be in genuine conflict with the Communist Party, USA.

American patriots have become so accustomed to communist lies and trickery that most of us put little credence in the split between China and Russia. Most anti-communists have tended to believe that this split was just a piece of propaganda designed to confuse the "free world". The apparent purpose was to fool the American people while traitors within our own country continued to give aid to the Soviet communist satellites under the pretext of fighting a more violent brand of Chinese communism.

It may well have been that this was the original intent of the communists but a long and careful study by our own intelligence branch has convinced us that the split between the Chinese and Soviet branches of world communism is very real and is actually quite deep.

BALLY TO PROTEST POLICE TESSOR IN MARIEN

A recent issue of the World Marxist Review seems to confirm this conclusion. It reports statements by the communist parties of many different countries pledging their support to Khrushchev and denouncing the deviation of Mao Tse-tung. International publications of the Chinese carry counter denunciations of the Soviets. It seems doubtful that it would be worthwhile for the communists to create such dissention within their ranks in almost every nation of the world, big and small, simply to carry out a piece of deceptive propaganda.

We will still hold to our original assumption that President Kennedy was killed as a result of the conflict between these two different branches of communism.

While it is difficult to be certain, it would seem that the Trotskyite branch had been backing Kennedy while the Khrushchev (Stalinist) is more friendly to Johnson.

In their current literature, the Communist Party, USA, is urging support of President Johnson and very bitterly denouncing Goldwater. The Socialist Workers Party is now taking the line that neither Johnson nor Goldwater can be supported and that they will run their own candidate. Even with the Trotskyites, however, the denunciation of Goldwaterism is much more violent than denunciation of Johnson.

MAKARIOS - A MEDITERRANEAN CASTRO

Cyprus will soon be the Cuba of the Mediterranean. Archbishop Makarios of Cyprus has openly defied the treaty which guarantees the safety of the Turkish minority and its quota of government offices. Enough communist arms have been smuggled into Cyprus on Egyptian ships to kill every Turk on the Island ten times over. British bases on Cyprus which are frequently used by U. S. warships will be jeopardized or eliminated as this situation continues to deteriorate.

CONFLICT IN VENEZUELA

Most informed Conservatives are familiar with the long communist background of President Romulo Betancourt of Venezuela. It is easy to be puzzled when we read in the American newspapers about raids on Venezuelan oil refineries by "communist guerrilla bands". Here again the apparent confusion results from the continuing struggle for power between the Trotskyite and Stalinist branches of International Communism.

The Anti-Betancourt movement is called the, "Armed Forces of National Liberation" (FALN) and is led by trained revolutionary, Elias Manuitt.

We don't suggest that we become a supporting arm for the election of Democrats... but we will not permit this to stop us from joining a united front to smash the ultra-right and gain victories that will have an influence long after the election."

TESTIMONY OF JACK RUBENSTEIN

Government agencies are still investigating the unauthorized leak of testimony given by Jack Rubenstein before the Warren Commission. At first, we considered reproducing the entire transcript of this testimony in On Target. After reading through many pages it hardly seems worth the paper and ink to do so. If any of our readers can make sense out of it, they're doing better than we can. The following is typical:

RUBY: I went to the building of the Times Herald, I went to the Times Herald - may I read that, Joe? May I please?

CHIEF JUSTICE WARREN: No, you are speaking very, very rational, and I am really surprised that you can remember as much as you have remembered up to the present time. You have given it to us in detail.

RUBY: Unless you can get me to Washington, and I am not a crackpot, I have all my sense - I don't want to evade any crime I am guilty of. But Mr. Moore, have I spoken this way when we have talked?

MR. MOORE: Yes.

RUBY: Unless you get me to Washington immediately, I am afraid after what Mr. Tonahill has written there, which is unfair to me regarding my testimony here - you all want to hear what he wrote?

CHIEF JUSTICE WARREN: Yes, you might read it. If you need glasses again try mine this time (handing glasses to Ruby.)

RUBY: (Putting on glasses) "This is the girl" -

MR. TONAHILL: "Thing," isn't it?

RUBY: "This is the thing that started Jack on the shooting."

MR. TONAHILL: Kathy Kay was talking about Oswald.

RUBY: You are lying Joe Tonahill. You are lying.

MR. TONAHILL: No. I am not.

RUBY: You are lying, because you know what motivated me. You want to make it that it was a premeditation.

MR. TONAHILL: No.

RUBY: Yes, you do.

MR. TONAHILL: I don't think there was any premeditation, but you go ahead and tell it your way. That is what we want you to do. That is what the Chief Justice wants,

RUBY: Not when you specify this. You are Senator Rankin?

MR. RANKIN: No. I am the general counsel for our commission, Mr. Ruby.

MR. TONAHILL: You go on and keep telling it down to Caroline and the truth.

CHIEF JUSTICE WARREN: Mr. Ruby, may I suggest this, that if we are to have any tests, either a lie detector or, as you suggest, maybe a truth serum, I don't know anything about truth serum, but if we are to have it, we have to have something to check against, and we would like to have the rest of your story as you started to tell us, because you are now getting down to the crucial part of it, and it wouldn't be fair to you to have this much of it and then not have the rest.

RUBY: Because the reason why, Joe knows from the time that I told attorney (Melvin) Belli, and the story I wanted to tell on the stand, and Mr. Tonahill knows this isn't the time. The thought never entered my mind. He knows it.

PSYCHOLOGICAL WARFARE.

Today's wars are not being fought with conventional weapons. They are being won or lost by infiltration, subversion and propaganda.

While other Americans wonder if or when we might get into another war, we Minutemen know that World War III has already started. A life or death struggle is raging right now between the forces of freedom and the conspiracy that is attempting to enslave all mankind.

The Minutemen represent one of the few groups that have not been infiltrated and largely neutralized by communist agitators. Still, we are fighting this vicious type of psychological warfare against an enemy that has many advantages on their side.

One advantage that the communists have is that of party discipline. Various communist leaders can twist the truth however they need to for their own purposes. Members of the communist party never question this. They never threaten to resign just because the communist leaders make some statement with which they personally disagree.

If we are to have a fighting chance of victory, then our own members are going to have to place a reasonable amount of trust in the organization they belong to. Our members must realize that certain statements made by Minutemen leaders are designed for their propaganda value. Some of our statements may be made to confuse or misdirect the enemy.

If the membership of the Minutemen demand that their Executive Council fully explain everything we say or do, then the propaganda value of such statements will be lost.

ANTI-MINUTEMEN PROPAGANDA

Patriotic resistance movements are always vulnerable to propaganda. One thing that our enemies will certainly do is to try to cause friction and hard feelings between different patriotic organizations. We must not fall victim to this trap.

Even though the leaders of other patriotic organizations may be tricked into making statements against the Minutemen we must resist the temptation of striking back. So long as we are all fighting the same enemy, we must avoid fighting with each other at all costs.

Another trick that the communists will certainly use is to discredit the leadership of all patriotic movements. They will attempt in every way possible to convince our members that they can fight as effectively by themselves as they can as part of the Minutemen organization.

During recent weeks a widespread whispering campaign has been launched by the communists against the Minutemen organization. In this campaign they are attempting to convince individual patriots that they should avoid the risk of belonging to any organization. These rumors are designed to convince you that you can fight more effectively by yourself than as part of a group. This is not true. The thing which the communists fear most is the organization of an underground army before they have achieved complete control in this country. Working alone it would be only a matter of time until they pick us off one by one.

Few people have the courage to fight on against a situation that seems hopeless when they are all alone. We must give each other the strength and courage needed for ultimate victory. That is the first reason why you need the Minutemen organization.

2. Information. To defeat your enemies you must know all you can about them. It is not enough simply to say the enemy are "communists". We must know what kind of cars they drive, where they live, their physical appearance, their strong and weak points, their habits and travel patterns. In addition to knowing the enemy there are a hundred other types of information which you will need. The Minutemen organization has already compiled more information in its files than anyone of us could accumulate in a lifetime.

To fight effectively you will need this information and this is the second reason why you need the Minutemen.

3. Equipment. Each member is expected to own his own gun, ammunition and other combat gear. These things are just the beginning of what an underground resistance fighter must have. The time may come that your life will depend on counterfeit identification papers. The lives of your family may depend on counterfeit food ration stamps. Few individual members have the equipment necessary to engrave and print such documents.

Most Minutemen are storing away food, ammunition, etc. What about photographic film? Communications equipment? Machinery to fabricate your own weapons? Surgical and medical supplies? Equipment for electronic surveillance? etc. etc.

As a group, the Minutemen are obtaining and stockpiling such equipment which you may sometime need most desperately. This is the third reason why you need the Minutemen organization.

4. People. There are many things that one person can do alone. A single saboteur can wreck a train or demolish a building. One spy, with skill and nerve, may penetrate the enemy's most vital secrets. Still there are limits as to what one person can do. Suppose you need a pilot but you can't fly. Suppose you need a radio operator but you have never learned the continental code. Suppose you have succeeded in intercepting a coded enemy communication but your band does not include a crypto-analyst. Suppose you succeed in capturing a number of enemy demolition charges but your band does not include an expert that knows how to use them safely.

There will be many times that your individual group will need the help of outside specialists which the organization can supply. This is the fourth reason why you need the Minutemen.

5. Coordination. During World War II the guerrilla forces in Greece were almost annihilated by the Nazis simply because they lacked coordination. Time after time two different bands would attack the same installation. The first group would alert the German troops, reinforcements would be called into the area and the second group would walk into a trap. At night one band would frequently walk into an ambush or booby traps set by a friendly band. This situation was corrected only when British Agents were sent in to coordinate the various guerrilla forces.

Without coordination the anti-communists will be almost as dangerous to each other as to the enemy. We must have coordination. This is the fifth reason why we all need the Minutemen organization.

The "D" and "E" sections of the Minutemen to whom this Bulletin is directed include a large number of members who are now part way finished with their correspondence training programs. Those of you who are now working on this training course are urgently requested to complete this training as fast as you possibly can. We can assure you that you will be assigned to a useful and important activity just as quickly as your training is completed.

HELP SUPPORT YOUR ORGANIZATION

All of us in the National Headquarters are discouraged at the number of complaints that we receive every day from our members.

"Why haven't I received my On Target on time? Why hasn't my letter been answered? Where is the material I ordered last month? Why haven't I received the information I requested?"

These and many other questions all have the same answer... We are so understaffed that we simply cannot take care of the amount of work there is to do. We don't have enough time, enough people, or enough money.

It seems that we are caught in a vicious circle. If we were able to operate as effectively as we would like, then our members would probably be glad to give us the financial support we need. On the other hand, if all of our members would pay their dues promptly, we would be able to support the necessary number of workers in our headquarters to operate with the efficiency all of us desire.

If every member would just send in \$2.00 or \$3.00 extra this month it would enable us to put in enough inventory of tapes, paper and some other supplies that would help a lot in speeding up the activities of our National Headquarters. To keep up with our mail each secretary in our office would have to answer nearly 50 letters a day. It simply can't be done. This does not start to consider the countless hours necessary for filing and indexing the incoming intelligence data or to package and ship supplies to our various Regional Headquarters. Other persons at our headquarters are engaged in research and development of new equipment. Others are working on grey and black propaganda projects which no one outside of their own secret group would ever connect with the Minutemen organization. Still, other members are working full time within the enemy apparatus. Some travel full time as couriers for the underground section of the organization.

All of these people have to have at least a minimum of living expenses.

The communists long ago gave up trying to support their activities by the collection of dues from their own members. At the present time the communists obtain their money in the following ways:

1. Misappropriation of funds. By infiltrating the tax free foundations. By raiding union retirement funds. By stealing money entrusted to them by elderly people who fall victim to communist lawyers.

2. Blackmail. The communist party includes hundreds of sex perverts and teen age girls who work full time at putting wealthy men in a position where they can be blackmailed to support the communist party.

3. Through the sale of narcotics. When the drug companies of the United States sent supplies to Castro in exchange for those prisoners captured at the Bay of Pigs they included hundreds of pounds of morphine. This morphine has been treated with acetic acid in Cuba to produce heroine which is 20 times as addicting as the original compound. This heroine is now being smuggled back into the United States. It is being used to both help finance

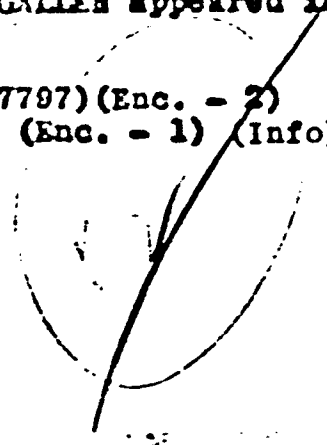

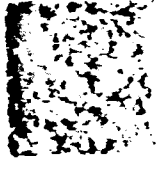

In the course of the investigation in the matter captioned JACK L. RUBY, Aka., Jack Leon Ruby, LEE HARVEY OSWALD - VICTIM, Deceased, CR, [redacted] Texas, furnished the following information:

In the late 1920's or early 1930's, the Home Trust Company, South Main Street, Kansas City, Missouri, was held up by four men who were subsequently identified as three Italian boys and one Jewish boy. [redacted] recalled the nicknames of two of the Italian boys as LOLLIPOP and MAGACINA. He could not recall the name of the third Italian boy. The Jewish boy's name was JACK RUBY.

[redacted] went on to relate that he could not recall, in amount, the loot but said that they effected their getaway in a Buick automobile. At the corner of 12th and Main in Kansas City, Missouri, a manually operated stop and go sign was operated by a Kansas City policeman named "HAPPY" SMITH. According to the information furnished by [redacted] the getaway car ran the stop sign and gunned down policeman [redacted] killing him. [redacted] recalled that the Jewish boy, JACK RUBY, allegedly shot the policeman.

In running the stop sign, the door handle of the Buick was torn off and the car was subsequently identified by means of this damage. Through this car, the Kansas City Police Department identified the three Italian boys who were tried, convicted and executed for this holdup and murder.
