

They ask me if
I had saw Lee
Harvey Oswald and
I told them I
let him out and
Ruth I said she
would take him
home with her
and help him get
a job. They said
if I saw him again
to tell him Jack
Ruby wanted to
see him and I told
them I would
do that.

I drove over
to South Oak
Cliff near where
I lived and stopped
for coffee. And started
to writing my
notes on what had
happened. And Dexter
& Joppita come in
the restaurant &
~~stop in~~ ask
if I had a gun
in the pickup.
I said no. They
said they noticed
some blood in
the floor.

I told him I
didn't know
they was in
there, when I got
back in the
pickup I picked
three blacks up
and put them
in a envelope and
put them in
my brief case
with some papers
I had with my
notes.

Then I drove
to ~~1310~~ 1310 Meritt
St.

That was on a
Sunday afternoon
about three P.M.
on Monday I went
to Caswell Dr. B.
to have my teeth
extracted.

After my operation
I wondered about
the stick with the
Communist Flag on
it, and remembered
about Caswell saying
he dropped it
when he shot at
the man with

gun, and little
girl. So I decided
to go back and
see if I could
find it. I remembered
the exact spot
where this happened
because there was
a culvert there
on the railroad.
So I drove back
and found the
Communist guarding
iron. I put that
in a envelope also
and put it in
my brief case

I also found
Lee Osballe Pistol
and kept it
April 1963. I
was driving out
Turtle Creek Blvd
and Decline Tipton
and the other
officer had Oswell
by the
hairs. And I
slowed down to
almost a stop and
they told me I
had better go on
if I didn't want
to get shot

So I drove on
and just as I
passed Mr Walker
house I heard a
gun shot and
I saw Mr
Walker sitting at
a desk I turned
around and drove
back by there and
I saw a tall
slim grey headed
man come out
of some bushes
across the st
from Mr Walker
house.

Friday morning April
5, 1963. I was driving
my wife to work
to Columbus Pizza
bakery where she
was employed as
a book keeper.
after I dropped
her off on Haskell
St. I was driving
back home & picked
up Harvey Oswald
again. He
told me he sure
was worried about
what he was going
to do with

And what he was
going to tell his
wife about where
he was all night
I ask him where
he was and he
said he couldn't
tell me. And I
turned around and
drove back toward
Haskell st. And
on the west side
of Central Express
way he pointed
north. And said
down there. And
that's all I can

tell you if I
ever told you
they would kill
me. I said they
won't. And I finally
found out that
Tuppits had kept
him at their house
all night. He
said their wife
was walking
all over him
all night &
ask him why
he didn't tell
his wife that
he had attempted

to spot Gen
Walker. He said
why tell her
that and I said
she is Russian
not pt. Oswald
said yes. I said
she would like
if you attempt
to kill a
General. He
said he was going
to tell her that.

That is one thing
I know Lee Oswald
didn't do so

Was blamed for
I drove Oswell
down town some
place and let
him out. Then I
didn't see him
again for some
time. Utility ~~for~~
about the 15 of
June 1963. I had
fell off of a bridge
and got hurt and
was out of a job
and read to want
add where they
needed Carpenters
at Irving Texas

I got up and
left home about
6:30 Am and ~~went~~
West north on ^{Industrial}
~~St. Blvd~~ ~~Free Way~~
and turned west
on highway 114 and
drove about four
or five miles and
crossed a ~~long~~
Long river bridge.
I was driving slow
and I heard some
one shooting a gun
and yelling damn
spitting at the
President's head

I crossed the bridge and come to a business district and stopped and ask the way to Spring. They told me to go to the next black top road and turn to the left. and that would take me to Spring.

While driving across from Highway 119 to Spring a pickup truck passed me and

When I stopped at
the next intersection
Lee Cowell got out
and ask if I could
ride in to town
with me and said
sure. I didn't go
and apply for the
job because it
~~was~~ had got too
late for me to
apply for it and
stopped and called
my wife and told
her I had picked
up a boy that
was in Russia

for three years
and wanted her
to meet him & drive
back by the house
and picket me
wife up and we
carried him to
by the Western
Union. He said he
was expecting some
money, Ruth and I
was talking about
driving off and
leaving him in
the Western Union
when he come out
and got in the

Car, Ruth my wife
ask him what he
thought of this
Country, he said
he liked it. And
liked Texas. But
he would like
to kill General
John Conley. I
ask him why
he said, because
he had wrote him
a letter and he
had completely
forgotten to answer
it. I told him
Mr Conley was

a fine man. And
he didn't want
to kill him.

And if I was in
his place if President
Kennedy ever
come to Dallas &
I would leave
town. Because if
President Kennedy
was killed by
I would be blamed
for it. I had
heard every ^{body} saying
about some Democrat
official from

Washington Ordine
The Post office
dept. to put
thirty Collard People
ahead of the white
people with more
creedity than the
white white

Collard people
had. They claimed
that the President
should be killed.

Before I got to
the Book place
where I let
Aswell out.

ask him if he
was a Communist
He said no
I am writing a
book. And I hope
way I could have
gone to Russia
was to pretend
to be a Communist.
And he also told
me that he was
trying to go to
Cuba.

After that I
~~didn't see Oswald~~
~~any more until~~
President Kennedy

I ask Jim why
he didn't make
someone fly
him to Cuba.
He said he was
afraid he would
get in trouble
if he did any
thing like that.

After that I met
the Federal Lady
Judge that swore
Linda Johnson in
as President and
I told her about
Oswell and

ask her to have
some one to watch
him and the places
he went and the
people he met.

I met Ruth?
and she invited
me to come to
her house one night.
She said they was
going to have seven
speaking Russian
Learners I got her
address and phone
No and told her
I would come

and dressed to
go and drove ~~down~~
down town, and
decided not to
go. And called
her and told
her I was afraid
if I messed around
with any Russians
or Russia Saucage
my name would
be mud. In
Dallas, Penka
I was only inter-
ested in her.
She refused
me.

I have told the
F.B.I. Part of my
story and told them
about my notes being
in Stamps in
Dallas. where they
could find them.

I left Dallas in
August and left
them locked up
and moved to
Houston, Texas. and
stayed there until
Nov. 10, 1963. and
Went to Chicago.

And I didn't
see or hear of
Lee Harvey Oswald.
Until I saw his
picture on T.V.
Accusing him of
Killing President
Kennedy.
