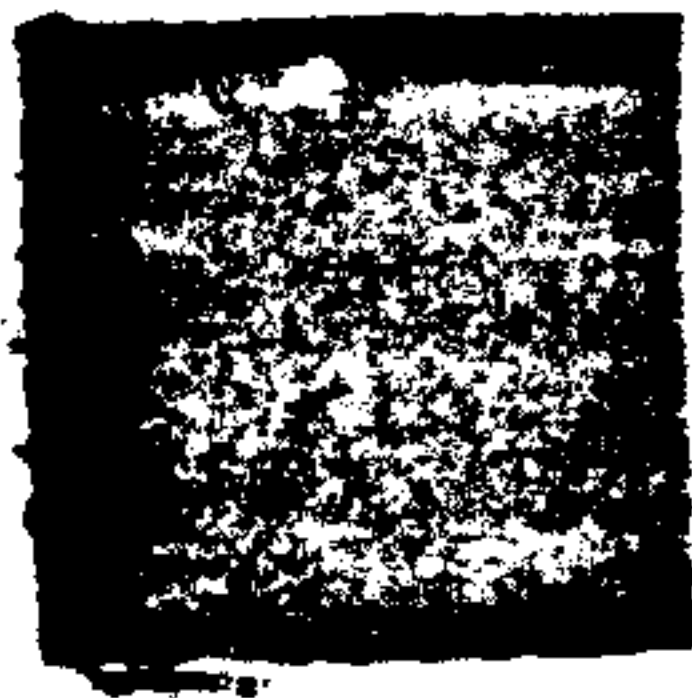

## APPLICATION COMMITTEE:

No written report received, however, Pastor Honold reported verbally on several cases as follows:-

A member of the Board of Directors of the Home for Incurables advised that they would return \$150.00 of the money paid them for the care of Miss. Hilda Boeck.

A case was submitted by Pastor Nau from Redeemer Church involving a boy 10 years of age, 1 boy 8 years and another 2 years. The mother was married to a Mr. Pickens, later married to a Mr. Oswald who has also died. While she has some money left from insurance policies finds it necessary to seek employment and would like to have the children placed in the home. Pastor Nau was informed we could do nothing about the boy 2 years old, but something might be done about the other two children. Pastor placed in the hands of the Committee with full power to act.

HAUPT CASE: Mr. & Mrs. C. Haupt requested permission to take their niece 8 years old with them for the Christmas Holidays. The mother has given permission. They would like to take the child permanently and Pastor Honold suggested they take legal adoption proceedings. The mother is not willing to agree to such proceedings. Another plan was suggested. The foster home arrangements whereby we would release the child to Mr. & Mrs. Haupt and still retain guardianship over her. The mother is willing to agree to such an arrangement, which would have to be worked through the Juvenile Court. On motion made seconded and passed the matter left in the hands of the committee with full power to act.

The report was then adopted as a whole.

## SUPERINTENDENT'S REPORT:

Superintendent reported no change in the enrollment since last report. Fifty children on roll, forty nine in the home and Leonard King at Austin. Superintendent also advised that all children has been placed in different homes Thanksgiving Day. The Film of the home had been shown in Passcagoula and while the attendance was not very good the collection amounted to \$20.00. Pastor Honold suggested we try and get the parents and relatives the children to take them from the home during the Christmas Holidays after the Christmas Eve. celebration. The matter was left to the discretion of the Superintendent.

SCHOOL BOARD: No report. Mr. Heintzen suggested that we include in the Pension Plan our teachers Mr. Koschmann and Miss. Anna Wegner. On

Dear Mr. Clemons:

Yours of the 16th. Jan. received and contents noted. Your statements seem to be eminently correct with one glaring error in par. 8 on page 1..

The facts are that Rubenstein was in the Dallas News advertising office at Young & Houston Streets which is SIX BLOCKS south of ELM ST. & HOUSTON WHERE THE KENNEDY CAR WAS WHEN HE WAS "LIQUIDATED". The advertising office has no windows facing NORTH - therefore any view of the Kennedy caravan or parade fro that location was impossible.. The news building is six blocks south and on the southeast corner.. Kennedy's car had already turned WEST on the Elm St. approach to the triple underpass.. Even from the roof of the News Bldg. or from any window facing north a person COULD NOT HAVE SEEN THE KENNEDY CAR or parade.. However one could have seen the Texas Book Depository from such a vantage point.. Incidentally Rubenstein was stalling around the Dallas News Ad Office, and used a phone from there at about the time Kennedy was shot.. RUBY SET UP A PERFECT ALIBI FOR HIMSELF THAT WAS AND WILL REMAIN SHOT PROOF AS FAR AS HIS PERSONAL POSITION AT THE TIME ACTUALLY WAS.. He seemed very nervous to persons in the office and later cancelled the advertising he placed for the Saturday and Sunday papers.. No part of this corrected data should be taken to mean anything beyond what I have stated-- Ruby's alibi for the time of the liquidation is letter perfect..

Par. re PAINE'S occupation-- He is an aeronautical engineer with BELL HELICOPTER, near Ft. Worth in Tarrant County, Texas and is separated from his wife who resides in IRVING, TEXAS - between Dallas and Ft. Worth.. I do not know if they are divorced but they are and were separated when Oswald liquidated JFK..

I turned the Chronicle tear sheets over to my old friend Sheriff Bill Decker and presume he turned them over to Henry Wade, Dallas County Dist Atty within 48 hours of their receipt by me..

Rubenstein's Bond hearing comed up tomorrow (Jan. 20) in Judge Brown's Court and Belli is trying for release on bail and for a change of venue to Fort Worth where a Jew stooge in a State, or in a Federal Court, could preside We'll know what success he has when this hearing is over// They are running additional psychiatric tests and an electric "brain wave test" on Ruby today. apparently Belli hasn't gotten the right Psychiatrist for the Defense so far.

I will probably be talking with Sheriff Decker after the Bail Bond deal is disposed of and shall show him your letters for his information.. I am of the opinion that all points you have mentioned have been and ARE BEING very thoroughly covered.. Un fact know several are still being checked but am not in a position to discuss any part of them.. Belli obviously wants to definitel put the monkey on Oswalds back for the assassination and plans to try to do so during the bond hearing.. as of now it looks as though he won't be able to introduce that evidence..

Dear Tex;

I have this date received a very interesting REPORT re. the DALLAS INCIDENT, as its now being called, and feel I should inform you of some of the high points in it...

The Rooming House where Oswald roomed was at 1026 North Beckly Street...

Oswald and wife were taken in by a Mr. Mrs. Paine, an ENGINEER, and Mrs. Paine had a Station wagon, which evidently was used to take Oswald to Old Mexico... *and other places*

Bernard Weissman and another New York jew drove from New York City to Dallas to place an AD, FULL PAGE in DALLAS Papers...

The Paines were evidently members of the 'American Civil Liberties Union', and took Oswald to meetings with them.

Mr. Truly, is the Manager of the Texas School Book Depository, and Mrs. Paine, called Mr. TRULY and got Oswald the job there... Evidently TRULY was IN on this...

Five anti-Communists were seized and held by Dallas Police for FOUR DAYS ~~with~~ seized within moments after the shooting of Kennedy... *do you know who they are, they are not to be?*

Jacob Rubenstien its reported was in a Dallas News Paper Advertising Office, placing an AD for his JOINT, and the Kennedy passed this Office, others ran to window to see Kennedy go by, but Rubenstien never bothered to take a look... Was Kennedy really an IDOL to Rubenstien?

Rubenstien seemed calm until it was announced that Oswald was going to TALK, and THEN became panicky

Mrs. Paine evidently attended Antioch College and the University of Pennsylvania, is a UNITARIAN... She sheltered and transported Oswald, BUT no photo of her or her husband has ever been made public... WHY ???

Its very probable some one in Yellow Springs, Ohio may have some News Papers or items, which mention left wing activities which would show what Mrs. Paine did while attending Antioch, which was VERY ACTIVE in the ABOLITION of the HUAC COMMITTEE ...

Oswald's wife is reported to be a HIGHLY SKILLED PHARMACIST. Mrs. Paine studied Russian and was able to talk with Oswald's wife, its reported the only person who was and did talk with her...

Oswald's wife's name before marriage was - Marina Fruskova, reported to be a very attractive girl.

Oswald and wife arrived in USA from Russia June 13-62  
Michael Paine is reported to have offered to publish a BOOK for Oswald, is there a Publixher in Dallas by this name ?????



These "investigations" frequently uncovered additional criminal information, etcetra. but the operator was not permitted to pursue any investigation of those SIDE EFFECTS.. He reported the data uncovered and that was IT.. If found desirable to investigate orders would be sent by the Dept. of Justice to the Director of the FBI and he would assign a man or men to continue the investigation.. OF COURSE SUCH PROCEDURE GIVES THE DEPT. OF JUSTICE (specifically the Atty. General) and the Executive Dept (President & advisors) unlimited opportunities to CASH IN on the underworld... That this has been done within the past 30 years in many instances would seem apparent when cases that have been "covered-up" are looked into.. That the evidence is not available to follow up on such cases is not surprising.. Within the past TWO YEARS we have witnessed some of this type of chicanery in connection with contract awards, drug investigations, Communist infiltrations and activities and other criminal or quasi-criminal activities ranging from the "blackmail paid Castro to release the Bay of Pigs survivors; the TRX contract; negro voter registration; reversal of Communist convictions, failure to enforce Communist registration laws, etcetra, etcetra - and such items as Dierksons reversal on the H Test Ban Treaty after JFK collected 97 thousand dollars from Haiti for Dierkson's nephew, the Baker case, etcetra are only minor breaches of trust. However, I do not have time to go into details so suggest you look 'em up.

Referring to your suggestions re Oswald-Rubenstein investigations,, You may rest assured all points you mentioned have been covered, recovered and are still under investigation by competent, honest Dallas officers, Sheriff officers and a special contingent from the State Dept. of Public Safety.. There is probably quite a bit that will come out when Rubenstein's bail hearing comes up Jan. 30 and far more in reserve for his trial.. I know of NO TEXAS LAMAN IN THE GROUPS MENTIONED WHO HAVE CONFIDENCE IN THE TRUTH BEING MADE PUBLIC BY THE SPECIAL WARREN COMMITTEE or any other Johnson may appoint.. However, this may not bottle up all information permanently since "leaks" similar to the "note Oswald wrote on the attempt he made to kill Maj. Gen. Walker are sure to occur... AT THE PRESENT TIME INFORMATION IS NOT BEING RELEASED THAT MIGHT HAVE ANY BEARING ON RUBY'S TRIALS.. MIGHT ALSO ADD NONE WILL BE RELEASED BY DALLAS POLICE, SHERIFF OR DEPT. OF SAFETY UNTIL IT IS USED IN COURT.. THE F.B.I. on orders from Johnson and the Dept. of Justice has gathered in all reports, evidence, and available data which little brother bobby and the loud braying jackass (LBJ) immediately turn over to the "Warren Committee".. They sort out the material and whatever **repo** t they make will be based upon what they choose from the mass of data they have received... However, parts of this data and/or copies of important evidence are still in local hands WAITING TO BE USED -- and in view of the "dirty" smoras" from the controlled press and Jewish sources LOCAL OFFICERS ARE NOT GOING TO BE SITTING DUCKS FOR ANYONE... Nuf sed!!!!

With EARL WARREN heading the President's Investigating Committee the big question now is his eligibility to head the Supreme Court if the Ruby case is appealed to that tribunal.. Rather an interesting question, What?!

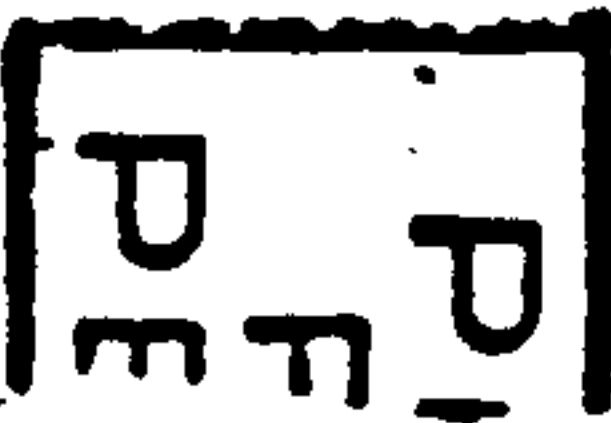

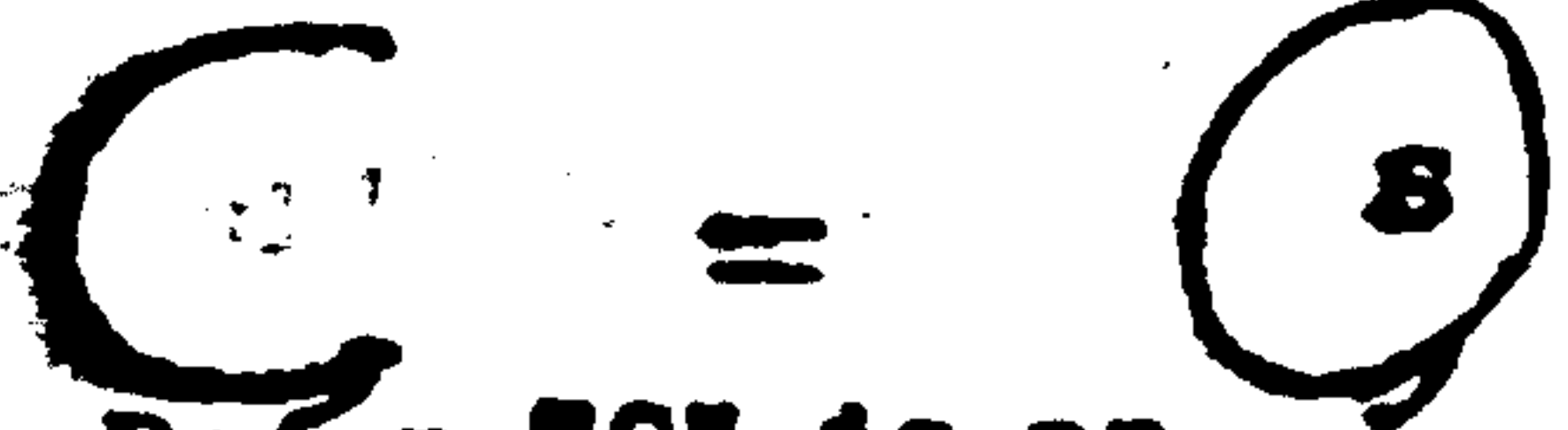

[redacted] has checked out allegation that Oswald was seen distributing pamphlets entitled "Fair Play for Cuba" in Montreal during the Summer of 1963. Commission has been furnished by letter of 4/8/64 copies of the LHM furnished by Legat, Ottawa. Commission has been advised in relet that no further action is being taken by this Bureau inasmuch as it appears that the distribution of pamphlets occurred on 6/7 and 8/63 instead of August, 1963, and Oswald was at work in New Orleans on Friday, June 7 and also on Monday, 6/10/63. Also, our inquiries disclose no record that Oswald made any foreign trips from the time of his return to the U. S. in June, 1962, until his visit to Mexico in September - October, 1963.

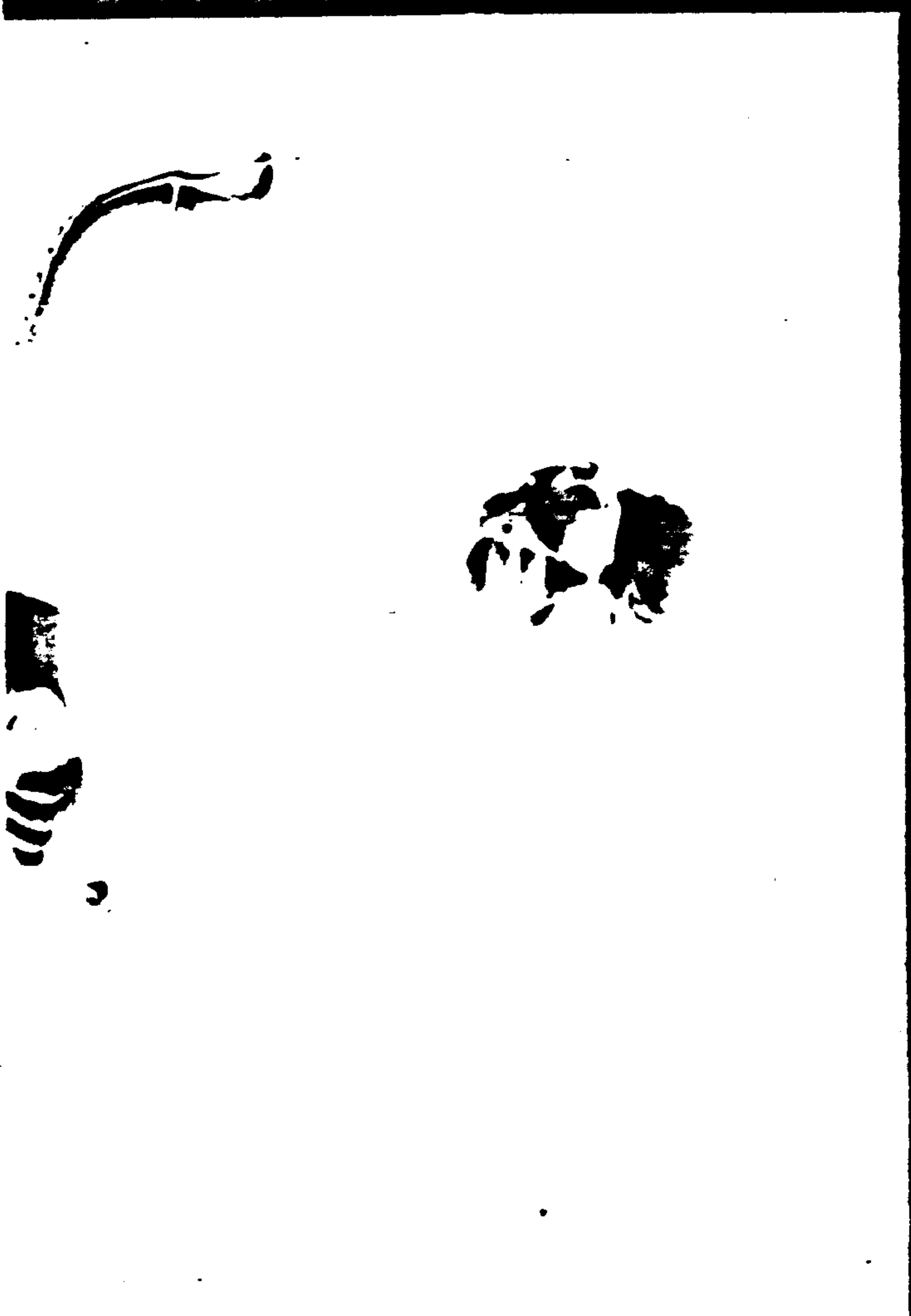

# Lee Oswald's Letters To His Mother

(with footnotes by Mrs. Oswald)





Lee went to Russia in November of 1959. He was in Russia twenty months before I had the first letter from him.

I was in constant touch with the State Department with no result, so I made a personal trip to Washington, D.C., in January, 1961, and approximately in March I received an answer from the State Department informing me of my son's whereabouts. He was in Minsk, Russia, where he was working in a radio factory. When he first went to Russia it was in the paper that he was in the Metropolitan Hotel in Moscow, and then for twenty months I didn't know whether Lee was alive or dead.

Lee joined the Marines at age seventeen, on his birthday. Three years later he got out of the Marines and three days after that went to Russia. Lee wrote continuously while in the Marines, and then stayed with me for three days when coming out of the Marines, and there's much speculation about the three days because he did leave a mother who was partially ill. I had had an accident. But Lee and I discussed this immediately upon his return. I was destitute and matter of fact, Lee got a dire-need discharge because of this accident, but he was only out of the Marines three weeks before his time would have been up. I started through the Red Cross at Lee's insistence, to see if he could help me in July. But it was September before he was released, and I have always said those three months of negotiation meant either that I could have been well and not needed my son, or that I could have been dead and not needed him, also. But someday I hope to do something about this, because I am sure there are very many other mothers who are ill and need their sons and I would say that they need them immediately and not at all.

through the Government red tape for three months before they are sent home to help their mother out, however the case may be. So, after the three days—Lee said, "Mother, I have no background of work, and if I stay here the only salary I can demand would be \$80 to \$85 a week." Now we're talking about Texas, and not the Eastern states, because the salaries there are very, very low and actually that is the standard salary. And he said, "You're broke, so we would both be in the situation that you're in, so I've made up my mind that I'm going to work on a ship in the import and export business, where I can demand some money and I'll be able to help you."

I agreed with Lee because this is the way you help seventeen-, eighteen-, nineteen-year-olds, and I said, "It's a wonderful idea; but why don't you wait; Mother will settle her claim." It was not a suit, it was a compensation claim, I would be entitled to sixty percent of my salary, and the claim would have to be settled. In the meantime, probably I could baby-sit, and together we could manage. He said, "No, my mind's made up. We'll both be as bad off as you are now if I try to find work here, so I want to work on a ship." This was good thinking, and he was right, because a \$35-to-\$40-a-week job would not take care of a mother and a boy. So I accepted the fact that he has a right to his own mind. And so he left, and one week later I received a letter from Lee from New Orleans, stating that he had passage on a ship to Europe and he didn't expect me to understand, but to please try and understand—"This is something I must do," and so on, so then about a week later I picked up the paper and knew that he was in Russia.
