# My Values Different, Defector Told Mother

NOV 15 1959

Lee Harvey Oswald, 20, the Fort Worth ex-Marine who defected to the Communists, wrote his mother a letter before he set sail for Russia but failed to tell her the destination, she disclosed Saturday.

Oswald revealed in Moscow two weeks ago that he had turned in his U. S. passport and asked for Russian citizenship. He announced there Saturday that his bid had been turned down.

Mrs. Marguerite Oswald, of 2616 Harley, tearfully read aloud here Saturday the letter she received from him before he left this country but said she had no idea when she got it what her son had in mind.

The letter:

"Dear Mother: Well, I have booked passage on a ship to Europe. I would of had to sooner or later, and I think it's best I do now. Just remember above

all else that my values are very different from Robert's or yours. "It is difficult to tell you how I feel. Just remember this is what I must do. I did not tell you about my plans because you could hardly be expected to understand.—Lee."

"I thought at the time he might be going to South America, but it never entered my head that he was planning on going to Russia and try to become a citizen there," she said.

"I feel very strongly that as an individual he has a right to make his own decision."

She described her son as "a bright boy," one who had to quit school at 14, but was so set on getting an education, he quit and returned three times. He quit, she said, to help earn a living.

"He finally got his high school diploma by attending school while he was in the Marine Corps," she said. He quit in the eighth grade to join the service.

The last letter she received from her son was postmarked New Orleans where he had gone, she thought, to get a job at an export-import firm. They used to live in New Orleans and he worked for such a firm.

She said Lee liked history, maps, and "deep books" as a child. He also liked to fish, taking a pole and catching a street-car to Lake Ponchartrain when they were in New Orleans.

She said she believed Lee Harvey would probably get in touch with her or his brother, Robert L. Oswald, 7313 Davenport, now that Russia has rejected his application for citizenship.

"Lee has definite ideas. I believe God gives us a conscience and the ability to know right,

and I feel he has a right to his own decision."

Mrs. Oswald was injured in December on the job when a carton of candy struck her in the face. She hasn't been able to work since.

# Fort Worth Defector SUN NOV 15 1958 Confirms Red Beliefs

MOSCOW, Nov. 14 (UPI). — Lee (Oswald) still sporting the chop-top haircut he wore in the U. S. Marines, said Saturday that when he left America to seek citizenship in Russia "it was like getting out of prison."

But his dream of achieving Soviet citizenship in exchange for the U. S. citizenship he renounced went aglimmering. The 20-year-old Texan from Fort Worth said Soviet authorities would not grant him citizenship although they said he could live in Russia freely as a resident alien.

"Imperialism" and lack of money while a child were his main reasons for turning his back on his native land, he said.

A slender, well-groomed youth, he carefully thought out his phrases before speaking in an interview at a Moscow hotel.

He had announced on Oct. 31 that he had renounced his U. S. citizenship and was seeking Soviet citizenship "for purely political reasons."

He said he told the U. S. embassy he was a devoted believer in communism and had read books on the subject since he was 15. Memories of a poverty-stricken childhood played a part in his decision, he said. His father, he said, died before he was born.

"I saw my mother always as a worker, always with less than

we could use," he said. He insisted his childhood was happy, despite poverty. He admitted his mother "would not understand" why he had fled to Russia.

"In the Marine Corps I observed the American military in foreign countries, what Russians would call military imperialism," he said.

"I was with occupation forces in Japan and occupation of a country is imperialistic," he said.

"I would not want to live in the United States and be either a worker exploited by capitalists or a capitalist exploiting workers or become unemployed.

"I could not be happy living under capitalism."

He said Karl Marx' work "Das Kapital" set him on the road to communism, and he began to read all he could find about it.

Oswald joined the Marine Corps at 17. During his hitch he learned to be a specialist in radar and electronics.

"I saved my money—\$1,600—to come to the Soviet Union and thought of nothing else," he said.

Many things bothered him in the United States, he said—race discrimination, "harsh" treatment of "underdog" Communists and "hate."

# Attempt to Halt MORN NOV 2 - 1959 Defection Made

Robert L. Oswald of 7313 Davenport made an effort Sunday to contact his younger brother, Lee Harvey Oswald, who announced in Moscow Saturday that he wanted to give up his U. S. citizenship to become a Russian.

The older brother dispatched a cable to Lee Harvey Sunday in care of the U. S. embassy in Moscow asking the brother to get in touch with him.

He also sent a telegram to Secretary of State Herter in Washington requesting his help in establishing contact with Lee Harvey.

At the same time, he disclosed that his mother, Mrs. Marguerite Oswald, 53, had been placed under sedation by a doctor. She has been in seclusion in Fort Worth since the news of her son's defection broke.

The cable to Lee Harvey said simply:

"Lee, through any means possible, contact me. Mistake. Keep your nose clean."

The telegram to Secretary of State Herter said:

"Wish to have brother, Lee Harvey Oswald, in Moscow, contact me as soon as possible through fastest means available. Would you please help?"

Young Oswald, 30, turned in his U. S. passport at the American embassy Saturday and announced he wanted to become a Soviet citizen.

A former Marine who grew up in Fort Worth, he was advised to wait until he was sure a Soviet citizenship would be tendered.

Robert L. Oswald said Sunday he intended to take every "reasonable" step to see that his brother changes his mind.

He said again that he didn't believe Lee Harvey realized what he was doing.

The following is a verbatim transcription from our recorded radio calls on November 22, 1963, on Channel 2 of KKB 364. Channel 2 was activated at 10:00 a.m. on November 22, 1963, and went off the air at 5:12 p.m. This transcript includes only the transmissions that might have a bearing on investigations or events of the shooting of President Kennedy on this date. There were no transmissions on Channel 2 for the dates of November 23, and November 24, 1963, concerning the assassination of President Kennedy.
