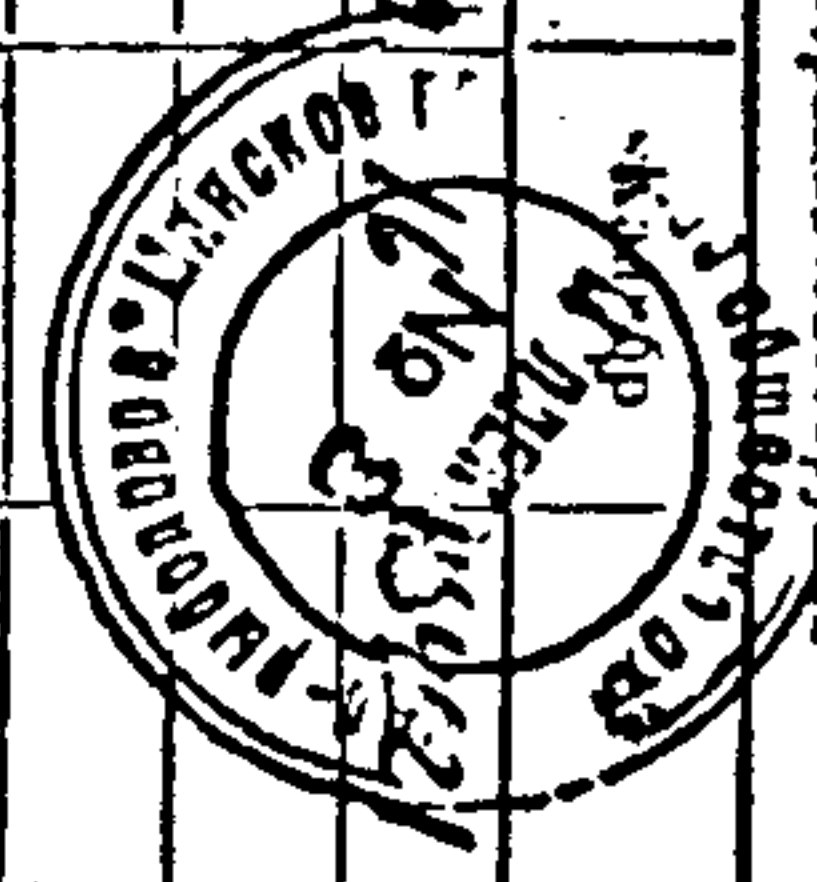

3. Охотник имеет право охотиться на всей территории СССР, за исключением заказников, заказников, а также охотничьих хозяйств, охота в которых может производиться только с разрешения администрации хозяйства.

10. При получении охотничьего билета для продажи, обмена или аннулирования в случае прекращения срока охоты в порядке пользования охотничьим оружием и боеприпасами.

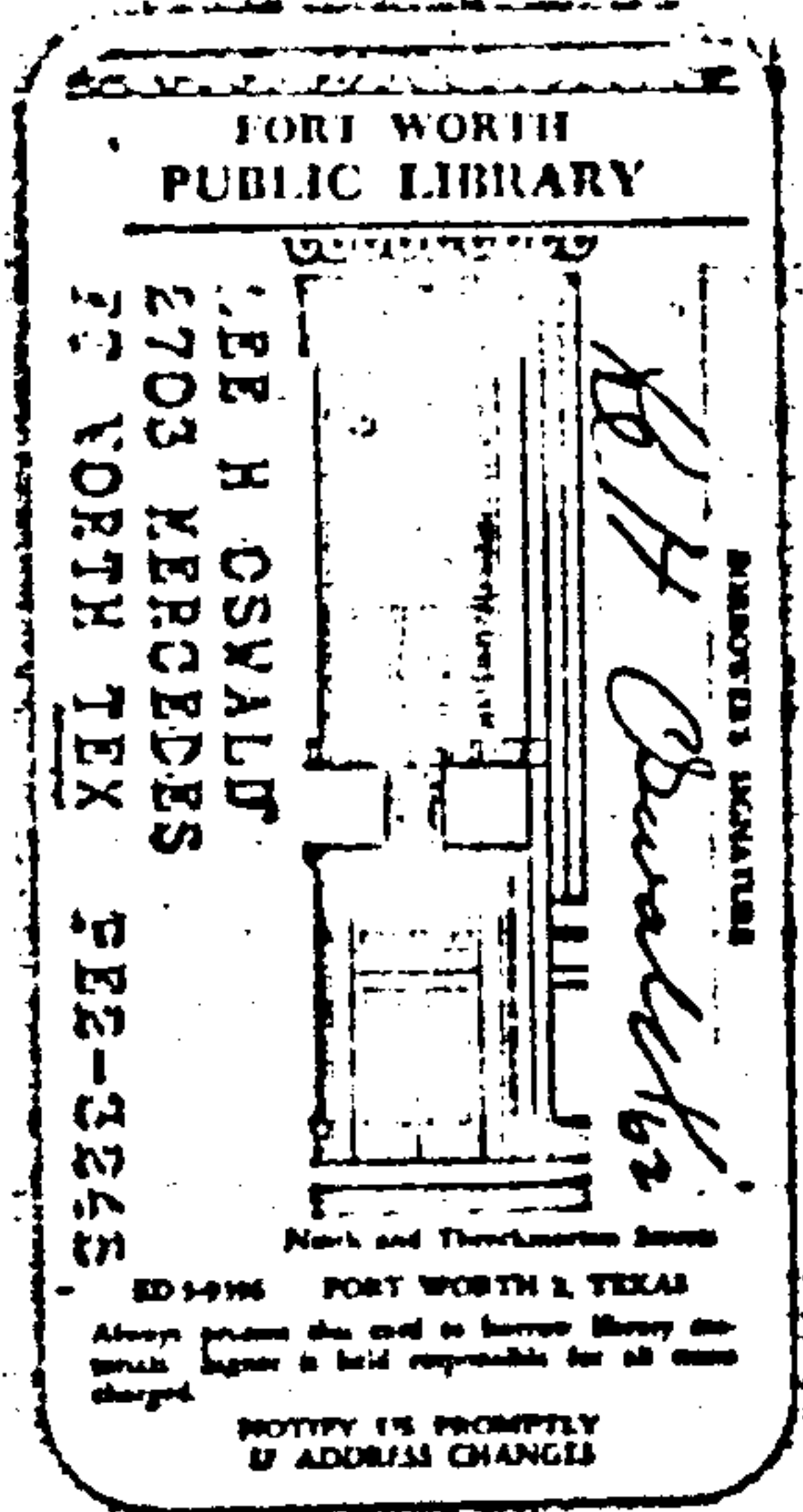

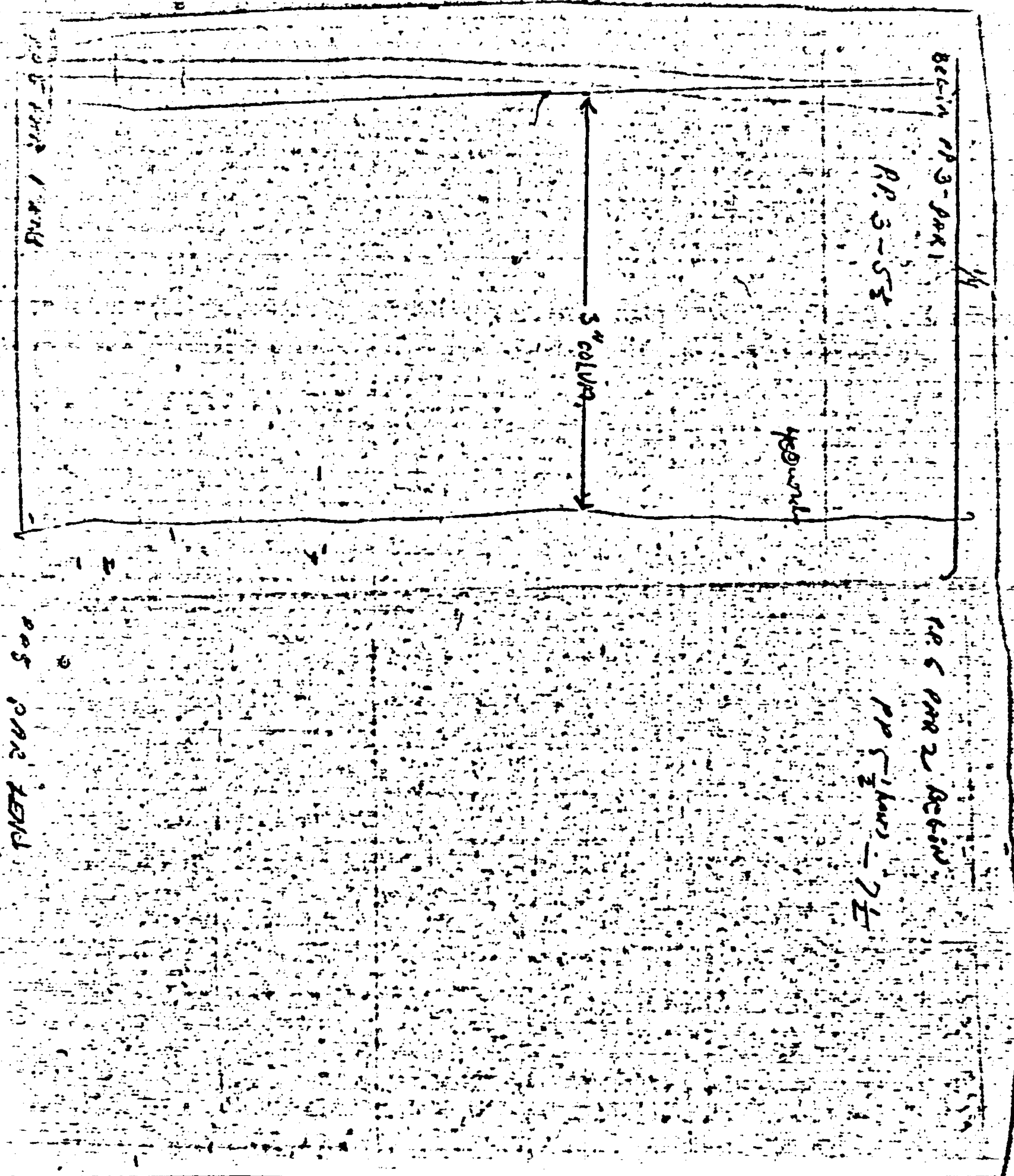
