NORMAN FREDERIKSEN, GRADUATE STUDENT, U OF WIS., ADVISED.

SA ARTHUR F. BAIER ON DECEMBER FOUR LAST THAT SOMEONE TOLD HIM THAT OSWALD, UPON RETURN TO U. S. FROM RUSSIA, WOULDNT TAKE A JOB EXCEPT IN A PHOTO LAB. FREDERIKSEN FELT THE SOURCE OF THIS INFORMATION MIGHT HAVE BEEN ILYA MAMANDOR, EMPLOYEE OF SOCONY COMPANY, DALLAS, TEXAS. FREDERIKSEN SAID HE BELIEVED MAMANDOR WAS RUSSIAN BORN BUT NATURALIZED U. S. CITIZEN. HE ALSO STATED MAMANDOR WOULDNT GO ANY PLACE WHERE HE MIGHT FIND OSWALD, AS HE DIDNT TRUST HIM AND DIDNT WANT OTHE PEOPLE TO SEE THEM TOGETHER.

BRANIFF AIRWAYS, SAN ANTONIO, ADVISES WILLIAM LINDERMAN, WHO WORKS TICKET COUNTER, ON VACATION AND WILL RETURN TO SAN ANTONIO DECEMBER NINE NEXT. LINDERMAN IS SINGLE AND IS BELIEVED TO BE VISITING HIS RELATIVES OF SAME NAME AT DYSART, IOWA, AND MAY HAVE LEFT THERE TO VISIT FRIENDS IN MINNEAPOLIS, MINN., AND A FRIEND KNOWN AS QUOTE WHITY UNQUOTE, EMPLOYED AT BRANIFF AIRWAYS, MINNEAPOLIS, WILL PROBABLY BE CONTACTED BY LINDERMAN.
