At approximately 8:30 AM, 4/2/64, SAC H. G. MAYNOR, of the New Orleans Office, telephonically contacted the Dallas Office, at which time he was desirous of determining whether the results of investigation conducted by various offices in an effort to determine OSWALD's mode of transportation from New Orleans to Houston, on 9/25/63, had all been reported.

Mr. MAYNOR was advised that all information pertaining to this aspect of OSWALD's travel had been reported under the travel sections of the various reports and that, from personal recollection, no positive information as to his mode of transportation from New Orleans to Houston had been obtained.
