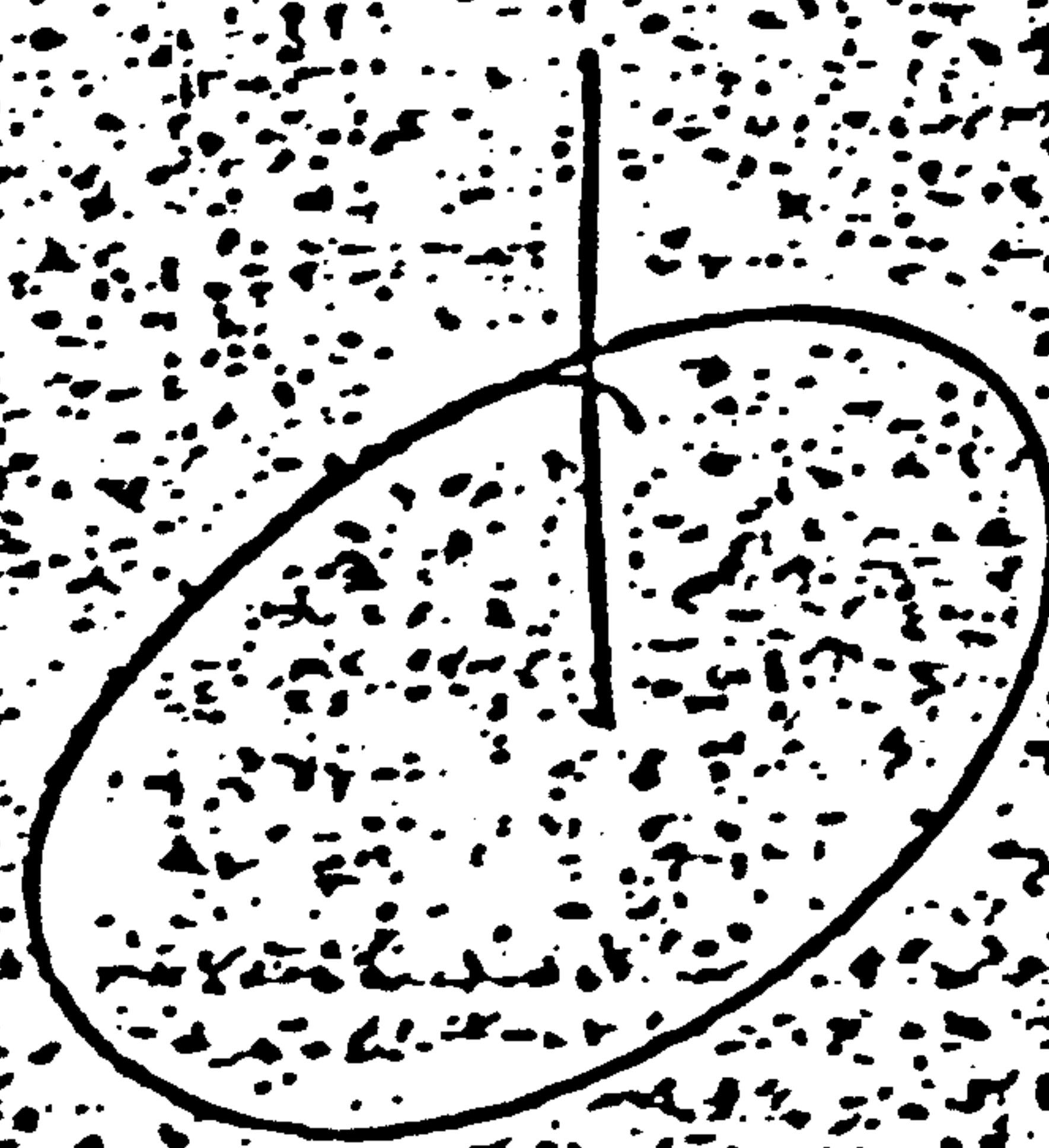

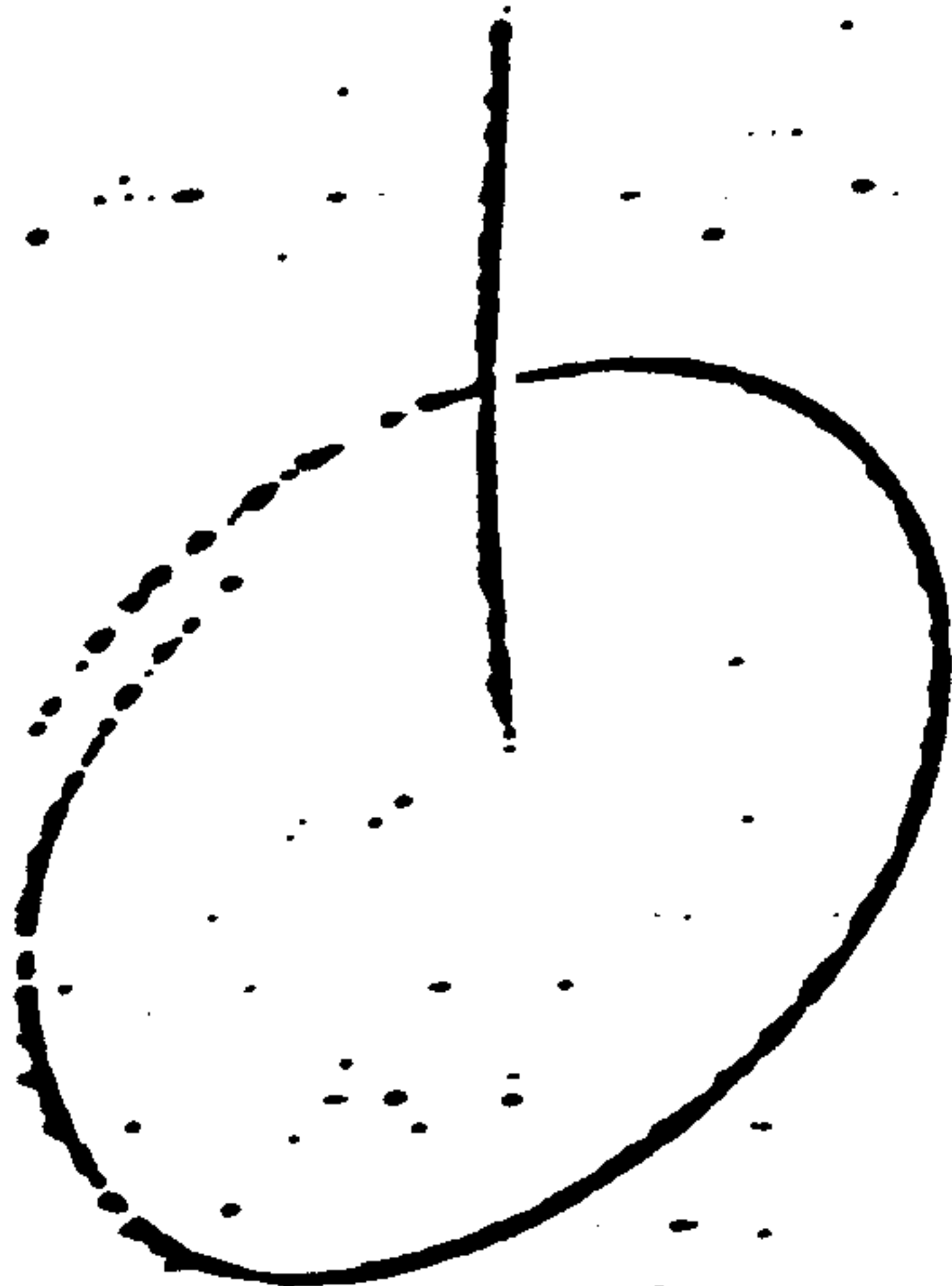

At 8:45 AM today, L. L. SHANEYFELT called from Bureau regarding the change requested on 6/1/64 in the affidavit of SA IVAN D. LEE. He noted that the letterhead memo that was prepared to go to the Commission covering the interviews of people about license plates and approximate date of the pictures, etc., page 9, made mention of the Praktina camera used, when in fact it was a Robot camera.

I advised SHANEYFELT that the corrected affidavits were mailed to Bureau by airtel, 6/1/64 and that the airtel also instructed Bureau as to what changes to make in the letterhead memo to show correct camera used. Although SA LEE had both cameras out to the Walker residence area, he used only the Robot camera. The camera was not mentioned in the FD 302.

SA LEE advised SHANEYFELT that he had taken photos in the railroad area, and SHANEYFELT stated he does not want those photos in the Bureau. SA LEE advised that they will be filed in Dallas office.

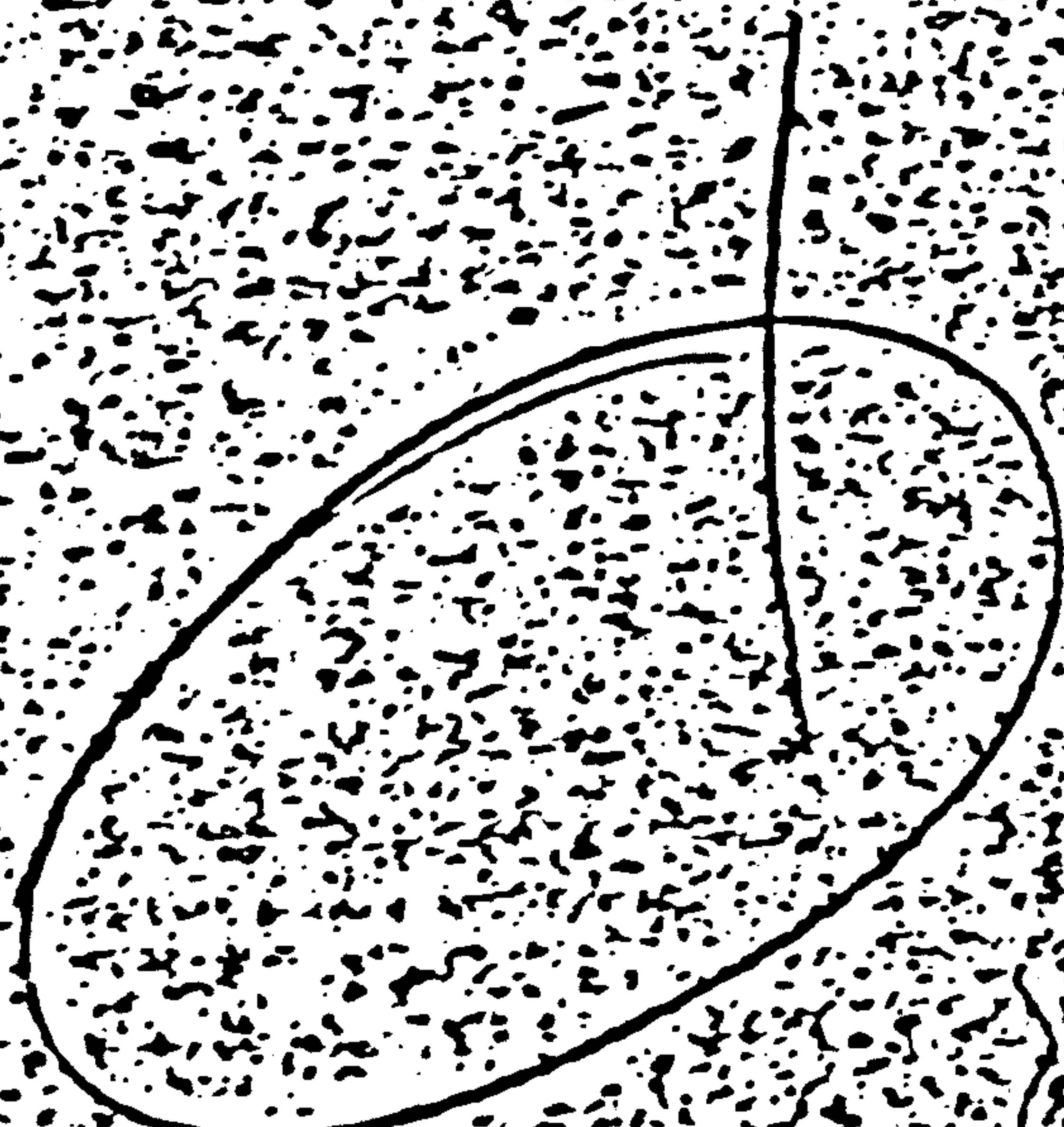

On the evening of June 2, 1964, ORVILLE O. NIX telephonically contacted SA GEMBERLING at his residence, stating that, upon examination of his camera after its return to him on that date, he had noted that the take-up spool was not returned with the camera and that numerous screws in the camera needed tightening.

Mr. NIX was advised that efforts will be made to locate the spool, and that in the event it was not located a new one would be obtained for him.

Shortly thereafter, Mr. NIX again telephonically contacted SA GEMBERLING at his residence and stated that, upon further examination of his camera, he had found that the footage indicator was loose and had fallen into the mechanism of the camera, and that he was somewhat concerned about the condition of his camera and as to whether it would function properly on his forthcoming vacation.

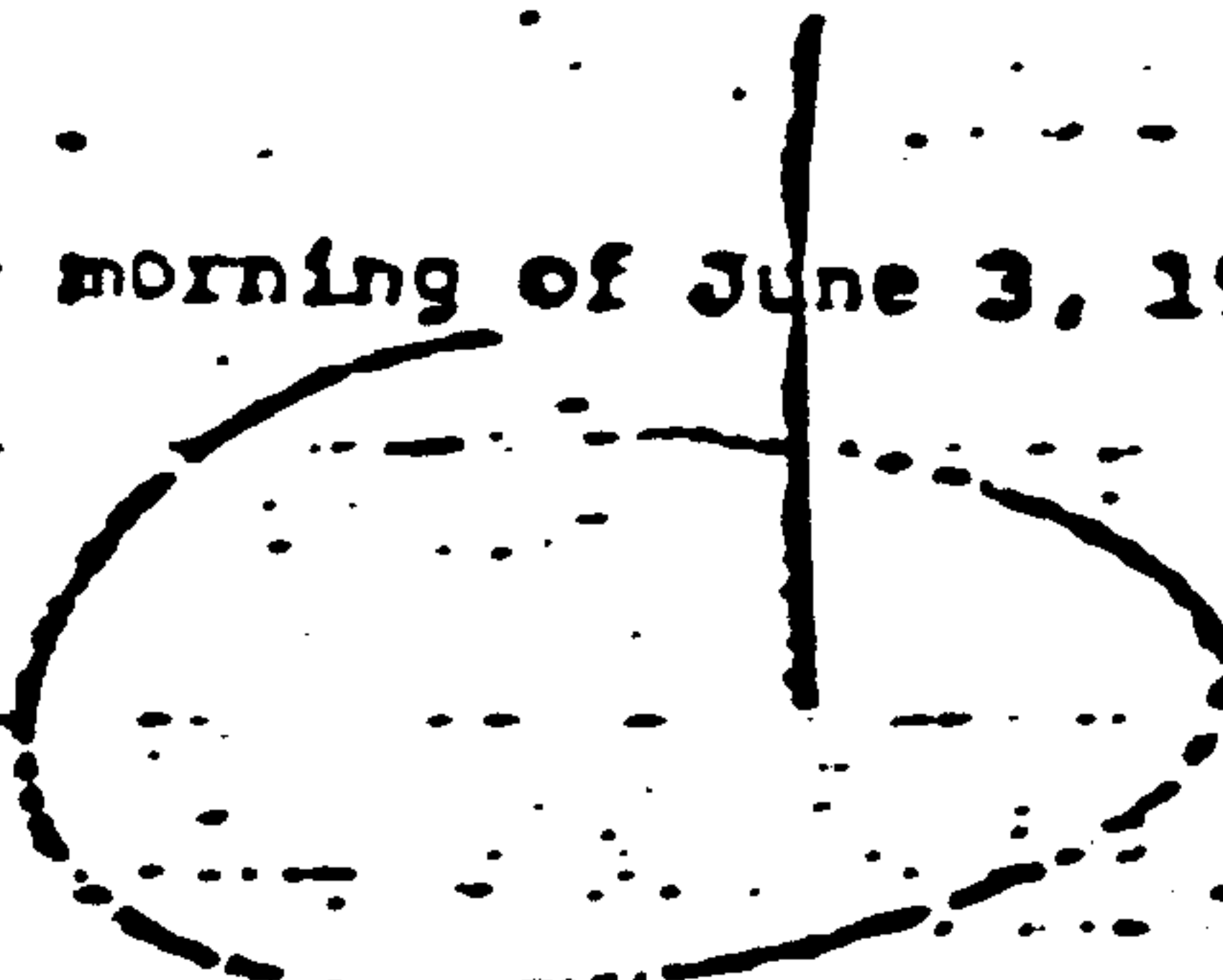
Mr. NIX was requested to recontact SA GEMBERLING on June 3, 1964, at which time arrangements would be made to appropriately get his camera in first-class working order.

On the morning of June 3, 1964, telephonic contact was had with SA L. L. SHANEYFELT at the FBI Laboratory, at which time Mr. SHANEYFELT was apprised of the calls from Mr. NIX. Mr. SHANEYFELT instructed that Mr. NIX be advised that he should take his camera to a repair shop, have it put in first-class working condition, and a new take-up spool provided and that the bill should be sent to the Dallas Office of the FBI.

At 9:50 AM, 5/29/64, Mrs. FRANCES HAYS, 913 Forest Ridge Drive, Garland, Texas, telephone Broadway 6-0140, telephoned and advised that she had been interviewed on two occasions concerning her knowledge of the facts surrounding the assassination of President KENNEDY.

Mrs. HAYS said that a photograph had recently been given to her by WYMAN PARR, Owner, Glendale Camera Store, 4448 South Marsalis Street, Dallas, Texas, and that someone had given this photograph to him. Mrs. HAYS stated she did not know who had taken the photograph and the photograph in her possession was a copy which was taken near the place where the President was assassinated, showing the old Courthouse and a close-up of the limousine in which the President was riding. She said that in this photograph is an individual who bears a resemblance to JACK RUBY, and she remarked that possibly the FBI already knew where JACK RUBY was at the time of the assassination. She said the photograph is in black and white, and she has no additional information concerning the person who might have snapped the picture.

Mrs. HAYS was requested to mail the photograph to the Dallas FBI Office, "ATTN: SA ROBERT P. GEMBERLING," inasmuch as she stated she was going on vacation for the next two weeks.

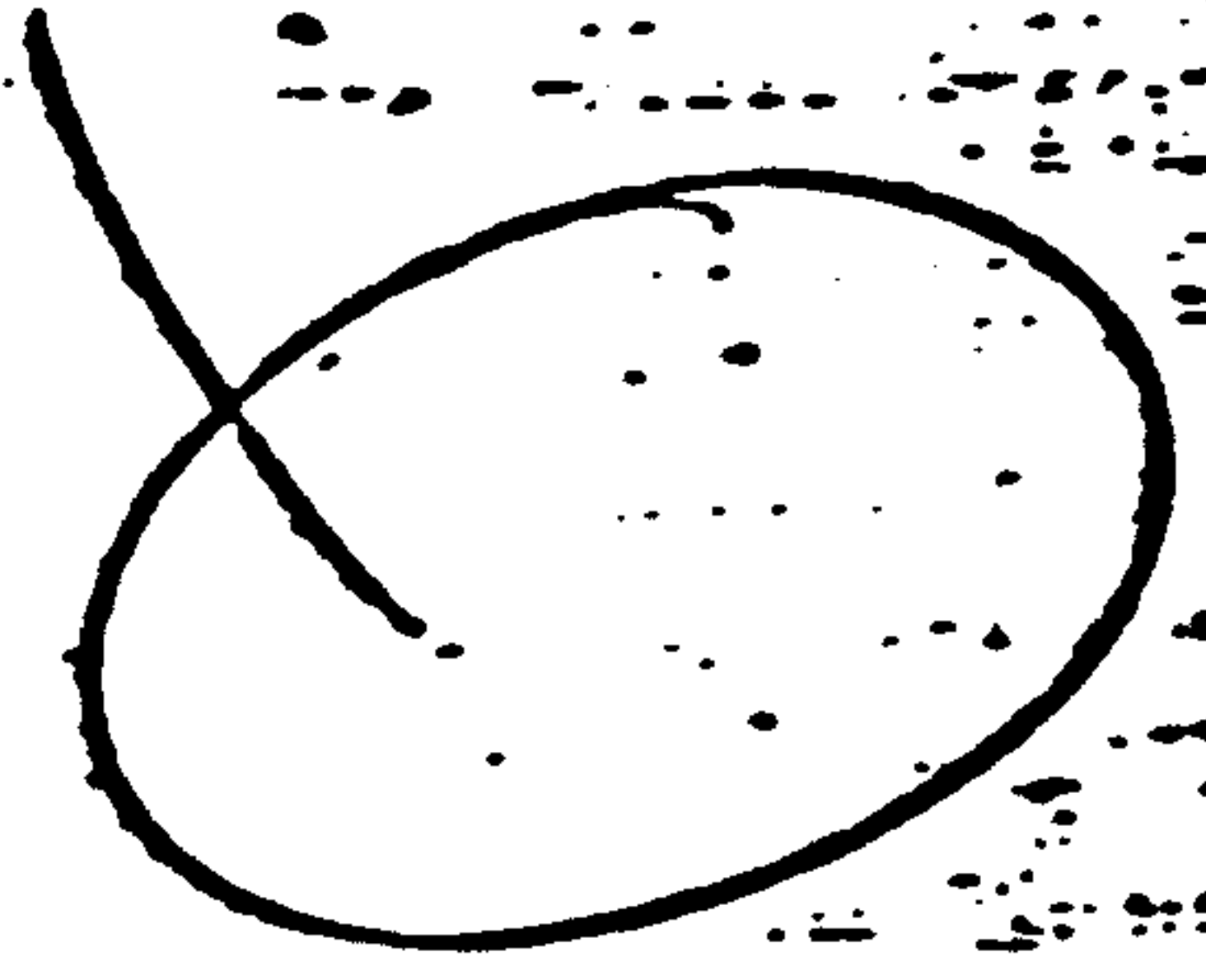

At 9:55 AM, this date, Inspector LEO J. GAUTHIER telephonically advised that in connection with re-enactment of the assassination, it will be necessary that we obtain the elevation of the site where ABRAHAM ZAPBUDER stood when taking the movies of the assassination. Mr. GAUTHIER requested Mr. WEST, the surveyor conducting the previous work, be contacted to obtain this information and that the same be furnished to him telephonically today.

Inspector GAUTHIER also advised that he had received the plats made by Mr. WEST, along with his request that he be afforded prints of the plats, as he had not had sufficient time to reproduce them.

The Commission has been contacted regarding this request and they instructed that Mr. WEST should be informed that prints were not available at the present time; however, they will be made and furnished to him at a later date.

Inspector GAUTHIER also advised that with respect to the request for scheduled drawings of the first and third floors of the police building, it is his understanding that these drawings may not be available. He stated that if this is a fact, the Bureau should be advised today so that a crew could be sent to Dallas to obtain the desired drawings over Saturday and Sunday of this week.
