At 2:45 p.m. Mrs. MARGUERITE OSWALD, 3704 Crestline Road, mother of SUBJECT telephonically gave writer the following information:

Mrs. OSWALD stated she has just purchased the current edition of Life Magazine and there is an article in this issue in regards to one TOMMY THOMPSON, former resident of Fort Worth, who has been promoted to an Assistant Editor of this magazine. Mrs. OSWALD said that on the day of the assassination of President JOHN F. KENNEDY, at Dallas, TOMMY THOMPSON interviewed her plus her daughter-in-law MARINA OSWALD at the residence of Mrs. PAINE, in Irving, Texas. Mrs. OSWALD stated at this time Mr. THOMPSON was only a simple reporter and since the assassination of the President he has been given this big promotion.

Mrs. OSWALD then related that this is not the first time she has heard of others involved in reference to the assassination of getting promotions in their work or occupation. She said that while her son, LEE HARVEY OSWALD, was in Russia she hired an attorney in Vernon, Texas by the name of JOHN STOREY, to send in affidavits to the State Department and American Embassy in Moscow, Russia. She said that JOHN STOREY sent in the final affidavit that brought her son, LEE HARVEY OSWALD, back to this country. Since the assassination Mrs. OSWALD stated that JOHN STOREY and his son, ROBERT STOREY of Dallas, have since been given big political jobs. Also Mrs. OSWALD advised that before her son's return from RUSSIA she was in contact with now the head of the CIA, SAM RABORN, FRED KORTH, former Secretary of the Navy, TODDIE LEE WYNNE, millionaire living in Dallas, ALLEN GRAND, former resident of Fort Worth living in Washington, D. C. with a big political job, and MIKE HOWARD, Secret Service Agent in Fort Worth-Dallas area now living in Washington, D. C.

Mrs. OSWALD stated that all of these men that she has mentioned all belong to a "power structure" and "political structure" which was a conspiracy in the assassination of President JOHN F. KENNEDY. Mrs. OSWALD said that "when I say anything, it's all been proven" and "all of these men have been involved with me directly."
