On 9/5/61 the following inquiries were made at Fort Worth, Texas, by SA JOHN W. FAIN:

JERALD M. PLUMMER, 1612 Hurley Street, advised that Mrs. MARGUERITE OSWALD, subject's mother, resided at 1612 Hurley. Street, Fort Worth, for several weeks following her return to Fort Worth from Boyd, Terris, beginning about April 1, 1961. She was employed for a short period for the Ables' Cleaners, but is understood to have left Fort Worth three or four months ago for employment of ranch somewhere in the vicinity of Munday or Benjamin, 2, exact address unknown to Mr. PLUMMER.

LOUISE ABLES, Ables' Cleaners, 1621 - 8th Avenue, stated that Mrs. NEWALD worked as an alterations employee for approximately one or one and a half weeks during about April 1961, but she resigned three or four months ago and went to a ranch located somewhere in northwest Texas in the Wichita Falls, Texas, area, where she had prospects for keeping house for some unknown couple on a ranch.

Mrs. DOROTHY REEDER (protect identity), Assistant Superintendent of Mails, U. S. Post Office, Fort Worth, advised that on 6/3/61 Mrs. MARGUERITE OSWALD, 1612 Hurley Street, Fort Worth, left a forwarding address of "General Delivery, Crowell, Texas."

On 9/18/61, R. L. OSWALD, 7313 Davenpart Fort Worth, where he continues to be employed as a sales coordinator, Marketing Department, Acme Brick Company, stated that he had just received a letter, dated 9/10/61, from his brother, the subject, wherein

subject mentioned that he was working in an electrical shop at Minsk, Russia. Subject mentioned that he owns a shot gun and occasionally goes hunting. According to R. L. OSWALD, subject has been married to a Russian girl, an orphan, by the name of MARINA, age about 18 or 19. Subject has written R. L. that MARINA was a nurse. According to R. L. OSWALD, MARINA seems to be very intelligent and from her photograph appears to be nice looking. This girl, prior to her marriage resided with her uncle and aunt. R. L. OSWALD stated MARINA desires to come to the United States with subject. R. L. OSWALD stated subject's letter was not too optimistic for his chances of getting to come back to the United States at an early date and subject indicated his belief that the Russians were "holding up" his return to the United States. R. L. OSWALD stated that subject has been severely critical of the Russians in his letter and he was surprised that the Russians would allow him to make criticisms.

R. L. OSWALD stated that his mother is residing at Crowell, Texas, but that he has no information as to the name of the people with whom she is residing and that on her letter of 7/19/61 she merely placed a return sidress of "Crowell, Texas."

The subject in the captioned case is OSWALD's wife, married to him in the Soviet Union, and, along with their infant daughter, brought by him to the United States upon his/ return to this country.

A file has been opened in the Dallas Field Division on subject under the SOBIR program. The files of INS, Dallas, have been checked. These revealed no information not already, known and reported in referenced report on subject's husband .

The case on LEE HARVEY OSWALD is in pending status and he is to be reinterviewed. It is not believed any active investigation gation of his wife or interview of her under the SOBIR program is logical or advisable at this time. It is felt her activities can be sufficiently followed at this time in connection with the case on her husband. It is noted there are no subversive references-on any member of the husband's family, and, under present circumstances she will be closely and intimately associated with them. According to INS records she is proficient presently only in the Russian language.

In view of the foregoing, the case on subject will be maintained in a pending inactive status in the Dallas Field Division for a period of six months, UACB. At the expiration of that time, it will be reopened and considered for further, arranted or advisable action.

ASSASSINATION OF THE PRESIDENT

Inspector Burl Peterson of the Secret Service called. He handles the press for Jim Rowley. Peterson told me that pressure was building up from the news media regarding possible interviews of Mrs. Marina Oswald. He stated thus far they have resisted all attempts to interview her and they planned to continue this policy.

Peterson wanted to know what I thought about his telling the New York Times that Mrs. Oswald is being protected by the Secret Service for obvious reasons, that her time was taken up fully and that she will not be made available to the press for interview.

I told Peterson that regardless of what he said to the New York Times he would undoubtedly get a bad press, however, that his position was undoubtedly sound and that it would seem rather foolish for the FBI or Secret Service to pre-empt the President or the Presidential Commission by shooting off our mouths at this stage of the game. Peterson agreed and stated they would hold the line. He indicated that the FBI would not be mentioned in any contacts with the press unless he cleared with us first.

UNITED STATES GOVERNMENT ${\it 1}emorandum$ Mr. Belmont DATE: December 11, 1963 TO C. A. Evans? FROM ASSASSINATION OF PRESIDENT KENNE SUBJECT: Deputy Attorney General Katzenbach telephoned. He advised that he had been contacted by representatives of the American Bar Association with whom he deals regularly in connection with the qualifications of persons being considered for the Federal bench. He was told that the American Bar Association had received several contributions for the benefit of Mrs. Oswald and her children. The total amount involved is between \$1,000 and \$2,000. Katzenbach has been asked by the Bar Association officials as to his recommendation for handling these contributions. One of the questions raised is whether Mrs. Oswald had been completely cooperative with the Government. Katzenbach asked if we could give him any guidance in this regard. Katzenbach was informed that the facts as we developed them were set forth in our report and this report would have to speak for itself. Katzenbach said that there were some difficulties here in that it was necessary to go through an intermediary as Mrs. Oswald didn't speak English and he didn't know whether she had an attorney. 
On December 12, 1963, SA COOPER telephonically contacted a woman at 18601 Concord, Detroit, who said she was BEENICE FETERS and that she had sent several such letters to various neighborhoods in the Detroit area. She was asked how the donor could be certain that any money sent to her would be forwarded to Mrs. OSWALD, and she said that she was maintaining a list of all donors and the list would be later published in "The Detroit News," a Detroit daily newspaper. She said that was the reason for the request to sign for any donations sent. She further said she was going to mail the money to "Mrs. PAINE in Texas," the woman with whom Mrs. OSWALD had made her home.

Rosen LEE HARVEY OSWALD INTERNAL SECURITY - R - CUBA Inspector Tom Kelly, Secret Service, telephonically advised that Secret Service was seriously considering removing the detail that they had assigned in Dallas looking after the safety of Marina Oswald. Kelly stated before doing so, he desired to discuss this matter with the Bureau as to whether it would affect the Bureau's work in any manner. Inspector Kelly was advised that the matter of looking after Mrs. Oswal by the Secret Service was one that was strictly up to the Secret Service; that any matters being handled by the Bureau would proceed regardless of whether Secret Service had been assigned to Mrs. Oswald or not. Inspector Kelly mentioned the possibility that if the detail is removed there might be considerably more difficulty in handling the interview that the Bureau was conducting with Mrs. Oswald. Inspector Kelly was told that while his comments were undoubtedly accurate, the Bureau was not in a position to request Secret Service to either continue or to discontinue their physical custody of Mrs. Oswald. Inspector Kelly indicated that he would probably take this matter up with the Department of Justice and in all probability with Deputy Attorney General Katzenbach.
