The above-captioned person telephoned me from Waldorf, Maryland, and said he has been in Dallas looking into the Oswald case and has talked to Marina Oswald. He told me that as a result of talking to Marina Oswald he had some information which the FBI might not possess and he wanted to pass it on to us. I told him we would be glad to receive this information. An appointment was set up for him to come in to my office at 11 a.m. tomorrow, Saturday, May 9, 1964.

As you know, [Redacted] is an author of many books. He was born in Russia and has been in this country for many years. He is a professional anticommunist, specializing in writing. We have not had any close relations with Levine; on the other hand, there has been no real problem.

Regardless to say, I will be extremely circumspect and merely receive whatever he has to offer us without comment.

It is noted that they were drafted in quasi legal terms, which caused them to be ungrammatical and difficult to comprehend.

Howard & Bell shall receive one fourth (25%) of all profits derived.





1. James H. Martin does hereby transfer, assign and convey to Textitalia Films, Inc., et al, the exclusive right to exploit the Marina H. Oswald Story throughout the world through the Media of Motion Pictures and Television.

2. James H. Martin warrants that he is empowered by the terms of his contract with Marina H. Oswald to convey the rights herein conveyed and make the agreements herein contained.

3. James H. Martin, manager, agrees to make available Marina H. Oswald to Textitalia Films, Inc. for the purpose of obtaining all pertinent story research, and warrants that this information and personal endorsement by Marina H. Oswald shall become the exclusive property of Textitalia Films, Inc., et al.

4. It is agreed and understood that Textitalia Films will require and will receive the services of Marina H. Oswald to appear, as herself, in certain segments of the films to be produced as a result of this contract, and that her remuneration for such services shall not exceed \$7,500.00 per appearance plus ~~expenses~~ reasonable expenses incurred by her in regard to such appearance. *43 4/27*

5. It is agreed and understood that Textitalia will require and shall receive the services of Marina H. Oswald to appear in person in connection with the programs to be produced and that her remuneration for such personal public appearances shall not exceed \$1,500.00 per appearance plus reasonable expenses incurred by her in regard to such appearances.

6. James Martin agrees and warrants that the information obtained in regard to the book now being written about Marina H. Oswald will be available and hereby gives permission to Textitalia Films for the use thereof for the purposes of this contract without further payment.

Should I be required to make any payment for such interest, you will pay your percentage share of such, unless you do not want your percentage.


Incidental to the arrest of Deaton, a small black bag was taken which contained, among other business papers, the following items:

A copy of a contract dated February 11, 1964, transferring exclusive right to exploit the Marina N. Oswald story throughout the world, through the media of motion picture and television, from James H. Martin, Manager for Marina N. Oswald to Toxitalia Films, Incorporated, signed by Charles R. Lasater, President, C. W. Deaton, Howdy Howard and George S. Bell, Jr. This contract stipulates a consideration of \$75,000 for this transfer but provides for a more detailed contract within 20 working days. Attached to the aforementioned contract of agreement is a Photostat dated December 6, 1963, addressed to Mr. James H. Martin, Dallas, Texas, signed by Mrs. Marina N. Oswald, giving Martin Mrs. Oswald's authorization to handle her personal and business affairs.

A letter of agreement dated February 12, 1964, signed Charles R. Lasater, C. W. Deaton, George S. Bell, Jr. and Howdy Howard. This letter concerns an agreement between the above-mentioned individuals to attempt to obtain the world-wide rights to movies and television and other public use of the "Marina Oswald Story." The letter was typed on the stationery of Howard and Bell, Realtors, 205 Stemmons Tower, East Dallas, Texas.

A copy of a letter of agreement, undated, signed by Charles R. Lasater, C. W. Deaton, Howdy Howard and George S. Bell, Jr. on February 12, 1964. The letter is an agreement between the above-mentioned parties to assign and convey for a consideration of \$1500, five per cent of the proceeds which may be derived from the Marina Oswald motion picture and television exploitation, to Jack D. Funderburgh.

Deaton has described himself as a financier.

SUMMARY OF THREAT

On August 6, 1964, a letter addressed to the Special Agent in Charge was received in this office from [redacted] "Miami News." The letter enclosed **b7D** an account of a threat to send a bomb in the mail to the "Miami News" by an unknown individual who hinted that President JOHNSON will die at the end of this year. Unknown Subject called the "Miami News" at 11:10 a.m., August 5, 1964, and spoke to [redacted] who works **b7D** the "Miami News" and the "Miami Herald" "have taken up niggers and Cubans... do not print stories about white men in the paper anymore." He said he was going to write a letter "right now. I'll send a bomb and fix it where it will explode when they open it...we got one Communist killed last year and we expect another will die at the end of this year. That's Mr. JOHNSON."

[redacted] had the call transferred to [redacted] who works [redacted] of the **b7D** "News," and an unsuccessful attempt was made by the telephone company to trace the call. According to [redacted] **b7D** report, the caller was incensed over the "Miami News" front-page story of the finding of the bodies of the civil rights workers in Mississippi. He said they were Communists who got just what they deserved. He said he hated "Negroes, Jews, and Catholics." He said that President KENNEDY was a "Communist Catholic," and that he was happy when President KENNEDY was killed. He said he had sent a gift to Mrs. OSWALD after her husband assassinated President KENNEDY, but she returned the gift to him.

[REDACTED] was of the opinion that the caller b7D sounded rational but fanatical, and he used very vulgar language.

IDENTIFYING DATA

[REDACTED] stated that caller said he was b7D a Mississippian who was now living in Miami. According to him, he had a deep Southern accent. He said that he had sent a gift, possibly a check, to Mrs. LEE HARVEY OSWALD after her husband assassinated President KENNEDY, and he seemed puzzled that she returned it to him. According to [REDACTED] the caller said he had sent many letters to b7D the editor of the "Miami News," but they had not been published.

[REDACTED] asked for his name and phone number, b7D and the caller refused but said, "They got my name lots of times." He asked [REDACTED] if JACK ROBERTS, a reporter b7D for the "News," was still working there, and [REDACTED] said, "Yes," which would indicate that caller had contacted ROBERTS in the past.

AGENCY ADVISED

On August 6, 1964, Mr. ROBERT JAMISON, United States Secret Service, Miami, was advised of the facts above, and said his office would undertake an immediate investigation to identify Unknown Subject.

Subsequently, Mr. ERNEST ARACON, Secret Service, was furnished Xerox copies of the reports of the "Miami News" employees.

On August 6, 1964, Postal Inspector WILLIAM NESTOR was above of the above, and said he would undertake immediate investigation regarding the bomb threat aspect.

Editorials

President and the People

A GREAT DEAL has been said and written about the danger involved in the President's tendency to go into crowds and shake hands. Senate Majority Leader Mike Mansfield is the latest to be concerned over Mr. Johnson's excessive mingling in crowds during his New England swing last week. But we wonder—where is danger greatest?

The Warren Commission's findings weigh heavily on all of us, particularly on those whose job it is to protect the President. We can also understand Sen. Mansfield's admonition of both President Johnson and presidential candidate Barry Goldwater to "avoid exposing themselves unnecessarily" to the danger inherent in "imprudent mingling with campaign crowds" and to comply with security safeguards recommended by the Secret Service and their official protectors.

Four presidents have been assassinated, at least three others have had attempts made on their lives. Only one such act took place in a crowd. Louis Dolgosz approached President William McKinley as if to shake hands and shot him with a hidden pistol. President McKinley was attending an exposition, therefore we presume it was in some type of crowd.

But Abraham Lincoln, James Garfield and John F. Kennedy were assassinated under conditions which, while public, were not "in the crowd."

Of the assassination attempts—to Teddy Roosevelt, Franklin D. Roosevelt, Harry Truman—only the attempt on FDR took place under similar conditions to the Kennedy assassination.

In every instance the president has been acting wholly within the advice and in compliance with the security rules ordered by whatever constituted his bodyguard.

So just how much danger is added to any public appearance by the president's shaking hands or gathering people around him? The danger operates whenever he appears in public and short of a bullet proof glass-cased exhibit system, there seems no solution to presidential assassination except through some form of national instruction that makes it unthinkable. The British prime minister, for example, customarily goes alone or with only a pair or so of protectors.

While following some of the recommendations of those concerned for his safety, the President might cut down the chances of an assassination, but as long as the President gets in some close proximity of the people he will be in some danger. The attempts on the various presidents have been more on the office than the individual. The only way to protect the individual completely would be to isolate him from the people, but in our country the office of the president must always have contact with the citizens.

J. Edgar Hoover's Testimony

J. Edgar Hoover's testimony before the Warren Commission investigating the assassination of President Kennedy now has been published.

Just as the Warren Commission did in its report, Mr. Hoover pin-points the devilish problem involved in trying to protect a president.

"President Johnson," he said, for instance, "is a very down-to-earth human being, and it makes the security problem all the more difficult, but you can't bar him from the people."

The FBI director spoke out strongly against "police-state" methods in shielding the president from possible crackpots.

"I am particularly concerned," he said, "that we don't become hysterical and go so far in restricting the citizens of our country from exercising their civil and constitutional rights."

He deplored an incident in Chicago when some "extremists" practically were put under house arrest while President Johnson was there.

"I don't think there is any place in this country for that kind of thing," Mr. Hoover said.

Coming from a man who has spent his life in police work, this is an especially

salutary attitude — as well as practical.

Mr. Hoover, however, did recommend some stringent restrictions on a president's travel: Careful advance preparation for a trip, maximum delay in announcing the route of travel, a car equipped with bullet-proof protection. "He must never ride in an open car," Mr. Hoover said.

But these are restrictions most presidents would shun.

The Secret Service, the FBI and the police combined cannot "case" every person who may be within striking distance of a president. As Mr. Hoover testified, they had cased Lee Oswald, but there was no indication of his homicidal intent.

The nub of Mr. Hoover's testimony, and the gist of the Warren Commission recommendations, is that protective measures for the president can be improved, but, as Mr. Hoover said: "We don't want a Gestapo. We have got to, I think, maintain a balance."

And presidents, as Mr. Kennedy believed, will continue to find it necessary to travel among the people, to see and be seen. The risk cannot be absolutely eliminated. But a president also has an obligation to the people to maintain his own safety — and Mr. Hoover's advice in this respect is highly pertinent.

Was Marina A Good Wife?

By JOHN TACKETT

Is the real Marina Oswald a victim of an unfortunate marriage to a Marxist misfit? Or is she a nagging, unhelpful woman who embarrassed her husband by complaining of his "inadequacy as a man?"

Before release of the Warren report, she was seen by most as an innocent victim of Harvey Oswald — a man who often abandoned her with their children, scolded her, and then left her branded with his hated name.

Now the image is foggy. The report quotes Mr. and Mrs. George DeMohrenschildts, close friends of the couple, as saying Marina was not the perfect wife.

The DeMohrenschildts told the Warren Commission that Marina called Oswald said he was inadequate as a man in front of Oswald."

"SHE WAS annoying him all the time — 'Why don't you make some more money?' or 'The guy was going out of his mind?' Mr. DeMohrenschildt said.

The report also says Marina had another friend that she had a very seldom sexual relations.

But Mrs. Ruth Paine, the cleaning housewife who took care of Marina and her two children, took issue with the statements of the DeMohrenschildts. She told The Press that during the couple's last two years together, Marina worked to mend the marriage. She never said anything intended to hurt him," Mrs. Paine said.

When we had one short

talk about her going to the planned parenthood clinic in Dallas — to make an appointment to go there six weeks after the baby's birth — she said they'd had difficulty.

"I TOLD her I might get the services of a marriage counselor. She said Lee might want to go also.

"So the only time we talked about their personal relationship, it was clear to me that she wanted to improve it.

"This gives our talk a very different character from what Mrs. DeMohrenschildts reported. And Marina's talk with me was a lot closer to the time of the assassination than this instance reported."

Mrs. Paine said Marina wanted to limit the size of the family. It was during their talks about this, Mrs. Paine said, that the two "talked about adjustments in their intimate relations."

AT THE time of Marina's stay in Mrs. Paine's home, Mrs. Paine was separated from her husband, Michael. But the two now are back together.

Marina herself now is in a conference at an unknown location with Priscilla Johnson, who is helping the Russian girl write a book about her life with Lee Harvey Oswald.

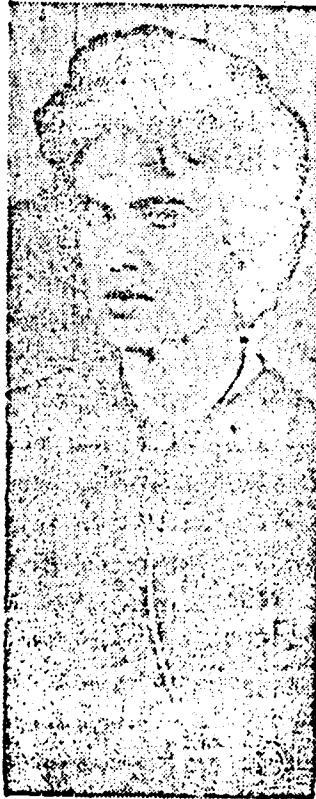
Miss Johnson once interviewed Oswald in Russia.

Marina's neighbor in Richardson, Tex., said Marina called recently long distance to make a routine check with her. But Marina did not say where she was.

A friend in Fort Worth said Marina wrote about two weeks before issuance of the report to

say she was going into seclusion to write her book.

The book will be the first real look by the public into the mind and personality of Marina Nikolaevna Pruskova Oswald.

Oswald's Widow to Study English

ANN ARBOR, Mich., Dec. 23 (UPI)—Mrs. Marina Oswald, the widow of President Kennedy's assassin, will enroll at the University of Michigan next month to take an intensive course in English, it was announced today.

The university said Mrs. Oswald, a native of the Soviet Union, would be one of about 100 students starting special courses at the English Language Institute. She will begin an eight-week course Jan. 7. The institute specializes in teaching English to foreign students.

Mrs. Oswald's stay will be sponsored by the First Presbyterian Church, which will make all the necessary living arrangements. The Rev. Ernest T. Campbell, pastor of the church, said:

"We'd like awfully much for Mrs. Oswald to come here just as a student without undue fanfare." But he conceded that this seemed unlikely.

A committee of church members invited Mrs. Oswald to come to Ann Arbor for the university's English course last December. The university said she had expressed interest because of her limited knowledge of English, but that she had been unable to come at an earlier date.

Mrs. Oswald, who came to the United States in 1962, has had no formal instruction in English. She was graduated from a technical course in pharmacy in Leningrad before her marriage. She will

spend five hours a day in at least two classes and practice sessions.

The institute's director, John C. Catford, said of the instruction:

"At least 60 per cent of our students come here because they want to acquire proficiency in English before enrolling in an American college or university for a long period of study."

The university said Mrs. Oswald had indicated a desire to continue her education.

An investigative file was opened on subject at Dallas on July 19, 1962, and investigation was subsequently conducted at Dallas and Fort Worth, Texas, and New Orleans, Louisiana, and was reported by interoffice letters and letters to Bureau. Following the assassination of President JOHN FITZGERALD KENNEDY on 11/22/63, for which crime subject's husband, LEE HARVEY OSWALD, was arrested on 11/22/63, at Dallas, subsequent investigation pertaining to OSWALD and subject was reported in Dallas files entitled, "ASSASSINATION OF PRESIDENT JOHN FITZGERALD KENNEDY, 11/22/63, Dallas, Texas, ASSAULTING FEDERAL OFFICER," Dallas file 89-43, Bureau file 62-109060, and "LEE HARVEY OSWALD, aka., IS - R - CUBA," Dallas file 100-10461, Bureau file 105-82555. No previous report has been written concerning MARINA OSWALD.

The Bureau's attention is directed to two reports which directly concern the activities and contacts of MARINA OSWALD at Dallas from the period February 24, 1964, through March 12, 1964, in the matter entitled, "LEE HARVEY OSWALD, aka., IS - RUSSIA - CUBA" reports being dated March 21, 1964, and March 23, 1964, prepared by SA MILTON L. NEWSOM. Information contained in these reports is not herein included.

MARINA OSWALD has been interviewed on numerous occasions since the assassination, and these interviews formed the basis for this report. Information set out in this report was furnished by MARINA OSWALD in these interviews if not otherwise noted. The majority of these interviews have been in the Russian language. There have been a number, however, conducted in the English language. MARINA OSWALD expressed a dislike for the FBI in the initial interviews following the assassination, and she has stated that it was because of this that she withheld certain information in these interviews. Specifically, she denied she knew of a trip of OSWALD to Mexico City in September - October, 1963, when, in fact, she did know of this trip. She later corrected herself in testimony before the Warren
