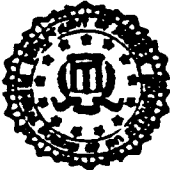

Sacred Heart Catholic Church, 215 North 16th Street,  
Edinburg, Texas, advised that Father RICHARD LAWRENCE  
PHILION who formerly resided at that address is now assigned  
to the Santa Maria Magdalena Church in Tequixistlan, Oaxaca,  
Mexico, whose mailing address is Apartado Postal, #93, Salina  
Cruz, Oaxaca, Mexico.

Father MORENO advised that Father PHILION obtained  
a Mexican Tourist Permit on about September 17, 1963, with  
which to enter Mexico. He stated he did not know what mode  
of travel Father PHILION was using, but believes it was  
possibly in an automobile.

On Page 6 of referenced communication the name of GUILLERMO HEVIA VILLAR, 217 W. Johnson Street, San Antonio, Texas, is listed as a person who entered Mexico at Nuevo Laredo, Tamps., Mexico, on 9/26/63.

A check of 217 W. Johnson Street, reflects that this house has been occupied by Mr. and Mrs. TONY MARTINO and their son TONY MARTINO, JR. for approximately 24 years. Interviews reflect that TONY MARTINO, JR. sold GUILLERMO HEVIA VILLAR a 1959 Chevrolet Impala, two door hardtop sedan, red and white in color sometime during the latter part of September, 1963. The sale was for cash. The car was registered to HEVIA VILLAR with the Texas Department of Motor Vehicles, giving the address of 217 W. Johnson Street, San Antonio in order to expedite the handling of the transfer of title. After the sale, which was for cash, GUILLERMO HEVIA VILLAR advised MARTINO, JR. that he was going to Mexico City to visit friends and asked that when the new title on the car was received from the Texas Department of Public Safety, that

It is to be noted that the first list is composed of the individuals registered as having entered Mexico at Nuevo Laredo, Tamaulipas, the same date OSWALD entered, 9/26/63. The second list is composed of individuals who departed Mexico at the same port on 10/3/63, which is the day OSWALD left Mexico at this port.

During the course of the interview, each office should bear in mind that if the person being interviewed has any information regarding subject or a person fitting his description, every effort should be made to elicit information as to the means of transportation used by OSWALD when they knew or saw him, or any of his activities.

If, during the course of the investigation, information is developed reflecting that the person who entered Mexico on 9/26/63 is still in Mexico, every effort should be made to ascertain this person's exact whereabouts in Mexico and an appropriate lead should be expeditiously sent to the Bureau for forwarding to Legat, Mexico, to have this person immediately interviewed.

Attached is a copy of a bus passenger list for a bus company called Transportes Frontera covering a trip made by bus No. 340 of this company from Mexico City to Laredo, Texas, on 10/2-3/63.

It is noted that the name "OSWALD" is listed in the space for seat No. 4 with a destination of "Lared." As was pointed out in mylet of reference, extensive investigation at the offices of the bus company in Monterrey failed to disclose a ticket which could have been used for OSWALD on this trip. Interviews of the two drivers of the bus on this particular trip have also been negative.

Because of the failure to discover a ticket for OSWALD and the fact that there possibly could be some variation in the writing of this name as compared with the writing of other names, it is requested that the following handwriting examination be made:

1. It is requested that the handwriting of the name "OSWALD" and "Lared" be compared with the known handwriting of the subject to determine whether the name was written by him.

2. That the handwriting also be compared with the handwriting of the other names appearing on the list in an effort to determine whether the name "OSWALD" was written by the same person entering some or all of the other names appearing on the list.

It is requested that the fingerprint card be searched through the files of the Bureau's Identification Division and this office furnished with four copies of any identification record which may be found for him.
