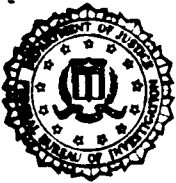

LEE HARVEY OSWALD

On December 6, 1963, TED C. BLAND, residence address 514 McKenzie Street, Hillsboro, Texas, advised that he left Hillsboro, Texas, on Wednesday, exact date believed by him to be September 25, 1963, in his 1956 yellow and black Cadillac sedan and drove to Laredo, Texas. He advised that on the following day, September 26, 1963, he attempted to cross the border into Mexico but had a .22 rifle in his car at the time and as a result of this he spent from approximately 11:00 a.m. until about 1:00 p.m. on that date, September 26, 1963, in completing his arrangements to cross into Mexico. He explained by stating that he was sent from Mexican Customs to a representative of the Mexican Army in Nuevo Laredo who sent him back across the river to Laredo, Texas, where he contacted the Mexican Consul. He advised that he recontacted American Customs at Laredo, Texas, and finally contacted a gun dealer at Laredo, Texas, whom he paid \$2 to ship the rifle back to him at Hillsboro, Texas. He advised that he finally crossed into Mexico about 1:00 p.m. and then drove straight to Monterrey, Mexico. He advised that he remembered being passed on the road by a young man driving a late model red Chevrolet automobile. He advised that he had no further description of this man or the car, however. He stated during the time he was crossing the border and making arrangements to cross, he did not remember having seen any individual who resembled OSWALD's photograph. He stated that in fact he did not recall many people being engaged in crossing into Mexico on that date and had no clear recollection of any individual so involved.

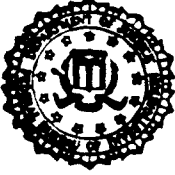

LEE HARVEY OSWALD

R. P. "BOB" SANCHEZ, Attorney at Law, 273 South  
17th Street, McAllen, Texas, furnished the following information:

"The recent tragedy which met our President and consequently the whole free world has, I am sure, been the topic of conversation among people of all social, economic and intellectual levels. Curiosity seekers have probably had a field day speculating beyond the published news on how the assassination occurred and how the accused assassin, LEE HARVEY OSWALD, operated. Moreover, many have wondered if OSWALD had accomplices, feeling that while OSWALD apparently met an untimely retribution, those who might have worked with him are apparently still at large.

"A news release, whether accurate or not, reporting that the Federal Bureau of Investigation had announced that OSWALD was operating alone and that he did not have any accomplices, stirred me to contact the FBI to report a very interesting and I might say startling piece of information regarding the assassination.

"A small group of people in an American city of the U.S.-Mexico border have, through the years, originated a so-called 'Institute of Psychorientology.' They have through many painstaking hours developed 'psychic operators' who, through psychic conditioning have developed extra sensory perception or super normal perception whereby they are able to perceive and disseminate information other than through normal or objective senses and yet produce information that has objective reality. They like to call this process 'clairvoyance' although they are aware that such term had a different and much less serious connotation sometime ago.

"using the process I have described above

"perceive maladies, malfunctions or physical faults or injuries contained in the human body. They are now even able to exercise therapeutic functions or processes whereby their work can have a curative effect on the human body. A brother of mine became interested and acquainted with this group of people and when they found out to their dismay that what they were doing was contrary to established medical practice and further found out that the Medical Association was beginning to frown upon their practices, though they were not wide spread, they approached me, through my brother, for legal counseling or orientation.

"About their ability to 'read' the human body there is absolutely no question in my mind or in the mind of any body whom they have actually examined. They were able to tell me the injuries I sustained even when I was a child and all about my present physical condition. I learned some things that I was not entirely aware of myself.

"To add a somewhat more official or formal character to this whole thing I should state here that I personally discussed the work these people are doing with a graduate student in this whole field at Duke University, the foremost cultural center in our country today in this field, and he personally told me that there was absolutely no question in his mind but that these people did have the power to do what I have described. He said that only one other human being in the world was able to do what these people are doing. I believe he said this individual lived in North Carolina, but I am not sure. He did say one thing however; he said that the fellow in North Carolina, while able to perform in this manner, was not able to transfer his abilities or his power to someone else and that this group of people apparently is able to do so; therefore they are training others, among their group, to do exactly what they are able to do.

"Recently a Dr. BANERJEE from India, a luminary personality in this field, made a talk in San Antonio, Texas and after conferring with the group of people I represent was also convinced that this is the only group of people in the whole world that can do this. I believe he gave them a letter of commendation, and told them, by the way, that the Russians are far ahead of us in this field.

"To take this matter one step further, this group of people is now experimenting on their ability to exercise mental projection in the present and in the past. By such process they are able to recreate past notable events and perhaps even perceive into the future. This process is again carried out by having one of their operators get into a mental state of semi-conscious or semi-sleep whereby the operator, with eyes closed, is still in full control of his faculties and is able to talk and thereby answer the questions of another operator who seeks the information desired.

"It is through this process exactly that these psychic operators have, apparently, been able to turn up with some information leading strongly to the belief that OSWALD had accomplices in the assassination of President KENNEDY. One note of caution should be exercised here and that is, as they have definitely told me, that they are not yet able to tell whether or not their operator, while in the special state of mind or 'trance,' if we may call it that, is from time to time getting in and out of such special state of mind whereby at some times he or she is producing true or concrete information and at other times, while not in the special state of mind, is not producing accurate or true information. They tell me very clearly that they have apparently not reached the state of perfection in their mental process whereby they can produce correct information 100% of the time.

"At any rate I sat in on one of their two experiments on the President KENNEDY assassination and they produced the following information which, to be sure, is largely fragmentary but I am convinced that with further study and better preparation of the operator who is doing the questioning, more concrete and more exact information could be produced. The operator doing the questioning and developing the information that follows was not very well organized in point of developing the story from its proper beginning and in chronological sequence of events. If he had done so they now admit that they could have developed better and more concrete information. Consequently, as I made my notes I found it very difficult to organize a complete picture but I will try to rearrange my notes as I report them here.

"The best starting point, I believe, is back during the period when OSWALD was training. The operator in trance claims that OSWALD trained extensively in Latin America. That he trained to use a rifle and trained to do many other things. If I had been doing the questioning I would have wanted to distinguish between OSWALD's Marine Corps training and the training that the operator was speaking about, but it became pretty clear to me that what the operator was speaking about was not the Marine Corps training but special training with some sort of Communist oriented group in Latin America. As the operator put it, OSWALD became very proficient with a rifle and with other things.

"We will now discuss a meeting which the operator claims was held on the 19th; I presume it was November 19, in New York. The operator claims that OSWALD had to drive for about four hours to a point somewhere north of Dallas to a private landing strip where he was picked up by a private airplane and taken to a place near New York City or just New York, as they put it. On the matter of producing the identification number on the airplane the operator seemed to come out very clearly with it, UN674. The plane

"is said to have landed somewhere in New York away from the city at another landing strip where there was a little garage or some type of garage like building. A long black car took OSWALD to a hotel in the downtown section and the operator had very much difficulty in producing the license number of the car. About the only thing that the operator could do was produce the last two numbers which appeared to be 16. The operator said that four men held a meeting on the 19th in a hotel and the operator had very much difficulty in producing the name of the hotel. In an attempt to read the name from the sign sitting on top of the hotel, they turned up with something like the following 'Calverence Hotel'. Like I say, the operator did not appear to be very exact on this score.

"The leader of the group of four men is a tall man who wears glasses and who has some sort of accent and he has used the name, G. H. WALTER, GEO. WALKER and H. G. WALLER. The operator, after giving all three variations of the name, then kept using the name WALLER all along so I am inclined to think that the real name is WALLER. He is said to work in a government building around three miles or more away from the White House. It is a good size building with two sets of steps in front of it but the operator was not able to produce the name of the building or its address. There was also no success in producing the phone number of the building because the operator in trance was not properly questioned on how one could call into the building. The said operator was concentrating on telephones inside the building which apparently have extension numbers rather than the full telephone number. The operator did say that some extension number in the building and in the office where WALLER works, I believe, appears to have the designation, 52. The operator was much more exact and clear on the residence address of WALLER. It appears to be 236 Walnut. The operator also turned up with the information that WALLER is married, was asleep in a fancy



"bedroom at the moment of our experiment, and has a wife and two kids the oldest of whom is a boy and is between 8 and 12 years old. WALLER works for a high government official who is not aware that WALLER is a Communist agent. WALLER gets information from this government official but without the knowledge of the latter.

"The assassination plot was discussed at this meeting on the 19th in New York and OSWALD was said to volunteer for the actual carrying out of the killing. One of the men there went to San Antonio and made a treating call but the operator did not seem clear on why he made the threatening call in San Antonio. Another man stayed in New York overnight and it is believed that WALLER returned to Washington. OSWALD returned to Dallas and at the proper time took his position in the building from where he fired the fatal shots.

"The operator was made to look through the telescopic sight of the rifle OSWALD used and reported that OSWALD was first aiming at the forehead of the President and that he intended to kill him with one shot. As he fired and missed the head hitting the neck he became angry and then fired at Governor CONNALLY although he at first did not intend to even shoot at CONNALLY. Then the operator says that he fired a third shot at the right temple of the President and hit perfectly well. The operator then reports that OSWALD started to leave the room from where he fired and as he was leaving the room he was rubbing off some wax which he had put on his fingers. OSWALD at first had thought that he would leave through the back exit of the building but then changed his mind thinking that if he should be caught leaving through the back it would cause suspicion so he then decided to leave the building through the front, and did so. The operator reports that OSWALD had some pills with him, apparently some type of sedative pills; that he took one pill before the shooting and four or five after the shooting. The operator described

"some of the scenes and businesses that OSWALD was passing through or passing by as he walked away from the scene of the crime. One of those, I believe, was a pet shop. The operator described OSWALD taking a bus but did not say anything about a taxi. Then the operator traced him to a movie theater and when asked what kind of movie was playing the operator had much difficulty in determining because, as she put it, (the operator in trance was a female), OSWALD was not even looking at the movie. Then the operator did say that it was a movie where there was a lot of shooting going on. Oh yes, when OSWALD found out that the President had not died immediately but had lived half an hour or an hour he became angry. He wanted to hear the report that he had died instantly.

"The operator then reported that OSWALD was not directed from Russia and that 'NIKITA', as she put it, was not connected with the assassination at all and had no knowledge of it. She said that there are many or various groups operating and that many times they just act on their own. Oh yes, the leader of the group, WALLER, and I believe OSWALD too, are said to have been angry at the President because of some sort of congressional bill that the President was backing. There was no further probing into this aspect by the questioning operator.

"As to what WALLER can expect out of all this she reported that he would expect a promotion or even some money along with it but that as of that moment, November 27 in the evening, it was not yet determined whether WALLER would be rewarded because they would have to wait to see whether their plot was a complete success.

"About JACK RUBY, the operator produced the following. Sometime ago JACK RUBY had an anti-American feeling but later had a change of heart and became very much pro-American. OSWALD had some communication with RUBY and was trying to convert RUBY back to his anti-American feeling but without success. The operator further said

"that OSWALD threw little hints about an attack on the President but that RUBY did not take them seriously. The operator was then pretty positive about saying that RUBY was not in any way connected with the plot to kill the President and that after the President was killed he (RUBY) was full of hatred for OSWALD. Oh yes, the operator also appeared to say rather clearly that the owner or operator or manager of the building from where OSWALD fired was not in any way connected with the assassination plot and had no knowledge of it.

"The above and foregoing is about all that has been produced up to the present time. As I say, the operators have run only two experiments on the subject. I have advised them that I have contacted the FBI about this matter and that if there is any basis to what they have produced, the FBI might like to have them cooperate in producing more information.

"The chief operator of the group told me that in the future they might be able to advance this science far enough that they will be able to perceive into the future and determine where and when there is any plot developing to kill the President and thereby be able to upset it.

SANCHEZ stated he has been very active in politics on behalf of the Democratic Party and exhibited telegrams and certificates of appreciation from President KENNEDY and Vice President JOHNSON thanking him for his assistance in their campaigns. He also exhibited autographed photographs of President KENNEDY, Senator RALPH YARBROUGH, Congressman HENRY GONZALEZ, and others.

He described himself as a crusader for the cause of lifting the socio-economic status of Americans of Mexican origin, but one who would like to make his country a better and safer place for all Americans to live in.

I feel impelled to write this letter although it may prove to be of no importance.

Has it occurred to any one of the Investigating Officers, that the life of Lee Harvey Oswald parallels the story of the motion picture "The Manchurian Candidate" in many ways.

The facts that keep running through my mind as I hear and read more of the life story of Oswald are as follows:

First, the name. If I remember correctly the name of the leading character in the picture is Laurence Harvey.

The leading character in the movie was in the Army, in the Far East, was brain-washed, and made a tool of the Communists.

Oswald was in the Marines, served in Japan, and in some manner came to embrace Communism.

The leading character despised his Mother.

Oswald must have had some resentment against his own Mother, as I read that he hung up on her personal telephone call to him when he was in Russia.

The leading character had a step-father, Oswald had a step-father.

Oswald had a grievance against a Governor.

The leading character in the Movie had a hatred for a man who aspired to be Governor, and was ordered by the Communists to assassinate a Governor.

He went high up in a cubicle in the top of an auditorium and waited with a rifle to assassinate the aspiring Governor.

Oswald went up to the fifth floor of a building and built a cubicle around him with cases of books and waited with a rifle to assassinate the President and no doubt intended to do the same to the Governor.

The thought has occurred to me that he saw the moving picture and identified with the leading character, and from that seed came the plan to assassinate the President.

Or could his Communist associates have known his story, seen the similarity, and used him as a tool to accomplish the act?

He took refuge in a Moving Picture Theater after the shooting. It might be interesting to ascertain on what dates this picture was shown in Dallas, and at what theater, and compare the date on which he purchased the rifle, whether before or after the showing of the picture. Also how many of the Communist group to which he belonged saw the picture.

## Words Of J. Edgar Hoover

In 1919, Mr. J. Edgar Hoover, as a special assistant to the Attorney General of the U.S., prepared a legal brief on the newly formed Communist party. His report concluded:

"These doctrines (of the Communist Party USA) threaten the happiness of the community, the safety of every individual, and the continuance of every home and fireside. They would destroy the peace of the country and thrust it into a condition of anarchy and lawlessness and immorality that passes imagination."

Forty years later, on Page 95 of the Pocket Book edition of his work, "Masters of Deceit," he described the individual Communists who make up the Communist Party USA: "... the Communist is not an angel of mercy, ministering to the weak, oppressed, and wounded, but a menacing demon splattered with blood and wielding a hammer and sickle of iron."

Do we need any more proof than we have had recently of the accuracy of Mr. Hoover's analysis of the Communist criminal character?

I certainly do not, and am writing to Cong. Page Belcher today to work for legislation outlawing and destroying the Communist Party USA, for we need no more proof that we are at war with the Communists. Neither in America nor in the rest of the world is peaceful coexistence possible with Communism any more than with a nest of rattlesnakes.
