She advised that she has resided at that address since August, 1963. She said that she is not familiar with many of her neighbors but has spoken to the couple who occupied the rear apartment at 4905 Magazine Street on several occasions. She states she was unaware of their name at the time. She stated that this couple was occupying this apartment when she moved in during August, 1963. She said that the man and woman who occupied this apartment had a son two years old and that the woman was approximately eight months pregnant when this couple moved out of the apartment in late September, 1963. She said that the only thing she recalls about this couple is the fact that they talked in a foroign language, which she believes to be Russian. She said the only thing peculiar she noted about the man was that the frequently walked around in just his bathing suit. She said that she never observed this fellow exhibit any interest in guns or in associating with his neighbors. She said that he never spoke to his neighbors as far as she knew. She said she also recalled observing a station wagon, light colored, which she believes to be a Chevrolet. She said she saw this station wagon only once and that this was sometime during the end of September, 1963. She stated that she never saw OSWALD drive a car so did not believe it was his.

She could offer no further information regarding these people. She advised sho was unaware of this couple's name until she saw the man's picture in the paper on November 22, 1963. She stated this man was identified as being a suspect in the assassination of President KENNEDY and that this man, LEE HARVEY OSWALD, was identical to the man whom she knew as the occupant of the rear apartment at 4905 Magazine Street.

She stated that she did not know LEE HARVEY OSWALD while he lived at 4905 Magazine Street, but recognized his is picture in the paper on November 22, 1963, as a suspect in it the assassination of President KENNEDY and as being identical to the man who occupied the rear apartment at 4905 Magazine Street during the summer of 1963. She said that she never saw much of OSWALD and when she did, he was by himself. She said that OSWALD kept to himself and did not speak to anyone. She said that she recalled seeing OSWALD smile only once and this was when he was visited by an individual whom she described as follows:

He stated he has resided at that address for approximately three years and is employed by the United States Engineers. He recalled the couple who occupied the rear apartment at 4905 Magazine Street from June, 1963, until late September, 1963, but did not know their name until he observed a photograph of LEE HARVEY OSWALD in the newspaper on November 22, 1963, who was arrested as a suspect in the assassination of President KENNEDY as being identical to the man who occupied the rear apartment at 4905 Magazine Street. He said that this man was not very sociable and did not speak to him or anyone else in the neighborhood. He said that this man generally sat on his lawn or on his porch reading. He said the man frequently wore his bathing suit. He said that he was under the impression that OSWALD was not employed inasmuch as he was around the apartment most of the time. He said that he often wondered what source of income OSWALD had. He stated that OSWALD apparently liked chicken inasmuch as he observed frozen chicken thawing on OSWALD's kitchen window sill several times a week. EAMES further advised that his kitchen window is directly opposit OSWALD's and that he had an unobstructed view of this window and OSWALD's kitchen. EAMES said that an alley of approximately 15 feet in width separated his kitchen window from OSWALD's kitchen window.

EAMES said that he never observed OSWALD exhibit any guns. He said that he did see OSWALD in the main branch of the New Orleans Public Library on one occasion and observed OSWALD frequently reading on his porch and lawn.

He said that the only peculiarity he recalls about OSWALD was the fact that he never spoke to anyone and that when he spoke to his wife he spoke to her in a tone of a command and always in a foreign language, which he believed to be Russian. He said that the OSWALDs never had any visitors as far as he knew. EAMES further

She stated she has resided at that address since October, 1962. She said that she was familiar with the couple who occupied the rear apartment at 4905 Magazine Street but never knew their name. She said that when she saw the picture of LEE HARVEY OSWALD in the newspaper on November 22, 1963, as being a suspect in the assassination of President KENNEDY she recognized him as being the man who occupied the rear apartment at 4905 Magazine Street from approximately June, 1963 until late September, 1963.

She said that while OSWALD lived at that address he never spoke to anyone and kept protty much to himself. She said that OSWALD and his wife talked in a foreign language, which sho believed to be Russian. She said that she worked during the day so that she did not see OSWALD very often and that when she did it was in the late afternoon when she returned from work. She said she recalls seeing a short, stocky, dark complected individual. who was wearing a dark business suit and looked to be either Mexican or Cuban extraction, enter OSWALD's home approximately three weeks before OSWALD vacated the apartment. She said that she did not believe she could identify this man inasmuch as she only observed the side of his face but was able to closely observe his appearance.

She stated that she also recalls seeing a woman who drove a station wagon bearing Texas license plates arrive at the Oswald apartment during late September. 1963, and load clothing and other articles into this station wagon. She furnished the following description of this woman:

She stated that the manager of the apartments, Mrs. LENA GARNER, told her that Mrs. OSWALD had returned to Texas. She said that she assumed that Mrs. OSWALD left with this woman. She further advised that this same woman brought OSWALD and his wife to this apartment in early June, 1963. She said that this woman remained two or three days and then left. She said at the time Mrs. OSWALD left she was approximately eight months pregnant. She said that the OSWALDS had a son approximately two years old.

She further advised that the only thing peculiar she noted about OSWALD was the fact that he was constantly spraying the ants and bugs in the back yard and that he frequently wore his bathing suit. She said that she never saw OSWALD exhibiting any guns but did observe OSWALD reading on his porch quite frequently.

She also advised that she did not believe OSWALD was employed inasmuch as he was around the house most of the time and when he did go out he would return shortly thereafter. She stated that OSWALD and his wife remained around the apartment most of the time.

- Mr. and Mrs. JESSE JAMES GARNER, 4911 Magazine Street, . advised that OSWALD rented the apartment at 4905 Magazine Street on May 9, 1963 and moved into the apartment either the same h day or the following day. His wife and baby came to New Orleans two or three days after OSWALD moved into the apartment in 4 a station wagon bearing Texas license plates driven by a woman who spoke the Russian language. OSWALD paid his rent in cash and there was no written rental agreement which was signed by him. Actually the apartment is owned by Mrs. BLAINE GREGORY, 414 Emerald Street, New Orleans, and Mr. and Mrs. GARNER act as rental agents for the apartments located in the building.

OSWALD advised Mrs. GARNER in September, 1963, that his wife was going to have a baby and that she was going to Texas for her confinement. The OSWALDS packed the wife's and baby's clothing on Sunday, September 22, 1963, and the same station wagon which had brought Mrs. OSWALD to New Orleans and driven by the Russian speaking woman who brought Mrs. OSWALD here was observed in front of the apartment. On this occasion, this woman was accompanied by her two small children. The clothes and play pen and other personal effects were loaded into the station wagon on the morning of September 23, 1963 during the mid-morning. According to Mrs. GARNER, the front seat of the station wagon was occupied by the driver and her two children, together with Mrs. OSWALD and her child. The rear portion of the station wagon was packed full with the OSWALDS' household effects and according to Mrs. GARNER, there was no room for any other passenger. OSWALD was observed by Mrs. GARNER after his wife departed, to board a bus at the corner hear his residence. He left some clothes hanging on the line at the rear of his apartment. He was not seen or heard in the apartment on September 24, 1963, however on September 25, 1963, Mr. GARNER entered the OSWALD apartment and found the keys on a table and observed that all of OSWALD's personal effects had been removed, including the clothes on the line.

According to Mr. and Mrs. GANNER, OSWALD did not associate with anyone in the neighborhood and rarely spoke to them. Mr. GARNER recalled that OSWALD did not even bid him the time of day. On one occasion in the evening, an

A visual observation was made of the residence at 407 Magazine Street. It was found to be a one story double, being the house next to the corner house. Dete November 25, 1963 Nrs. GLADYS RODGERS, 4907 Nagazine Street, was interviewed in an office in the Psychiatric Ward of Charity Hospital. Her psychiatrist, Dr. KYLE HAMM, was present during the entire interview.

She advised that she remembered LEE OSWALD and his wife who resided in the apartment which was immediately adjacent to her apartment. She said that LEE OSWALD worked at a coffee company for several months and then lost his job. During the time he was working he would leave home at 7 a.m. and return home at about 5 p.m. During the time he was working he spent the weekends at home with his wife and baby. After he lost his job, occasionally he would leave home about 1 p.m. and come back at about 5 o'clock in the evening. Occasionally he would change this routine and leave sometime around 10 or 11 a.m. and return at about 5 p.m. in the afternoon. On these occasions he was casually dressed, usually wearing a dark pair of trousers and a white sports shirt. She said that OSWALD conversed with his wife in a foreign language which she thought was Russian. He was very mean to his wife and beat her up on several occasions. OSWALD was aloof and kept to himself and only had one conversation with her. On this occasion he inquired as to why she would raise her window and leave it in that position for a short period of time and then close the window. She stated that she told him that she was trying to keep the insecticide, which he used to spray for ants and other pests, from coming in her apartment. In this connection she stated that frequently she would observe OSWALD spraying the under portion of the floors of his apartment. She recalled that OSWALD had two male visitors who arrived at about 3 p.m. one afternoon. One was a tall slender individual whose name was BILL STUCKEY. He conversed with OSWALD about a radio program and instructed him to be at 520 South Broad Street at 4:30 p.m. She advised that the companion of BILL STUCKEY was PETE MOLLAR (Phonetic). She heard them mention an individual named HAYDEL (Phonetic), but she does not recall in what connection his name was mentioned.

Mrs. RODGERS said that upon one occasion she observed an individual talking to her husband, ERIC BODGERS, and asked for the location of the OSWALD apartment. This was several days before OSWALD moved. She described this person as white male, 5'7", 175 pounds, dark complexion, wearing dark trouser and a white shirt, and had a foreign appearance, probably Spanish. **Bhe** recalled that OSWALD received a package of books through the mail and said that in his spare time he always sat on his front porch and read. She recalled an elderly couple visited OSWALD on two occasions, both during the day time, once was on a Saturday and once was on a Sunday. This couple drove up in a green, medium sized station wagon and on the last occasion when this couple called, Mrs. OSWALD packed all of her clothes and personal effects and went off in the station wagon. Mrs. RODGERS remembered that prior to the time Mrs. OSWALD left in the station wagon, a young couple in their early 20's stopped in to see the OSWALDs and that they arrived in an automobile but that she did not know the make or model of the car. She said that she did not see any firearms in the possession of either Mr. or Mrs. OSWALD.

She recalled that after OSWALD lost his job a female, who wore a white coat and who was thought by Mrs. RODGERS to be a welfare worker, called at the OSWALD apartment. She stated that several days later OSWALD brought home a large bag of groceries which she assumed he got from either the welfare agency or a relative.

JOHN EX HEVRON, Assistant Secretary and Treasurer, New Orleans Public Service, Inc., 317 Baronne Street, advised that his records show that LEE H. OSWALD applied for gas and electric services for the lower center apartment at 4907 Magazine Street, on May 9, 1963. He indicated a former address of 757 French Street, and showed his employer as LEON ISRAEL Company, 300 Magazine Street. He said that the service was turned on on the morning of May 10, 1963, and that no one was home at the time the service man made the installation and that the service man had obtained the keys for the apartment from a neighbor. He said the service was ordered disconnected on October 7, 1963, as a result of a telephone call received by GUY HENNESSEY, Service Center Representative and the records indicate that the caretaker of the apartment had called and advised that the apartment had been vacated. A notation in the file showed that it was a possibility that the occupant of the apartment had left the city. Mr. HEVRON stated that OSWALD owed the Public Service a gas and electric bill of \$23.17, and that when the service was discontinued, the bill was mailed to the address 4907 Magazine Street.

He stated that he now is sure that BEA OSWALD is not identical with LEE HARVEY OSWALD and that he recognized the latter because he lives quite near his former residence on Magazine Street.

Mr. MOLINERE advised that he did not know the whereabouts of OSWALD on September 18, 1963, but did see him walking on Magazine Street sometime after OSWALD was arrested in New Orleans on August 9, 1963. He could not specify the exact date.

He assisted in the review of these prescriptions for the period of May 1, 1963 to September 30, 1963, inclusive, and, when asked, explained the nature or content of any prescription of question. He said he knew most of the persons for whom he had filled these prescriptions, being in that neighborhood for many years. No prescription was found in the name of OSWALD, HIDELL or O. H. or V. L. LEE, or for any person for the addresses of 4907 Magazine Street "OF 757 French Street.

MC NULTY stated that he recalled LEE HARVEY OSWALD, upon seeing his photograph in the paper after the assassination of President KENNEDY, as a person who used to come in that pharmacy to purchase a daily paper, this being during the summer of 1963 (dates unrecalled). He knew he had never filled any prescriptions of any nature for OSWALD. He said he did not know Mrs. OSWALD and might possibly have filled a prescription for her, although he does not recall same. He said a prescription could have been filled by him for certain type ear or nose drops, skin cream, or antibiotic ointment, in which instance he would not have retained the prescription and the item purchased by the customer would not have required labeling. To obtain a refill, the patient need only call for the drug by hame or return an empty bottle for a refill.

HENRY GOGREVE, owner of Eenry's Market, 5101 Magazine, New Orleans, Louisiana, Wdvised that he recalled y Beeing LEE HARVEY OSWALD in his store several times, but never had any conversation with OSWALD nor could he recall any particular date that OSWALD was in the store.

He further advised that during the early afternoon of November 26, 1963, a man and a woman, who appeared to be husband and wife, and who also appeared to be Cuban inasmuch as they spoke with a Cuban or Spanish accent, came into his store, purchased a soft drink, and began a conversation with him. He said that the man and woman told him that OSWALD was not guilty and should not have been shot. He said that he was of the opinion that they arrived by bus, although he did not actually see what means of transportation they used to get to his store. He said he had never seen these two individuals before and from their conversation, they were apparently friends or sympathizers of OSWALD. They began this conversation by asking him if he was the individual whom they saw on television and who had made statements that he had known OSWALD. He said it was obvious that these two people did not enter his store to conduct business, but primarily to express their opinion regarding LEE HARVEY OSWALD and his death.

Mr. ERIC ROGERS, 407 Magazine Street, front apartment, advised that he and his wife moved into this apartment on about July 16, 1963 and that OSWALD and his wife were already living in the adjoining apartment at 4905 Magazine. ROGERS said that he was out of work and that it was not until October 1, 1963 that he, ROGERS obtained a part-time job at the Meal-A-Minute, 1000 Canal Street, as a waiter. He said that up until he went to work he believes that he saw OSWALD at least once every day, up until the time OSWALD left.

He recalls that OSWALD had packed household effects and clothes in a station wagon one afternoon and that OSWALD's wife and child departed with the woman who drove the station wagon on the following morning. He said on the following day he saw OSWALD running to catch a bus on the corper, carrying two suitcases. That was the last time he saw him.

Shortly after ROGERS moved into the neighborhood he observed an individual whom ROGERS thought to be of Spanish descent called to visit OSWALD. The exact time of this visit not recalled by ROGERS, but he is certain that it was before the time OSWALD was arrested by the New Orleans Police Department.

ROGERS never saw any guns or firearms in the OSWALD apartment and never saw OSWALD with anything resembling a firearm. He recalls that although OSWALD spent the majority of his time reading either on the porch or in the front room of his apartment, in the afternoons he would walk to the corner and catch a bus going toward the business section or would walk in that direction. He said occasionally OSWALD would walk up to the confectionary on the corner of Magazine and Dufosset to buy ice cream, since he would see him returning to the apartment with it. He said that OSWALD always spoke Russian to his wife, in fact, Mrs. OSWALD could not speak any English.

He said that it was rumored in the neighborhood that Mrs. OSWALD was pregnant at the time she moved and he believed that on one occasion OSWALD took her to a physician. The date and time of this visit was not recalled by ROGERS, Mor was the identity of the physician known to him.

JESSE JAMES GARNER, 4911 Megazine Street, advised that on September 16, 1963 he approached OSWALD at the OSWALD apartment and asked OSWALD when he intended to pay his rent for the apartment which was due co September 9, 1963. OSWALD said that he did not have the money to pay the rent because his wife was going to have a baby and that he wanted to keep a few dollars for omergencies. Mr. GARNER agreed to give OSWALD more time to pay his rent. He said that on Wednesday, September 18, 1963 he believes that he saw OSWALD sitting on his front porch reading but that he cannot positively affirm this. On Thursday, September 19, 1963 and Friday, September 20. 1963, GARNER was off from work and stayed at the apartment, cutting grass and doing other chores in the yard. He recalled that the woman who was visiting the OSWALD's and who drove a station wagen with Texas license plates was in the small yard in front of the OSWALD apartment with her two children. He asked her how she liked New Orleans and she replied that she enjoyed it and had visited the New Orleans French Quarter with the OSWALDS on the previous day. GARNER observed OSWALD in the OSWALD apartment on both of these dates, namely September 19 and September 20, 1963.

On September 21, 1963 GARNER went to work and did not observe OSWALD until that evening when he, GARNER returned home from work and he observed that OSWALD was placing some of his personal effects in the station wagon which belonged to the woman from Texas. On Sunday, September 22, 1963, OSWALD completed packing the station wagon and was tying down a baby's stroller on the back of the station wagon when GARNER approached him and again asked him for the rent. OSWALD replied that his wife was going to Texas for her confinement and that he, OSWALD intended to remain in New Orleans. He promised to pay his rent at a later date.

Mrs. MILDRED SAWYER, 126 Exchange Place, New Orleans, Louisiona furnished the following information:

Mrs. SAWYER advised that she is the widow of JOSEFH S. SAWYER, and that she was residing at 126 Exchange Place in the latter part of 1955, and has continued to reside at that address since that time. She stated that she recalled a Mrs. OSWALD and her young son living there at that time. She stated that the boy was only about 14 or 15 years old and attended school during the day. She did not know of any jobs that he might have had, either after school or on the week ends.

Mrs. SAWYER advised that Mrs. OSWALD was a saleslady and worked for one of the large department stores on Canal Street. The son would always arrive home prior to his mother, and was always very quiet. He seemed to read a lot and was seen on several occasions bringing library books home to read. Mrs. SAWYER stated that at that time the son appeared to be an average, normal teenage boy, dressed neatly, and was not boisterous in any way. As far as she could recall she never heard him being reprimanded by his mother. Both Mrs. OSWALD and her son seemed to have few friends, and very few people visited them in their apartment. She believed that on a few occasions some teenage boys did come home with the OSWALD boy after school, however, they were always very quiet, and did not stay long.

Mrs. SAWYER stated that she never saw the OSWALD boy with any kind of gun, and never heard Mrs. OSWALD mention that he had any gun, or was interested in guns.

Mrs. SAWYER advised that she believed sometime in the Spring of 1956, Mrs. OSWALD told her that she was leaving New Orleans with her son, and that she was going to Fort Worth, Texas where she had another son. Mrs. SAWYER could not recall if Mrs. OSWALD quit her job voluntarily or whether she was terminated by the department store where she was employed

The meters were again read on August 26, 1963 and a bill for \$10.32 was rendered. This bill was not paid on or before September 17, 1963, the due date, and therefore the penalty was added to the bill, which on that date became a total of \$11.36.

The meters were read again on September 25, 1963 and a bill of \$11.02 was rendered, which was due to be paid on or before October 17, 1963. This bill was not paid and therefore after October 17, the penalty of \$.79 was assessed, making the total amount owed to the New Orleans Public Service \$23.17. Deducting the deposit of \$10 which was made by OSWALD at the time he applied for electric and gas service, plus the interest earned on this deposit of \$.20, the net amount owed to the Public Service was \$12.97.

CHESTER ALLEN RIGGS, JR., Vice President, Orbit Industries, Lac., 250 Carroll, howe address 836 Edgefield, advised that he is the owner of a duplex house at 2703 Mercedes Street. Mr. RIGGS said that he owns the duplexes at 2701 through 2715 Morcedes and acquired this property as an investment because the property is located in commercial zoning. He said the duplexes are of a low income type rent property.

Nr. RIGGS said further that he does not keep a record of persons presently residing in the duplexes and has no record of persons by name as baving resided in these duplexes as the only record maintained by him is the renial income, which would be for tax purposes only.

Mr. RIGGS said that as a result of the assassination of President KENNEDY in Dallas on November 22, 1963, and the ensuing total television and radio coverage, that it came to hig attention, and he recalls that LEE OSWALD did reside in his duplex located at 2703 Mercedes for a period of about three months during the Summer and possibly sarly fall of 1962. Mr. RIGGS said that he has searched his records cf. remial income during that period of time through his accountant and has found that there is no individual rental shown on each duplex and that the income was all grouped. Therefore, he would say there would be no way of pinpointing the exact dates that OSWALD and his wife resided at 2703 Mercedes.

Nr. BIGGS said further that he could furnish the following information from memory concerning OSWALD. He said be caught now recall the conditions under which OSWALD and his wife moved from 2703 Merceddes; however, he recalls that there was no adverse condition which prompted OSWALD to move.

rent that OSWALD would be reading. RIGGS said he recalls one time shortly after OSWALD moved into the duplex that he asked for curtains for the house. RIGGS said that he told OSWALD be would furnish curtains and at a later time went by the house and talked to OSWALD's wife, but upon talking to this person discovered that she could not speak English. RIGGS said he does not know what language she spoke.

RIGGS said further that he recalls during the period OSWALD was living at 2703 Morcedes, he recalls OSWALD telling him he worked for some welding company located nearby. RIGGS said further that bis business office is located near the duplexes and that he recalls seeing OSWALD walk to work and knows that he did not have a car during the period of time he lived at this address.

RIGGS said further that he cannot recall any other conversation with OSWALD except that concerning the curtains.

RIG3S advised that after OSWALD and his wife left 2703 Mercedes that he did not know where this family moved. He said he does not know where the OSWALD family resided prior to living ht 2703 Mercedes. RIGGS stated that he did not know any background concerning OSWALD.

Mr. RIGGS advised that the duplex owned by him is furnished. He said there is no other person living in his group of duplexes at the present time that would have lived in the duplexes at the time LEE OSWALD resided at 2703 Mercedes with the exception of one person and that is Mrs. MARION BOYD, who resides at 2707 Mercedes, which is next door to 2703 Mercedes. RIGGS explained that the turnover of tenants in his group of duplexes is very great due to the type of housing.

On October 18, 1963, Mrs. EDITH SHANNON, 2701 Mercedes Street, Fort Worth, Texas, advised that she could not recall LEE OSWALD or bis wife when they lived at 2703 Mercedes Street, Fort Worth, Texas.

On October 18, 1963, Mrg. M. M. BOYD, 2705 Mercedes Street, Fort Worth, Texas, advised that she could not recall LEE OSWALD when he resided at 2703 Mercedes Street, Fort Worth, Texas.

On October 29, 1963, a pretext interview by a Special Agent of the FBI at 2919, West Fifth Street, Irving, Texas, reflected that Mrs. RUTH, PAINE resided at 2515 West Fifth Street. Mrs. PAINE was separated from her husband, MICHAEL B. (FAINE. It was determined that Mrs. PAINE was Employed at St. Mark's School, Dallas, Texas, on a part-time basis as a teacher of the Russian Janguage and she had'a Russian born woman living with her. This Russian born woman gave birth to a girl about a week ago and Mrs. PAINE was taking care of this woman. If was determined that the husband of the Russian born woman visited his wife at this address periodically but did not reside there.

On October 31, 1963, <u>bis.</u> DOROTHY SMITH, Irving, Texas, Credit Bureau, advised that they had a credit record for MICHAEL B. PAINE and his wife RUTH PAINE, who resided at 2515 West Fifth Street, Irving, Texas. Mrs. SMITH advised their credit was satisfactory and that Mr. PAINE was employed by Bell Helicopter Company in Fort Worth as a Design Engineer. Mrs. PAINE was employed as a housewife.

On October 31, 1963, Mr. EDWARD T. OVIATT, Assistant Head Master, St. Mark's School of Texas, Dallas, Texas, advised that Mrs. PAINE was a Satisfactory employee and was loyal to this country and he considered her to be a stable individual. Mr. OVIATT stated that Mrs. PAINE was employed on a part-time basis as a teacher of Russian language. He also advised that he had recently learned from DL 100-10461 2

a conversation with Mrs. PAINE that she had a Russian born woman living with her and she was assisting this woman in view of the fact that she had recently had a new baby and she, Mrs. PAINE, was: improving her Russian speaking ability by having this Russian speaking person in her house.

On October 31, 1963, J. H: KITCHING, Dallas County Sheriff's Office, and LEON POWERS, Irving, Texas, Police Department, advised that they had no record for RUTH PAINE.

On October 31, 1963, Mr. TED SCHURMAN, Security Officer, Bell Helicopter, Fort Worth, Texas, advised that MICHAEL R. PAINE was presently employed by that company as an engineer and he holds a security clearance.

On November 1, 1963, Mis. RUTH PAINE, 2515 West Fifth Street, Irving, Texas, was interviewed at which time she advised that MARINA OSWALD, wife of LEE HARVEY OSWALD, was staying with her following the recent birth of her baby. Mrs. PAINE furnished OSWALD's place of employment as the Texas School Book Depository, 411 Elm Street, Dallas, Texas, where he was employed as a laborer. Mrs. PAINE stated that she did not know where OSWALD was residing in Dallas at this time but that it was his plan as soon as he had enough money, to get an apartment for his family and take his wife and children to live with him. Mrs. PAINE volunteered that she would be glad to furnish this address to the FBI as soon as she determined where the OSWALDs were residing.

On November 5, 1963, Mrs. RUTH PAINE advised SAs JAMES P. BOSTY, JR. and GART S. WILSON that she had not been able to obtain the address of LEE OSWALD in Dallas, Texas, but that she would furnish it to the FBI as soon as she was able to obtain it. Mrs. PAINE advised that LEE OSWALD had visited his wife, MARINA OSWALD on November 2 and 3, 1963, at Irving, Texas.

Mrs. PAINE then expressed the opinion that she considered LEE OSWALD to be a very illogical person and recalled that he admitted to her being a "Trotskyite Communist." **DL 100-10461**

CATHERINE, ANE, Secretary, Warren Easton High School, 3019 Canal Street, New Orleans, advised Special Agent JOHN M. MCCARTHY of the following facts after a review of her records:

She advised that a file from Beauregard Jr. High Schoolrevealed LEE OSWALD, 126 Exchange, New Orleans, Louisiana, entered Beauregard Jr. High School on January 1, 1954, and stayed through the 1955 school year. She stated that the record shows OSWALD formerly attended Riglio Elementary School Fort Worth, Texas, as well as Byron Jr. High School (PS 44), New York City, New York. The record further shows that OSWALD's father ws RCHERT EDWARD OSWALD while his mother was MARCHET YOSWALD. The record showed both of the above individuals resided at 126 Exchange, New Orleans/, Both OSWALD's father and mother were employed as store managers but the name and address of the stores were rot listed. The file also showed that OSWALD listed no brothers but had two sisters.

The file reflected that OSWALD was born on October 18, 1939, at New Orleans, Louisiana. He listed his height as 5'5", weight fat 135 pounds. The subjects OSWALD liked best were Civics, Math, and Science while the subjects he liked least were English and Art. OSWALD listed his present vocational choice as Biology and Nechanical Drawing. He said, via the record, that his health was generally good except for an abnormal left ear drum. He listed his recreational activities as reading and outdoor sports with a particular interest in football.

CATHERINE AME advised that OSWALD showed an address of 809 French Street, New Orleans, where he probably resided during the time he attended Beauregard Jr. High School.

Mrs. ANE stated that OSWALD came to Warren Easton High School on September 8, 1955, and left on approximately October 14, 1955. She stated that the file shows a letter dated October 7, 1955, from <u>MARGRET</u> OSWALD in which it is explained that LEE HARVEY OSWALD was being withdrawn from school due to the fact that she and LEE were moving to San Diego, California. She stated that the file further shows that the school received a request on September 18, 1956, to forward

OSWALD's records to Arlington Senior High School, Fort Worth, Texas. She stated that the Warren Easton records show OSWALD's name to be LEE HARVEY OSWALD, 126 Exchange Place, New Orleans; Louisiana. They show OSWALD's mother to be <u>MARGRET</u> OSWALD of the same address and his date of birth as October 18, 1939. ANE said most of OSWALD's grades were in the 70's except that he averaged in the 80's in Civics and Art and Physical Training.
