She stated she could furnish no additional information in this matter, but added possibly a review of his school records would provide additional information.

Dr. MURRET stated his mother and LEE's mother did not get along very well. LEE's mother had been previously married. He is of the opinion LEE's mother never went to church. His opinion is that LEE's mother was the type of person who would remind LEE of the difficult times she had after the death of LEE's father and how hard she labored to raise her children. He stated LEE probably also felt resentment towards the world because of his inability to provide a good livelihood for his family.

Mrs. HAZEL OSWALD, 136 Elmeer Street, Metairie. Louisiana, advised she is the widow of WILLIAM STOUT OSWALD, She stated her husband's brother, LEE OSWALD, SR., and wife, MARGUERITE, nee Claverie, had been residing in New Orleans, in the 1930's. LEE SR. died in 1939 and approximately? two months after his death, a son, LEE HARVEY OSWALD, was born. When LEE was approximately 21 years of age, MARGUERITE left New Orleans, going to the Fort Worth, Texas, area where she continued to raise LEE and an older brother, ROBERT E. Mrs. OSWALD stated the next time she heard from either MARGUERITE or LEE was one day in about April, 1963, when LEE telephoned her saying he was in New Orleans and wanted to visit and obtain some information about his father's relatives, specifically a HARVEY OSWALD, the grandfather, then deceased. LEE came to her residence and arrived alone by bus. They talked about his father's folks and she gave him a photograph of his father. were Russian and LEE replied "Why do you ask that?". She said that other than this one exchange, all of her conversation was about relatives.

She stated she did not hear from nor see LEE thereafter and to her knowledge he was not in personal contact with any of the other relatives in the OSWALD family. With respect to any contacts or associates in New Orleans, she stated she had no knowledge whatsoever as to what his activities may have been. As to other members of the OSWALD family, she said she had a son, NORMAN A. OSWALD, at 706 Division Street, Metairie. He has a son, WILLIAM STOUT OSWALD, III, who is a school teacher in Metairie, and has some responsible position in one of the military reserve units. WILLIAM OSWALD, III, had talked to Mrs. OSWALD on the morning of November 23, 1963, indicating someone had questioned him about LEE OSWALD and he indicated that he knew nothing whatsoever about him. She said she does not know what school or organizations LEE might have been associated with while he resided in New Orleans and that the name HIDELL meant nothing to her and she was positive it was not an OSWALD family name. She had never heard LEE use this name.

In conclusion, Mrs. OSWALD advised that after the death of LEE's father, the mother had severed relations with the OSWALD family and after moving to Texas, did not maintain any association with any member of the family and she could not furnish any further details concerning his background.

Date November 25, 1963

Mr. and Mrs. CHARLES MURRET advised that LEE HARVEY OSWALD is Mrs. MURRET's nephew, Mrs. MURRET's sister being OSWALD's mother. Sometime after Easter, 1963, exact date not recalled, OSWALD called Mrs. MURRET on the telephone and advised that he had just arrived in New Orleans by bus. He asked if he could spend a few nights at her residence while he was seeking employment in New Orleans. They said that he spent from three to five nights at their residence, and that he spent the daytime seeking employment. He would never eat breakfast but would leave early in the morning and return to their residence shortly before dinner and would eat the evening meal with them. OSWALD had but few clothes consisting of a change of pants and shirt although he claimed to have several duffel bags at the bus station. He also had a few cardboard boxes in which he stated were clothes belonging to his wife and baby which he kept in the MURRET garage. OSWALD did not possess any firearms while residing at the MURRET . residence to their knowledge. He had no visitors while staying there and only received one letter which he claimed was from his wife. He did receive several telephone calls after he left regarding jobs. OSWALD obtained a job, according to his statement to them, as a mechanic at the Reily Coffee Company which they believe he obtained by answering a newspaper advertisement. He told them he found an apartment on the same day on which he got the job and that he moved to this apartment either the next day or the day following it. OSWALD's wife and baby arrived several days later from Texas in a station wagon which was driven by a woman who spoke the Russian language. Mr. and Mrs. MURRET did not know this woman's name but they did recall the station wagon bore Texas license plates.

Mrs. MURRET advised that she and her sister, OSWALD's mother, did not getalong very well and that when OSWALD was about two years of age, her sister and her children moved to Texas. She said she has had no contact with LEE OSWALD over the years until he telephonically contacted her requesting permission to stay at her home while seeking employment.

Mr. and Mrs. MURRET knew of no friends or acquaintances of OSWALD in the New Orleans area. Mr. and Ters. MURRET had no knowledge of when OSWALD left New Orleans or by what means he may have traveled.

JOYCE later told her she stopped at the Police Station two or three times and left without making up her mind whether she should pay the money, which she believed was \$25, to get him released. JOYCE asked a police officer to show her the sign or literature OSWALD had been carrying and when she saw it pertained to FAIR PLAY FOR CUBA she said she was not anxious to have him released. The police officer suggested to her that instead of paying the \$25 she should contact one of the city or state officials who has the power of parole and OSWALD would be released on parole until his case was heard, without her having to pay the \$25. JOYCE then contacted a family friend, EMILE BRUNO, who operates the B & W Package. Liquor Store, 2712 Canal Street, and Mr. BRUNO contacted Someone else who had OSWALD paroled.

Mrs. MURRET advised OSWALD Visited her home about two or three times from the time he arrived in the Spring of 1963 to Labor Day, which is the last day she saw or heard from him.

Several weeks after OSWALD brought his wife and child to New Orleans, MARILYN MURRET took them crabbing. OSWALD told Mrs. MURRET when he first arrived in New Orleans that his wife liked to be near water and he liked to go crabbing, and also liked the water, so he thought he would settle in New Orleans if he could find work.

On another visit to her house, OSWALD and his wife and child spent the entire day and ate dinner with them. She is of the opinion her daughter, JOYCE, was visiting her at the time. On this occasion, Mr. MURRET drove them to their Magazine Street apartment in his green, Mercury, 1956 model.

OSWALD, his wife and child, visited the MURRETS on Labor Day. Mrs. MURRET's son, JOHN, drove them home to their apartment in a Dodge, four door, white color, 1960 model. Mrs. MURRET and daughter, MARILYN, accompanied them.

Mrs. MURRET stated no members of her family went into the apartment at any time, to her knowledge.

OSWALD gave her telephone number, HU 8-4326, as the place where he could be reached while he was seeking employment. He would then telephone her during the day to find out if any prospective employer or employment agency left a message for him. She recalled there were several calls for him and the messages were relayed to him. She could not recall the names of any of the people who telephoned.

OSWALD did not engage in any political talk during the several visits to her home. He did on one occasion say something in praise of President KENNEDY and JACQUELINE KENNEDY but it was during a casual conversation and not in connection with any political discussion.

OSWALD did not smoke or drink. He tried not to inconvenience the MURRET family. He borrowed a few dollars from Mr. MURRET when he rented the apartment and repaid him when he received his first salary.

Miss MARILYN MURRET, 757 French Street, a teacher at Junior University of New Orleans, furnished the following information:

She is a cousin of LEE HARVEY OSWALD. Her mother and LEE's mother are sisters. She did not see LEE OSWALD during her trip around the world which started in July, 1959 and ended in January, 1963. She did not visit Russia. Her first stop after leaving the United States was Hawaii. She stopped at practically every country between there and England. She taught school in several countries. She went from country to country, spending some time in Japan, New Zealand and Australia. She visited the countries in the Holy Land, Turkey, Greece, countries of Europe and arrived in London in January, 1963.

She advised that this past summer she left New Orleans on July 13, 1963 and traveled through Mexico and the Central American countries to Panama and came back to the United States just before Labor Day.

Miss MURRET stated she could recall nothing concerning LEE OSWALD during his childhood and did not know of any of his friends or acquaintances.

She met OSWALD when he came to New Orleans in the Spring of 1963 and stayed at her mother's house for a few days while he was seeking employment. She met LEE's wife and child and took them crabbing several weeks after they arrived in New Orleans. LEE visited her home several times but she never engaged in any other than ordinary conversation with him. He never discussed politics or his political views. She never visited LEE's apartment on Magazine Street but was in the car when her brother JOHN drove LEE and his family home on Labor Day. This was the last time she saw LEE or heard anything from him.

About the only conversation she could recall that LEE's wife. engaged in, was after the time they went crabbing.

Mrs. OSWALD apparently did not realize that LEE enjoyed going crabbing and that is the only reason that she took them.

Miss MURRET stated that the few times LEE OSWALD and his family visited at her home they came by bus. She maid OSWALD did not own an automobile and insofar as she knew was incapable of driving one. She stated her brother, JOHN MURRET attempted to teach OSWALD to drive, but JOHN MURRETT told her OSWALD was not interested in learning.

Mrs. CHARLES F. (LILLIAN) MURRET, 757 French Street, furnished the following information:

The address 809 French Street which her nephew, LEE HARVEY OSWALD, may have given to the P. G. Beauregard Junior High School or Warren Easton Senior High School is not an address at which he ever lived, but rather is the address by which her own residence was known prior to about ten years ago. The house numbers on the street were changed at that time and her house number was then changed to the current 757 French Street. OSWALD and his mother probably stayed at her home for a few days when they returned to New Orleans around that time or OSWALD may have given that address because he knew it was a more permanent address than the one his mother and he would have. OSWALD and his mother lived on Exchange Place at this time and it may be that he also listed Mrs. MURRET's address in case of an emergency of some kind. OSWALD never actually lived at her home but only stayed for a few days.

Mrs. MURRET advised that a few of her relatives still send her cards addressed to the old address. LEE OSWALD sent her a card while he was in Russia and he addressed it to 809 French Street. She stated the card was destroyed by her nephews while they were playing games. As best she could recall, OSWALD requested on the post card that she write to his mother.

Mr. JOHN M. MURRET, residence address 6622 Louis XIV Street, employed by the E. R. Squibb and Sons as a pharmaceutical representative, furnished the following information:

He is a cousin of LEE HARVEY OSWALD. His mother and LEE's mother are sisters. He could not recall anything about LEE OSWALD while LEE was going to Beauregard Junior High School or Warren Easton High School. He did recall that on one occasion LEE's mother telephoned his house several times during an evening when LEE apparently was attending a party of the Civil Air Patrol. LEE's mother was worried and, he understands, LEE did not arrive home until about 2:00 A.M. This is the only incident he could recall pertaining to LEE's stay in New Orleans in the 1950's. LEE never did play with him when they were both children.

In the Spring of this year, he went home at lunchtime and there was a bag on the floor, and his mother told him that he could never guess who was at the house. For some unexplained reason, LEE's name came to his mind and he guessed that was who it was. LEE had on worn clothes and was wearing a heavy wool suit which had apparently been purchased while he had been in Russia. He gave LEE some of his white shirts and ties so that he would look presentable while seeking employment.

LEE apparently contacted a number of employment agencies and left word with them to call the telephone number of MURRET's mother, because JOHN answered quite a number of telephone calls himself. LEE had apparently requested that the number be called even though no job was available because most of them merely told JOHN that there was nothing available for LEE. He recalled receiving a call a few days after LEE started to work for the William B. Reily and Company. The caller, who was a man, said that they had something LEE was interested in and gave a name and telephone number. JOHN tried to call LEE at the Reily company but could not immediately reach him and then tried to look up in the telephone book the name he had been given but could not find it. He did not telephone the number given to him to advise that he could not immediately contact LEE, but later on did give LEE the message. He was of the opinion that it was a blueprint or a photography shop that had called.

JOHN recalled that LEE received a letter from the Unemployment Department of the State of Texas, which apparently

contained his unemployment check. He could recall no other mail received by LEE.

LEE and his wife and shild visited the MURRET home on about three occasions. There were no political discussions of any kind. LEE had worked in Russia either as a photographer or as an assistant in the photographic laboratory and was interested in painting and draftsman's work.

MURRET recalled that on the day OSWALD had a debate over a New Orleans radio station with another individual, pertaining to his political views, LEE telephoned the house about fifteen or twenty minutes before the debate started and asked them to turn on the radio to listen to it, which he did. He did not question OSWALD subsequently in connection with this debate or regarding his political views.

He never went into LEE's apartment on Magazine Street but he did drive him home on Labor Day after LEE and his family had visited MURRET's home. MURRET's mother and sister accompanied him and he drove his 1960 white four-door Dodge Dart automobile.

MURRET's father drove LEE and his family home the one or two other times in his father's 1956 green four-door Mercury, although the family's 1950 gray Plymouth may possibly have been used.

JOHN MURRET stated LEE HARVEY OSWALD had no co-ordination whatsoever. MURRET tried to teach him to drive an automobile and took him out about two hours one day to let him practice, but it appeared hopeless as OSWALD had no sense of co-ordination. JOHN MURRET stated that he actually pushed OSWALD into even trying to learn how to drive and OSWALD apparently was not in the least interested.

The last time MURRET saw OSWALD, or heard anything concerning him, was on Labor Day when he drove him home. He could furnish no information concerning any friends or acquaintances of OSWALD's.

Mrs. OTIS GRAFFORD, Mc Adams Ranch, Crowell, Texas, advised that Mrs. MARQUERITE CLAMERIE OSWALD of Fort Worth, Texas, had worked for her and her husband for two months during June and July, 1961, as a housekeeper and cook. added that she had employed Mrs. OSWALD as a result of Mrs. OSWALD answering an ad that she, Mrs. GRAFFORD, had placed in a Fort Worth, Texas newspaper. She added that Mrs. OSWALD was an excellent housekeeper and cook and that her employment was entirely satisfactory and the only reason she left was because she was a 11ttle bossy and that Mrs. OSWALD and her mother, LESLIFYMC ADAMS, who is elderly, started functing with each other quite a bit and all of them thought it better if Mrs. OSWALD left.

Mrs. GRAFFORD added that Mrs. OSWALD had advised her that she had a son who had gone to Russia and had married a Russian girl. She added that Mrs. OSWALD had furnished this information prior to the time she agreed to work for them. She further added that Mrs. OSWALD corresponded with her son and talked about him quite frequently during the time she worked for them. She added that Mrs. OSWALD had told them that her son, LFE OSWALD, had been discharged from the U.S. Marines and came to her home in Fort Worth where he stayed for two or three days then left to go to New Orleans, Louisiana, to work. She stated that Mrs. OSWALD further stated that she thought her son LEE was in New Orleans working until she read in a local Fort Worth paper that her son had defected' to Russia. She further added that Mrs. CSWALD told them that she had no idea whatspever as to why her son had left the United States and gone to Russia and could not understand how he could get to Russia unless maybe he might have been working for some Government agency.

Mrs. GRAFFORI) stated that when Mrs. OSWALD left their ranch that she moved to Vernon, Texas, where she worked for various families and that on one or two occasions she returned to Crowell and came to the ranch to visit them but only stayed a short time on each visit. OTIS GRAFFORD, McAdams Ranch, Crowell, Texas, advised that Mrs. MARGUERITE CLAVERIE OSWALD had worked for him as a housekeeper and cook from June 1, 1961, until August 1, 1961, when she left his employment because she and his mother-in-law, Mrs. LESLIE MC ADAMS, started fussing at each other nearly all of the time. He added he and his wife first became acquainted with Mrs. OSWALD when she answered an ad they had placed in a Fort Worth, Texas, paper. JOEALONG, 318 North First Street, Crowell, Texas, advised that Mrs. MARQUERITE CSWALD had worked for him for approximately six weeks during May and June of 1962 as a practical nurse taking care of his invalid mother. He added that Mrs. OSWALD had advised him and had mentioned it on several occasions that her son, LEE OSWALD, had left the United States and gone to Russia to live and had married a Russian woman and had one child. He added that during the time she was working for him, that she had received information that her son was going to return to the United States and bring his Russian wife and child with him and that she expected him to return in the near future. He added that during the time she worked for him, she appeared to be a loyal American citizen but was considerably upset and talked quite a bit. He further advised that Mrs. OSWALD had stated that she resented the fact that people did not have anything to do with her and turned their backs on her because her son had gone to Russia. BYRON FRILLIPS, Route 1, formon, Texas, advised that Mrs. MARGUERITE OSWAID had worked for Fim as a housekeeper and practical nurse for approximately six months from about August or September, 1961, until about January or February, 1962. He added that her duties were to take care of his mother and father, who lived mearby. He added her work was entirely satisfactory, and she never made any statements against the U.S. Government during the time he knew her; and, according to her actions and talk, he never had any reason to doubt her loyalty to the U.S. Government.

On November 24, 1963, YVONNE COOPER, nee RUSSELL, Operator Number 19, Covington, Louisiana, notified her supervisor that two or three days previously she had handled a prepaid long distance, person-to-person call to LEE HARVEY OSWALD at the "Texas State Book Depository", Dallas, Texas. Mrs. COOPER recalled that it was necessary for her to contact the Dallas information operator for this information. She specifically remembered the words "Book Depository" in her request to Dallas Information. She stated she obtained this number and was connected without any difficulty.

Mrs. COOPER stated that this call was placed by an adult female who was very polite, had no speech impediment, no accent, and who appeared to be familiar with the proceedings in placing long distance telephone calls. Mrs. COOPER stated that the answering party in Dallas, who was a female, was asked by her for LEE HARVEY OSWALD. The answering party advised she did not know who OSWALD was. At this point, according to Mrs. COOPER, the calling party advised OSWALD is a new employee. Mrs. COOPER thinks the calling party said OSWALD was the janitor. Mrs. COOPER stated that at this point the answering party said "oh" as if she knew who it was, and the call was completed.

Mr. TURNLEY stated that he interviewed Mrs. COOPER at length and was unable to obtain any variations in her story in any way. Mr. TURNLEY described Mrs. COOPER as being 31 years of age, with seven or eight years service with Southern Bell. TURNLEY stated Mrs. COOPER is divorced and lives with her mother and father in rural Covington, Louisiana. TURNLEY said that Mrs. COOPER appeared completely sincere and levelheaded throughout the interview and was not nervous. He stated that Mrs. COOPER told him she worried about this information on Saturday, November 23 and Sunday, November 24 and consulted her parents as to what to do, prior to reporting this information to her supervisor. She was then off for three days and again worked her regular shift on November 19, 20, 21, 22, and 23, 1963. Mr. TURNLEY stated that the only available toll tickets at Covington were those for November 21 and 22, 1963, which were visibly checked, and no such ticket was located. He stated that tickets for dates previous to November 21, 1963, had been forwarded to the Accounting Department and were mixed in with all of the other toll tickets, including direct-distance dialing tickets for the entire New Orleans area. He stated the Covington Office of Southern Bell handles calls from Covington, Slidell, Mandeville, Madisonville, Pearl River, and LeCombe, Louisiana. He said Mrs. COOPER believes the call originated at Slidell, Louisiana.

Mr. TURNLEY stated that he is attempting to arrange for an IBM run on all toll tickets in New Orleans, which he estimated to be approximately 70,000. He stated that the check would consist of three separate runs of these tickets and would necessitate the entire Accounting Section being shut down.

The following investigation was conducted by SA EDWARD C. MORGAN, JR.:

AT SHREVEPORT, LOUISIANA:

On November 27, 1963, Major ORVILLE/RICHARDS, Identification Officer, Shreveport Police Department, made available the arrest record of JOHN DAVID KHLGORE, Shreveport Police Department #68059. This reflects an arrest on July 26, 1959, for investigation of "false statement." He was sentenced on August 14, 1959 to a \$50 fine or 15 days in jail, and an additional 15 days in jail, for a violation of Paragraph 5, Article 174, Louisiana Code. No other local arrest was shown. AT BENTON, LOUISIANA:

On November 27, 1963, Deputy W. E. JONES, Bossier Parish Sheriff's Office, advised his records reflect that JOHN DAVID KILGORE, was received from the Bossier City Police Department, date unknown, on a charge of forgery and was sentenced on January 15, 1962, to one year in the Louisiana State Penitentiary, Angola, Louisiana. This record shows his address as Jefferson Motel, Shreveport, Louisiana, occupation bull dozer operator. It reflects birth place as Haskell, Louisiana, but does not indicate birth date.

Mrs. JOHN D. KILGORE, 2830 Chapman Street, Shreveport, Louisiana, advised her husband, JOHN D. KILGORE, had left the house that morning indicating he was going to contact the FBI and tell that he had known LEE HARVEY OSWALD in Dallas, Texas. She stated her husband is out of work and has been out of work ever since he was discharged from his job at Bilbo Trucking Company in Dallas, Texas, except for a brief period of employment with a trucking company at Shreveport. She stated he stays away from home most of the day and comes in late at night and indicates he is looking for employment.

Mrs. KILGORE stated she had met LEE HARVEY OSWALD, known to her as HARVEY OSWALD, on one occasion this being in 1956 when she and her husband lived at 820 Packard Street, Dallas, Texas. She advised her husband went to work for Wales Trucking Company, Dallas, where OSWALD worked at that time and that her husband brought OSWALD hom for dinner on one occasion. She stated she never saw OSWALD again but her husband said later that when he worked at Bilbo Trucking Company, Dallas, OSWALD came in several weeks to get his pay check but did not seem to work there. She stated she recognized the LEE HARVEY OSWALD shown on television in recent days as the HARVEY OSWALD she met once at Dallas.

Mrs. KILGORE advised her husband had received a head injury while working for Bilbo Trucking Company at Dallas and had also been hit on the head several times while working in the oil fields. She stated he also suffers from a bad back condition and has difficulty holding employment. She advised that he is rational most of the time but on occasion appears to have spells when he seems to be "out of his mind". She stated she did not think he would intentionally furnish false information, but that he may be angry with BILBO because BILBO fired him from his job and reportedly told an employment agency at Austin, Texas, that KILGORE stayed drunk. She stated her husband always seems to feel that when he loses a job it is because

ROBERT LAWRENCE MELLER, 4703 Freret Street, advised he resides in the upstairs apartment at this address and has a telephone number 899-8631. He advised that at this time he is employed part time with television station WYES and also Motion Picture Advertising, 1032 Carondelet Street. HELLER stated that he is not personally acquainted with LEE HARVEY OSWALD as he has never met this individual, however, some time during the month of August, 1963, he was at the location on Canal and Carondelet Streets when he observed OSWALD handing out leaflets for Fair Play for Cuba. At this time he observed that OSWALD was being "pushed around" by several male individuals he identified as Cubans and that these individuals were actually taking the leaflets from OSWALD and destroying same and causing a considerable disturbance. As a result of this disturbance, OSWALD was arrested by the New Orleans Police Department and he believes was taken to jail. HELLER advised that he is unable to give the specific date of OSWALD's arrest at this time but believes this can be checked with the New Orleans Police Department. He is of the opinion that this was some time during the month of August, 1963.

As a result of this arrest he contacted attorney JACK NELSON and advised him of OSWALD's predicament because he felt OSWALD would probably be needing an attorney in this instance. He advised that he is not aware of what action, if any, NELSON may have taken in connection with OSWALD. HELLER advised that this was the only occasion he has ever seen OSWALD and has no further information as far as OSWALD is concerned.

At some time in July, 1963 she received a long distance call from a Mrs. RUTH PAINE in Irving. Texas. Mrs. PAINE said she had gotten Mrs. KLOEPFER's name from a Mrs. BLEANOR/HAMMOND, 1202 Bandera Lane, Garland, Texas. Mrs. KLOEPFER knew Mrs. HAMMOND to be a Quaker and active in the Friends Meeting Group. Mrs. PAINE wanted to ask a favor of Mrs. KLOEPFER, going on to say she would like Mrs. KLOEPFER to visit a Mrs. LEE OSWALD at 4907 Magazine Street. Mrs. PAINE identified Mrs. OSWALD as a friend of Mrs. PAINE who has having domestic trouble and feared her husband might send her back to Russia. Mrs. PAINE wanted Mrs. KLOEPFER to find someone who could speak Russian in case Mrs. OSWALD, who was about to have a baby, needed help. Mrs. KLOEPFER agreed to do this but did not do so as soon as she had anticipated.

About two or three days later she received a second long distance call from Mrs. PAINE. She told Mrs. PAINE she had not been to see Mrs. OSWALD as yet. Mrs. PAINE stated that was fine because in the meantime she had received a letter from Mrs. OSWALD who informed that Mr. OSWALD had returned, that they were not separating, and that Mr. OSWALD was not sending her back to Russia. She promised Mrs. PAINE she would visit Mrs. OSWALD anyway to see if she could help.

She then received a letter from Mrs. PAINE which was dated July 18, 1963 and with which was included a copy of a letter Mrs. PAINE had written to Mrs. PAUL BLANCHARD. Mrs. KLOEPFER furnished these two letters and they read as follows:

"Dear Ruth Kloepfer -

"The enclosed speaks for itself. I don't know, of course, whether Mrs. Blanchard is on vacation, or will get this letter promptly. I have only her home address, which might go to her directly on Saturday, but on Menday she would be at the Unitarian Church (I

"As you see, I feel finding a Russian speaker is very important not only to get the present news, but to act as a contact for Marina should she need emergency help. I doubt one year of college Russian would be sufficient, although your daughter would probably find contact with Marina rewarding. What they could say to each other, however, would be severely limited.

"I very much appreciate your taking interest in this matter.

"Dear Mrs. Blanchard,

"Mrs. Philip Harper, the secretary at the Dallas Unitarian Church suggested I write to you when I told her of the following problem.

"I have a girl friend in New Orleans whom I have not heard from for over a month. She is from the Soviet Union and came to this country over a year ago with her husband, an american whom she met and married there.

"Marina's contact with speakers of English has been small and she still speaks and understands very little in English. (She and I speak and correspond in Russian.) Her last letter stated that she thought "she might have to go back to the Soviet Union, something she would prefer not to do. But she and her husband have not been getting along, and he has said that he would like her to go back. They have a baby girl 12 years old, and are expecting a second child in October. Marina's last letter also stated that she has not been able to make contact with any Russian speaking people in N.O.

"Frankly, I'm worried. I have no way of calling them and getting current information directly. I would like to ask you to seek a Russian speaking person there who would be able to go and visit with Marina, thereby making contact for her with someone of the N.O. Russian community. With such a contact she could seek help if she needs it.

"Yesterday evening, in my concern, I telephoned Mrs. Ruth A. Kloepfer (Mrs. Warner) 306 Pine Street; New Orleans 18, UN 6-0389. She is clerk of the N.O. Friends Meeting. (Quakers) I asked her also to look for someone who could speak Russian and go to visit Marina. She could not think of anyone she knew who could speak the language, but said she would go. It is a great kindness on her part to do this. She does not know me any more than you do.

"Marina's full name and address is: Mrs. Lee Oswald, 4907 Magazine, N.O. It is my impression that this address is not far from your church.

"If you would be so kind, please call Mrs. Kloepfer and see if she has any news. I am asking for your help in addition to hers because of her mention that she knew no one in the Russian community. Perhaps between you you can find some Russian speakers. There must be quite a few in N. O. The language barrier is very real; I don't believe Marina would be able to convey much to a person speaking only English. (Russian is her only language.)
