On December 12, 1963 Marie Donnelly, who was born April 1, 1907 at Cincinnati, Ohio and who resides alone in a house trailer at 4535 Telephone Road, Houston, Texas upon interview advised as follows:

She has no concrete proof who hired Lee Oswald to kill President Kennedy. She stated President Kennedy and Arthur Godfrey, prominent television figure, have been sending individuals from Washington, D. C. to assist her in getting out of Houston, Texas. However, representatives of the Harris County, Texas Sheriff's Office, according to Mrs. Donnelly, have prevented these individuals from helping her. She further advised she spends every penny she can on postage stamps in order to write various organizations in Washington, D. C. requesting help which will enable her to get out of Houston, Texas.

Dear Mrs. Schell:

I have received your letter of December 9th and can understand the concern prompting your communication.

In response to your request about watching Lee Harvey Oswald on the day of the assassination of President Kennedy, I would like to explain that as a Federal investigative agency, it is our obligation to disseminate information coming to our attention which indicates potential danger to the President or his family. The Secret Service is charged with protecting the President and the FBI promptly advises that agency of any data within our possession pertinent to this responsibility. But the data we had regarding Oswald gave absolutely no clue indicating he was a potential assassin.

With respect to your inquiry concerning "Common Sense," information contained in the files of the FBI must be maintained as confidential in accordance with regulations of the Department of Justice and is available for official use only.

I am enclosing some literature which I trust will be of interest to you.

On December 11/63, information was received from the Secret Service, Washington, D. C., that during an interview of Robert Lee Oswald by the Secret Service on 11/25/63, Robert Oswald indicated that he recalled going rabbit and squirrel hunting with subject and his brother-in-law. He indicated he believed such hunting trip occurred after subject's release from the Marine Corps. You should recontact Robert Oswald and attempt to pinpoint the date when such hunting activities took place. You should also ascertain whether subject possessed his own gun and, if so, you should attempt to ascertain what disposition, if any, of such weapon was made by subject.

For your added information, the Secret Service has also informed the Bureau that in an interview of John Edward Pic, half-brother of the subject, by the Secret Service and an agent of the Office of Special Investigations, Air Force, on November 22, 1963, Pic stated that he visited his brother, Robert, on Thanksgiving Day, 1962, in Fort Worth, Texas. Pic added that he and Robert discussed the un-American beliefs and activities of Lee Harvey Oswald and that Robert informed him, Pic, that the FBI had visited him and had assured him that Lee Harvey Oswald was alright and not dangerous to his country and that he, Robert, need not worry about him.

During your interview with Robert Oswald, you should ascertain if he made such statements to John Edward Pic. If Robert states he made such statements, you should obtain complete details from him concerning such interview by the FBI including the approximate date of the interview and the identity of the FBI Agent who allegedly made such statements to him.

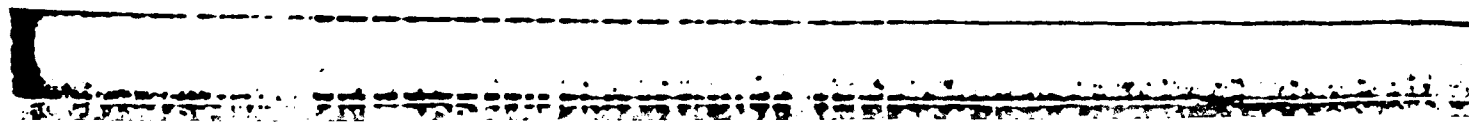

LEE THAT DURING SUMMER OF FIFTYNINE, SHE VISITED HER NEPHEW, HENRY ROUSELL AT SANTA ANNA, CALIFORNIA, WHERE ROUSELL STATIONED WITH USMC. QUINN STAYED AT SANTA ANNA IN PRIVATE BOARDING HOUSE FOR ABOUT TWO MONTHS. DURING HER VISIT, ROUSELL ASKED HER IF SHE WOULD ACCOMPANY LEE HENRY OSWALD, A POLYGLOT RUSSIAN, ON A DATE AS OSWALD WAS TEACHING RUSSIAN. DELGADO DID REPORT OSWALD APOS. A RECEIPT OF RUSSIAN LANGUAGE NEWSPAPER TO LIEUTENANT D. PADRO, BUT DOES NOT KNOW WHAT WAS DONE. DELGADO SAID THAT HIS REASON FOR SUGGESTING CONTACT WITH CUBAN CONSULATE WAS AS A RESULT OF A DISCUSSION WITH OSWALD WHEREIN OSWALD INDICATED HE REALLY WANTED TO HELP CUBA. DELGADO SAID THAT HE WROTE DOWN THE ADDRESS OF THE CUBAN EMBASSY, WASHINGTON, D. C., ON THIS OCCASION AND SAID TO OSWALD THAT HE SHOULD WRITE TO THIS ADDRESS IF HE REALLY WANTED TO FIND OUT WHAT HE COULD DO.
