SHORTY stated that on Monday, November 18, 1963, while in the Wayside Inn, Lawrence and Clark Streets, he overheard a conversation between three Puerto Rican looking persons. These persons were discussing "how to overthrow the President of the United States and the President of the Dominican Republic. SHORTY engaged the three individuals in conversation and they told him that they were from the Dominican Republic.

SHORTY could give no further background information concerning the three unknown persons and stated that he had never seen them before or since.

On November 22, 1963, an individual who would identify himself only as "SHORTY", but who was later identified as RICHARD VINCENT LOEBSACH, was interviewed in Simon's Tavern, Clark and Foster, Chicago, Illinois. LOEBSACH stated on Monday night, November 18, 1963, while drinking in the Wayside Inn, Lawrence and Clark Street, he observed three individuals who were speaking in Spanish discussing plans to assassinate the President of the United States, JOHN F. KENNEDY, and the Governor of Texas. LOEBSACH said he cannot speak Spanish but can understand enough Spanish to know that this is what they were discussing.

According to LOEBSACH, the three men were later joined by two women all of whom continued to talk in Spanish. LOEBSACH said he engaged the five in conversation at which time they said they were from the Dominican Republic and then called him "a sawed off runt". LOEBSACH said he then called the FBI in Chicago and that the FBI sent two Agents to the Wayside Inn who arrested two of the men and one woman but that the other man and woman escaped.

LOEBSACH was unable to furnish a description of any of the three men or two women.

LOEBSACH said that the one individual who appeared to be the leader could speak Russian, German, French, English, Spanish and a little Italian.

LOEBSACH said he has no address or telephone number and can only be contacted through the PM Club, 2049 West Howard Street, telephone HO 5-9311 or HO 5-9795. LOEBSACH said two days a week he acts as a porter at the PM Club and the remainder of time he spends as a private detective and is on surveillance almost constantly. LOEBSACH was under the influence of liquor when interviewed and appeared to be unstable.

COY HOOD is employed by the Ekco Company on its third shift, which is from 12:01 a.m. until 8:00 a.m., and his work week starts at 12:01 a.m., Monday morning.

HOOD worked the week of November 18, 1963, up until 8:00 a.m. on Thursday morning, November 21, 1963. The plant record indicated that HOOD did not work on November 22, 1963, because of illness.

RUNGE advised that HOOD's supervisor was OSCAR SAGER, 4831 West Cortland Street, Chicago.

SAGER stated that HOOD had been injured on Thursday, November 21, 1963, and had been sent home and instructed to obtain medical care for a steel splinter in his eye.

SAGER said that HOOD reported for work at 12:01 a.m., Friday, November 22, 1963, but that he, SAGER, had sent HOOD home because it was obvious that he was in no condition to work because of the condition of his eye. SAGER said that HOOD did not return then for work until 12:01 a.m., November 25, 1963.

COY EDGAR HOOD, 325 South Kilpatrick Avenue, Chicago, Illinois, advised that during the early morning of Thursday, November 21, 1963, while employed at the Ekco Products Company, he was injured by getting a steel particle in his right eye.

HOOD stated that he was sent home and instructed to contact a doctor and receive treatment prior to returning to work the next night.

HOOD exhibited a bill for medical care, for his eye in the amount of \$10, which bill was dated November 21, 1963, from Dr. JAMES D. WALSH, 28 Madison Street, Oak Park, Illinois.

HOOD advised that he had received this medical treatment for his eye at about 12:00 noon on Thursday, November 21, 1963, and had spent the remainder of Thursday resting at home. He advised that he reported for work at 12:01 a.m., November 22, 1963, but was sent home because the injury to his eye was such that he was not suitable for work on that day.

HOOD advised that he spent all day Friday in his apartment at the above address and in the apartment of CHESTER BREWINGTON, also at that address.

TOM PAPPAS, who states he runs a restaurant at 3155 West Harrison, resides at 1614 North Central Avenue in Chicago, telephonically advised he had important information concerning the assassination of the President but would not discuss same over the telephone. He made vague references to the fact that "letters" had been sent to Washington by himself three weeks ago and had been unanswered to date.

In an attempt to ascertain just what PAPPAS had in mind, efforts were made to get him to explain the nature of his information; however, these attempts were made with negative results. Arrangements were made with PAPPAS to have him contacted at his restaurant during the day on November 25, 1963. He stated he arrives at work at 7:30 in the morning and his restaurant is open until 7:00 P.M. each day.

On November 25, 1963, SAs VERNON G. SMITH and RUSSELL R. GIRSCH contacted ATHANANASOS GEORGE PAPADOPOULOS, also known as TOM PAPPAS, at his place of business, Andy's *Chicago* Restaurant, 3156 West Harrison Avenue, at which time he advised *Ill* that his true name is ATHANANASOS GEORGE PAPADOPOULOS and that he came from Greece October 4, 1959. He stated that since coming to America he has shortened his name to TOM PAPPAS.

Mr. PAPPAS advised that in October, 1963, he had several dreams at which time an old man appeared and instructed him to warn the president that his life was in danger. He stated that as the dream continued night after night, he wrote a letter to the president. He was at a loss to understand why he would have such a dream. He stated that he knew of no one that would want to kill the president. He stated that the day of the shooting of the president he saw a vision of the president and his wife dressed in white robes and that Mrs. KENNEDY was pushing the president to the floor.

Mr. PAPPAS stated that he has been working twenty hours a day, seven days a week at his restaurant and was unable to sleep while he was having the visions.

GREENBERG said his daughter advised him that an anonymous person stated "are you listening to that devil speak? He is going to die too." The caller terminated the call without further comment.

Mr. GREENBERG stated he felt the information should be called to the attention of authorities even though he was of the opinion it was a "crank call".

Miss GREENBERG, age 19, is a political science major, Sophomore, at the University of Wisconsin, Madison, Wisconsin. She advised she has been so emotionally upset as a result of the death of President KENNEDY, she cut classes at the University and returned to her parents' home at Chicago, Illinois, for the remainder of this week. Her family consists of CHARLES T. GREENBERG, father, ROSALYN GREENBERG, mother, and DONNA GREENBERG, sister.

She stated her radio was tuned to President JOHNSON's speech before the Joint Session of Congress this AM when her private phone rang at approximately 11:45 AM. She answered "hello" and a voice not familiar to her stated "can you hear that devil speak? He's going to die too." The unknown person immediately terminated the call.

Miss GREENBERG stated she could overhear a voice in the background of the conversation which she assumed to be a radio or television broadcast of the same speech. She could not be certain the conversation was directed to her or whether she had overheard a portion of another conversation.

The family phone is listed as PL 2-8515; however, Miss GREENBERG claims only a few of her close friends at the University of Wisconsin have her private phone number MI 3-7906, where the call was received.

She is of the opinion the call was not intended for her or the GREENBERG residence.

On November 30, 1963, Investigator, WILBERT FORTUNE, Criminal Investigations Detachment, Office of the Provost Marshal, Fort Sheridan, Illinois, advised SA ROBERT K. MC QUEEN as follows:

SP/4 DONALD LESTER HUMMER, U.S. 55-709-285, arrived at Fort Sheridan, November 29, 1963, for honorable discharge December 5, 1963, and is assigned to the Transfer Section.

During the early morning hours of November 30, 1963, he was found in a ditch at Zion, Illinois, in a heavily intoxicated condition by the Zion Police Department, who took him to the Zion Community Hospital. At the hospital he informed he was a soldier, and at about 7:00 AM, November 30, 1963, he was transferred to the U.S. Naval Hospital, Great Lakes, Illinois, where he was examined, found to be intoxicated, complained of soreness in his right shoulder and found to have an abrasion back of the right ear. The head nurse, Mrs. M. CHICHON, Zion Hospital informed Warrant Officer C.W. HERRINGTON, Chief Master at Arms, U.S. Naval Hospital, that while at the Zion Hospital, HUMMER had said that he was "married to a JOANN, that he shot the President yesterday, no, I mean Friday". Asked where he shot him from he said, "the art building". Asked what kind of a gun he answered "deer rifle". Asked what he did with the gun he said he "left the gun on some boxes". Asked why he did this he said, "I did not like KENNEDY". FORTUNE said HUMMER was released from U.S. Naval Hospital and transferred to Fort Sheridan, Illinois, where he was now sober and apparently thinking clearly.

Voucher number 600967 in the amount of \$67.38 for advance of travel pay to Fort Sheridan from Fort Hood, Texas, was paid to HUMMER who stated this was the voucher upon which he was paid between 12:50 and 1:30 PM, November 22, 1963, at the Finance Office, Fort Hood, Texas. It reflected that he was paid by R.J. PREUSS, Major, Finance Center, First Armored Division, Serial Number 6450, Fort Hood, Texas, in November, 1963. Certification date by his personnel officer was November 14, 1963, and actual date of payment is not reflected on his copy of the voucher. HUMMER said that he understands the date of November 14, 1963, would be the date that the payment was authorized and the voucher was sent to the Finance Office for processing.

DONALD LESTER HUMMER, Transfer Section, Fort Sheridan, Illinois, was advised of his right not to make a statement, that anything he said might be used against him in a court of law, and of his right to an attorney. He thereupon advised SA ROBERT K. MC QUEEN as follows on November 30, 1963.

He entered the Army on December 6, 1960, at Detroit, Michigan, and was assigned to the Service Battery, First Battalion, 73rd Artillery, First Armored Division, at Fort Hood, Texas, since February, 1961.

He was to be transferred to Fort Sheridan, Illinois, on November 25, 1963. He was to draw travel pay of \$67 and some cents prior to departure, and on Friday, 12:30 PM, November 22, 1963, at Noon Muster, was directed by the First Sergeant of his company (First Name Unknown) NOVENCIDO to proceed to the Finance Office and draw his advance travel payment. Accompanied by his assistant truck driver, SP/4 ARLEN MIZELL, same company, he drove to the Finance Office where MIZELL waited in the truck outside, while he stood in line to obtain said pay. He was standing in line at about 12:50 PM when he heard over the radio that the President had been shot. He remained in line until about 1:30 PM, when he was actually paid, and returned to work for the rest of the day, later learning of the President's death. He spent Friday night, Saturday and Sunday in or near Fort Hood and left Monday morning for Fort Sheridan via his mother's home in Roseville, Michigan, arriving at Fort Sheridan at about 4:00 PM, November 29, 1963.

HUMMER stated that he has never been in a mental institution and never has been under the care of a psychiatrist. He said that he drinks alcoholic beverages rarely and loses control of himself when he does. He said he left Fort Sheridan with a soldier named (First Name Unknown) HOPPE, also transferred to Fort Sheridan for discharge, from Fort Hood, late afternoon of November 29, 1963, but instead, they started drinking. He recalls drinking at several taverns and of HOPPE's departure at the third tavern on HOPPE's statement that he would get a ride back to the post in some unrecalled

fashion. He recalls becoming more and more intoxicated at a hillbilly tavern and the next thing he recalls is being in an ambulance en route to the hospital, later discovering his wallet was missing. He said he cannot recall making any statements with regard to President KENNEDY's assassination, although he does vaguely recall claiming to have a wife and child which is not true. He said he bore no animosity toward President KENNEDY and was greatly shocked at his assassination and knew absolutely nothing about it nor had he ever had any contact with OSWALD. His knowledge of the assassination was obtained mostly through listening to the radio en route from Fort Hood, Texas, on Monday, November 25, 1963. He said he is deeply aware that to make such a statement even in jest would be completely wrong under these circumstances.

HUMMER said his whereabouts on November 22, 1963, can be corroborated through the Finance Office at Fort Hood and through his fellow soldier, ARLEN NIZELL, as well as other members of his company, should that be necessary.

The following description was obtained through interrogation and observation:

White male American, born February 21, 1938, Detroit, Michigan, 5'8½", 180, stocky build, dark brown hair, brown eyes, tattoo of "DON" on left forearm, 9th grade education, father, deceased, mother, EDNA HUMMER, 20400 Voyland, Roseville, Michigan, marital status, single, arrested February 21, 1959 and February, 1961, for drunk and disorderly, Mount Clemens, Michigan, both suspended.

FRED FRANKEL, Owner, Statistical Sales Promotion, 179 Washington Street, Room 215, Chicago, Illinois, on November 25, 1963, advised that MICHAEL CAIATI, was employed by him as a salesman selling mailing lists which furnished various types of business firms with the listings of people moving from city to city. He advised CAIATI was paid only on commission.

He advised that MICHAEL CAIATI departed the Dallas, Texas, area on November 13, 1963, for the San Antonio area. He advised on November 22, 1963, between the hours of 4 and 5 P.M., that he received a collect long distance telephone call from CAIATI which originated in the Corpus Christi, Texas, area. He stated he received a letter postmarked November 20, 1963, from CAIATI from Corpus Christi, Texas. He advised CAIATI was due to arrive in Houston, Texas, on November 25, 1963, and would pick up his mail at General Delivery, Main Post Office, Houston, until such time as he established residence in a hotel or motel. *III.*

FRANKEL described CAIATI as a white male of Italian extraction, 165 pounds, 5'9", black hair, thinning on top, medium complexion, and about 38 years of age.

He advised CAIATI formerly was employed as a car salesman by the Holiday Lincoln Mercury, 535 Chicago Avenue, Evanston, Illinois.

FRANKEL advised CAIATI resided at Sandy Shores Motor Hotel, Corpus Christi, Texas, during his stay that area.

WILLNER admitted that he was source of rumor which got around wherein a payoff was allegedly made to OSWALD and/or RUBY in Chicago in connection with the assassination of President KENNEDY. WILLNER advised that no one person was source of this information. After the assassination of President KENNEDY, a number of people, including patrolmen on the Chicago Police Department, contacted him with tidbits of information and ideas. He stated he received information that there had been a Cuban Committee that had been active in Chicago and one individual, whose identity he cannot recall, suggested to him that perhaps the Cuban Committee had been behind the assassination. *Ill*

According to WILLNER, as a result of all the information he had gleaned concerning the assassination of President KENNEDY, he concluded there was a good possibility there had been money paid to OSWALD or RUBY to provide for the assassination. He did not have any facts to back this up and he passed this analysis of his own to HANSEN, "Chicago Daily News" reporter covering the Dallas story, to see if he could secure any corroboration of the theory that there had been a payoff in Chicago.

WILLNER stated he was unable to get any corroboration of his theory and, therefore, did not print this story. He stated he still feels, although he does not have facts to back it up, that there could very likely have been such, as he does not believe that either OSWALD or RUBY acted spontaneously and on their own. He stated had he secured anything to corroborate this theory of his, he would have published it in the paper. He could not give the identity of any person who suggested this theory to him and feels that this conclusion was arrived at by him as a result of all of the information reaching him.

During the night of November 23, 1963, the Chicago Office received approximately 18 to 25 calls from various individuals who described themselves as businessmen, professor, Northwestern University, housewives, citizens, etc., and expressed great concern over the following:

They all indicated grave concern (in varying degrees) that the death or assassination of the President may have been a deliberate act for the purpose of getting all of the top officials of the United States executive branch, U.S. Armed Forces, SAC, United Nations, Congress, Leaders of the Free World, all under one roof. Specifically, it was cause for concern that on Monday, at the time of the funeral, all of the major important people in the Free World, and certainly of the United States, will be at St. Matthews Roman Catholic Church in Washington, D.C. They feared (all appeared to be sober, responsible citizens) that a bomb, missile, or other explosive directed at the Church or Washington, would succeed in placing the free world in complete chaos, and would permit the Communist world to take over the free world without destroying it.

Some indicated that although the assassin may have operated without direction, that since the assassination, the powers opposed to the Free World could not but help to see the opportunity of wiping out the constitutional form of the U.S. Government, as well as foreign leaders of the Free World, by merely concentrating on Washington, D.C., next Monday. All felt that at no other time in history would such an opportunity possibly present itself.

They expressed concern that Cuba could launch a missile, a submarine laying in the Atlantic, or a well organized group in Washington or perhaps a single bomber launched from U.S. or nearby territory.

They indicated that although it is likely that the U.S. officials have considered this possibility and are taking all precautions, it is conceivable that with the new administration and all the deep sorrow in the world, they may

overlook the unique opportunity that those opposed to the U.S. or the Free world will have Monday. They indicated that they would feel better if prominent members of the Communist world would also be present in D.C., but it appears that only expendable Communists will be with our leaders.

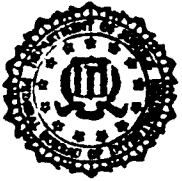

Special Agent D. B. Flohr, U. S. Secret Service, on 12-9-63, requested that the U. S. Secret Service be furnished with a copy of Ruth Paine's address book, which he was led to believe was in the possession of the FBI Laboratory.

The Dallas Police Department obtained various items believed to belong to the subject and his wife at the residence of Ruth Paine in Irving, Texas, on 11-22-63, where Mrs. Oswald had been residing. These items were subsequently turned over to the FBI. One of the items, number 330, listed on the inventory prepared by our Dallas Office is described as an "address book", which is possibly the book desired by the U. S. Secret Service.

Mr. E. T. Turner of the Domestic Intelligence Division has advised that our Dallas Office is in the process of determining the ownership of this book and we expect an early reply. Item number 330, is currently in possession of Mr. R. A. Frazier of the Laboratory Division.
