The following investigation was conducted to obtain information about travel OSWALD may have performed on or about September 26, 1963, and October 3, 1963.

Date December 7, 1963

Mr. ROBERTO SANCHEZ, Trans-Texas Airlines, Laredo, Texas, advised that the following persons boarded Trans-Texas Airlines at Laredo, Texas, on Flight 290 on October 3, 1963. Flight 290 departs Laredo, Texas, at 7:20 a.m. enroute to San Antonio, Austin, Fort Worth, and Dallas, Texas.

1. L. W. GRAHAM. Reservations made on September 30, 1963, from "El Cortez" Motel, Laredo, Texas. GRAHAM was enroute from Laredo, Texas, to Oklahoma City, Oklahoma.
2. C. ERVING. Reservations made in San Antonio, Texas, and this person came to Laredo from San Antonio by automobile and returned to San Antonio by Trans-Texas Airlines, one-way ticket.
3. Mrs. W. P. PEARSON. Reservations made on September 30, 1963, from Randolph 2 1614. Mrs. PEARSON was enroute to St. Louis, Mo. via Dallas, Texas.
4. S. C. SCIBIENSKI. This person left Laredo, Texas, on the October 3, 1963, flight for Lubbock, Texas, and returned to Laredo, Texas, on October 5, 1963.
5. E. H. BORCHERS. Departed enroute to Austin, Texas, and return to Laredo, Texas. Telephone Randolph 3 6244 (well known Laredo attorney).
6. (FNU) NIETO. Serviceman with copy of orders and was traveling to San Antonio, Texas, enroute to air base in that city.
7. E. JURGENSEN. Made reservations from the Siesta Motel, Laredo, Texas, and was enroute to Dallas, Texas.

11. H. VILLARREAL. Came to the airport on the morning of October 3, 1963, and purchased a ticket to San Antonio, Texas (no additional information available).

ROBERTO SANCHEZ, Trans-Texas Airlines, advised that Flight 291 departs Laredo, Texas, at 12:08 p.m. enroute to Houston, Texas, via the Rio Grande Valley. This flight picked up one passenger at Laredo, Texas, on October 3, 1963.

This passenger was H. R. HUNTER who used an Eastern Airline ticket as part-payment of his fare and this ticket was Eastern Airline Ticket Number 526 from Houston, Texas, to San Antonio, Texas.

ROBERTO SANCHEZ, Trans-Texas Airlines, furnished the passenger list for Trans-Texas Airlines Flight Number 292 that departs Laredo, Texas, at 6:44 p.m. enroute to San Antonio, Austin, Fort Worth, and Dallas, Texas. This flight arrives in Dallas, Texas, at 9:35 p.m.

The passenger list is as follows:

SANCHEZ stated that the above is the complete list for October 3, 1963, and that a check of passengers for October 2, 3, and 4, 1963, under the name of LEE HARVEY OSWALD or his aliases failed to reflect anyone by that name boarding an airplane in Laredo, Texas, at Trans-Texas Airport. SANCHEZ viewed a photograph of OSWALD and JACK RUBY and stated he had not seen either person at the Trans-Texas Airport which is the only commercial airport in Laredo, Texas.

AT SAN ANTONIO, TEXAS

The following drivers of Greyhound buses who drove buses out of Laredo, Texas, on October 3, 1963, en route to San Antonio, stated they had no recollection of having had LEL HARVEY OSWALD or anyone fitting his description on their buses on October 3, 1963, nor at any other time. After viewing photographs of OSWALD they advised that they do not know this individual and did not observe him at any time at any place:

On December 6, 1963, RAUL TILJERINA, Tex Baggage Agent, Greyhound Bus Terminal, advised that he was on duty as Ticket Agent at the Greyhound Bus Terminal, Laredo, Texas, from 12 midnight to 8:30 a.m., on Thursday, October 3, 1963. He stated, after viewing photographs of OSWALD, that he does not know this individual and does not recall seeing him at any time at any place.

Date December 11, 1963

BUFORD McCARTER, Greyhound Bus Driver, residence 129 Palm Street, advised he was on duty on October 3, 1963, and according to his log book he left Laredo, Texas, on 11:45 a.m., arrived in San Antonio at 3:00 p.m. He left San Antonio at 6:30 p.m., and arrived in Laredo at 10:15 p.m. He stated he had no recollection of seeing LEE HARVEY OSWALD or anyone fitting his description in his bus or at any of the terminals between Laredo and San Antonio, Texas, on that day.

San Antonio, Texas

McCARTER upon viewing photographs of OSWALD, stated that when he first saw OSWALD on television following the assassination of President KENNEDY, and also when he first saw photographs of him in the newspapers, he told his wife that OSWALD in some respects resembled a passenger he carried in his bus sometime during about July or August, 1963, from San Antonio to Laredo, Texas. He related the individual who he was referring to, got off the bus at Willey, Texas, at 8:15 p.m., and watched the unloading of baggage from his bus for passengers who transferred to the Winter Garden bus en route to Eagle Pass, Texas. After the unloading of the baggage was completed the man resembling OSWALD asked McCARTER if he would have a cup of coffee with him and they did have a cup of coffee in the Don Jones Cafe. McCARTER stated to the best of his recollection the man was by himself, was not wearing a cap or hat, had dark hair and did not carry anything in his hands when boarding and leaving the bus. He wore a sport shirt, pair of slacks, color not recalled, and wore shoes rather than boots. He last saw the young man who he could describe only as about 20-22 years of age, 5'6" tall, weighing about 130 pounds, when he was walking around in the bus station at Laredo, Texas. When he last saw him the man was by himself. He recalled the man was smoking cigarettes but could not recall the brand.

Mr. McCARTER concluded by stating that he had no conversation with the man in which the man identified himself and since several months had elapsed he was not at all certain that this man actually resembled OSWALD as much as he had first thought he did.

Upon viewing a photograph of LEE HARVEY OSWALD, she stated she has never seen this individual and she positively did not see him on September 26, 1963, either at Mexican Immigration Station, or anywhere else.

TED C. BLAND, 514 McKenzie Street, advised that he left Hillsboro, Texas, in his 1956 yellow and black Cadillac automobile on a Wednesday believed by him to be September 25, 1963, and drove to Laredo, Texas. He advised that he spent the night in Laredo and then crossed the border at Nuevo Laredo on the following day which would have been Thursday, September 26, 1963. He advised that he was involved in crossing the border from approximately 11:00 a.m. to about 1:00 p.m. on that date. He explained by stating that he had a .22 rifle in his car at the time and that as a result of having the gun in his car he was sent from Mexican Customs Office to a representative of the Mexican Army who then sent him back across the river into Laredo where he contacted the Mexican Consul, American Customs and then finally went to a gun store in Laredo, Texas, where he paid \$2 to have the .22 rifle shipped to his home in Hillsboro, Texas. He advised that he drove on from Laredo, Texas, to Monterrey, Mexico, on September 26, 1963. He advised that he did not recall any individuals being involved in crossing the border at the same time that he was crossing and that he certainly did not recall having seen anybody at the border crossing on that day who resembled OSWALD's photograph. He advised that he did recall being passed by a late model Chevrolet automobile, color red, driven by a young man between Nuevo Laredo and Monterrey. He advised, however, that he did not see this individual well enough to know whether or not he resembled OSWALD's photograph. He advised that he returned to the United States at Zapata, Texas, on about September 28, 1963.

The following investigation was conducted on September 5, 1963, at Austin, Texas, by SA H. T. BURK in an effort to locate or secure information concerning HENRY CLYDE EMERSON or ADRIENNE B. EMERSON.

A check was made of present and past city and telephone directories as well as a call made to Southwestern Bell Telephone Company to see if either of them had a recent listing. No record of either of them was located.

MARTHA HODNETT, Retail Merchants Association, NATHAN DARBY, Identification Division, Austin Police Department, Mrs. THILMA HACKLEMAN, Driver's License Division, Texas Department of Public Safety, CHARLIE KEY, Identification Division, Texas Department of Public Safety, and NELL SAVAGE, City Water and Light Department, all made a search of the records of their respective files and records without locating any record of either of the EMERSONS.

A check was made at the following hotels in Austin, Texas, in an effort to locate either of the EMERSONS:

ROBERTO GONZALEZ, whose permanent address is 250 N. Jacker, Victoria, Texas, advised that on September 26, 1963, he, his mother, his stepfather, and two friends drove to Laredo, Texas, in his automobile, arriving there at approximately 4 p.m., on that same date. They left the car in Laredo and took a taxicab from Laredo to Nuevo Laredo, crossing the bridge shortly after 4 p.m. After clearing Customs, he, his mother and his stepfather, caught a bus to Monterrey, Mexico. Upon arriving at Monterrey, they changed buses and then went on to Saltillo, Mexico, arriving there at approximately 2 a.m., on September 27, 1963. Upon their arrival there they went to a hotel but GONZALEZ did not remember the name of the hotel where they spent the remainder of the night. GONZALEZ advised that there were some Anglo Americans on the bus from Nuevo Laredo to Monterrey, but no one but Latin Americans on the bus from Monterrey to Saltillo. GONZALEZ was shown a photograph of LEE HARVEY OSWALD but advised that he did not see any individual fitting the description of OSWALD while crossing the bridge into Mexico, while clearing Customs in Nuevo Laredo, nor while en route from Nuevo Laredo to Saltillo by bus.

GONZALEZ stated that they stayed in Saltillo the night of the 27th and on the 28th returned to the United States and to their home at Victoria, Texas.

AUSTIN CERRA REYES, Room 324, Continental Hotel, who is self-employed as a musician, playing the guitar and violin, advised that he left San Antonio at 9:30 p.m., on September 25, 1963, and entered Mexico at the Port of Nuevo Laredo between 1:00 and 2:00 a.m., September 26, 1963, in his 1954 Mercury sedan, bearing Texas 1963 license HY 2502. He advised that he made this trip by himself and his destination was Monterrey, Nuevo Leon, Mexico, where he visited his wife and seven children who reside at Matamoros 1043 Oriente. He advised that he left Monterrey about 1:00 a.m. on September 28, 1963, and returned to the United States via the Port at Laredo, Texas, at about 5:00 a.m., on September 28, 1963, and arrived in San Antonio on the same day at about 9:30 a.m.

REYES advised that when he entered Mexico at Nuevo Laredo on the morning of September 26, 1963, there was no one at the Immigration and Customs checking station except the attendants, and he did not observe any hitchhikers or anyone else while enroute to Monterrey who in any way fit the description of OSWALD. Upon viewing photographs of OSWALD, he stated he does not believe that he has ever seen OSWALD in his lifetime.

Mr. RICARDO SANDOVAL who resides at 805 Jean Street, San Antonio, was interviewed at the warehouse of the Jorrie Furniture Company, 1524 West Poplar Street. He stated he is employed by this firm as a truck driver.

SANDOVAL stated that he entered Mexico at the Port of Nuevo Laredo at approximately 1:00 or 2:00 a.m., on September 26, 1963, in his 1954 Ford two-door sedan. He stated he was on this trip by himself and arrived at Anahuac, Nuevo Leon, Mexico, at approximately 5:00 or 6:00 a.m. on September 26, 1963. He stated the purpose of his trip to Mexico was to contact relatives and furnish them transportation to San Antonio, Texas, so that they could attend the funeral of his mother-in-law, Mrs. BERNADA RAMIREZ, of 805 Jean Street who died September 25, 1963, and was buried in San Antonio on September 23, 1963. He advised that he returned to the United States via the Port of Laredo, Texas, at about 4:00 p.m., September 26, 1963. He advised that on this trip to Anahuac and returning to Laredo, Texas, and San Antonio, he did not observe anyone fitting the description of OSWALD, and, after viewing a photograph of OSWALD, stated he had never seen such an individual.

On December 5, 1963, the following individuals were contacted in an effort to identify, locate and interview TIM PRADO CHAPA, however, none were familiar with anyone at Taylor, Texas, by that name:

Mr. J. LINDQUIST, Berchline Lane, Washington Heights, Taylor, Texas, advised that a CHAPA family of Latin Americans with a large number of children have resided on the LINDQUIST farm for a number of years, but were out of town laboring in agricultural pursuits elsewhere. He added that the CHAPAS did not have anyone in their family by the name of TIM PRADO CHAPA. *Texas*

MANUELA GILESQUEZ, 400 South Main, Taylor, Texas, operator of a Humble Oil Station, who is familiar with the Latin American population of Taylor, did not recognize the name TIM PRADO CHAPA. *Texas*

Postmaster DAN HANNON, Taylor, could not provide any information of value. *Texas*

RALEIGH ALMANZA, proprietor, Casino Club, 405 South Main, Taylor, could not recall anyone by the name TIM PRADO CHAPA. *Texas*

NED FAILS, Constable, Taylor, who is a longtime resident of that area did not recognize the name and made a number of contacts, but was unable to develop any information concerning TIM PRADO CHAPA. He advised he would continue to be alert for any information and would advise the FBI of any developments. *Texas*

A. SCHIER, Chief of Police, Taylor, advised that PRADO was unknown to him; no record was located at the Taylor Police Department identifiable with TIM PRADO CHAPA. Chief SCHIER queried several of his officers, but none recognized the name in question. *Texas*
