RE: TRAVEL ON "SS MARION LYKES"
SEPTEMBER TO OCTOBER, 1959

On December 11, 1963, ROBERT F. RADER, General Vice President, Lykes Brothers Steamship Lines, New Orleans, Louisiana, advised the "SS MARION LYKES", operated by his company sailed from New Orleans, Louisiana, on September 20, 1959, with four passengers, including LEE HARVEY OSWALD, Fort Worth, Texas. This vessel proceeded to France. RADER stated he expected most of the officers, stewards, and waiters on this vessel would have become acquainted with the passengers at that time. RADER identified the third mate on the above trip as JAMES L. GRIFFIN and the radio operator as LOVIX M. STEPHENSON.

The following investigation was conducted by
SA CARLOS L. KIRBY, JR.:

AT GALVESTON, TEXAS

On December 18, 1963, LOVIX M. STEPHENSON, 3824 Avenue P, advised he is a retired radio operator. STEPHENSON recalls he worked from approximately August, 1958, until August, 1960, as a radio operator on the "SS MARION LYKES". STEPHENSON stated he made numerous voyages on this ship during the above period but due to the lapse in time, he could not recall the identity of any passengers. STEPHENSON stated that he had observed many photographs of LEE HARVEY OSWALD but that OSWALD's photographs were not at all familiar to him and he had no recollection of ever having seen OSWALD in his life.

AT LA MARQUE, TEXAS

On December 18, 1963, JAMES L. GRIFFIN, residence 2415 Oakland Drive, La Marque, advised that he is presently employed-as Second Mate on the vessel "SS JEAN LYKES".

He stated that he vaguely recalled that he was employed on the "SS MARION LYKES" as Third Mate, number two, on the 8:00 to 12:00 watch in 1959 recalling that this ship sailed to Le Havre, France. He stated that he does not remember any passenger by the name of OSWALD and does not recall the identity of any of the passengers that were aboard the "SS MARION LYKES". GRIFFIN has seen numerous published photographs of LEE HARVEY OSWALD and stated OSWALD's photographs are unfamiliar to him.

On December 24, 1963, JOE BILL EVANS was interviewed aboard the "SS JOHN LYKES" at Pier 10, Galveston, Texas, by SA CARLOS L. KIRBY, JR. EVANS is presently employed as Chief Steward aboard this vessel and his home address is 2130 Loving Street, Houston, Texas.

He stated he was employed as Steward aboard the "SS MARION LYKES" from 1955 to 1960 and recalled that this ship made several trips to France. He stated the "MARION LYKES" carried numerous passengers during his employment and he does not recall the names of any of the passengers. He further advised that he does not recall any passenger by the name of OSWALD.

about 8:10 p.m. he relieved Continental Trailways driver CONRAD
ROBERTS at Beaumont, Texas. He advised the bus was en route to
Houston, Texas from New Orleans, Louisiana, and was bus number
5121.

Mr. HENDERSON advised he drove the bus from Beaumont
to Houston, arriving approximately 10:50 p.m. He advised he
does not recall seeing LEE HARVEY OSWALD aboard this bus.

Mr. HENDERSON advised to his recollection he has
never seen LEE HARVEY OSWALD.

Enclosed herewith is a replica sack made by SAs BARDWELL D. ODUM and GIBBON E. MC NEELY at the Texas School Book Depository building on December 1, 1963, from paper and tape available in the shipping room of the Texas School Book Depository.

The original sack found on the sixth floor of this building on November 22, 1963, and believed to be the sack in which OSWALD carried the rifle into the building on November 22, 1963, was in possession of SAs ODUM and MC NEELY at that time and the replica sack was made to approximately the same size and as nearly as possible in the same manner as the original sack.

This replica sack has been shown to witnesses primarily to convey the true color of the original sack, its color being changed by chemical processes during treatment to develop latent fingerprints.

It is requested that you make a comparison between the replica sack and the original sack to determine if they are made with the same weight and type of paper and gum tape, and if the paper and tape is the same color as, that used in the original sack.

Please return the replica sack to the Dallas Office when your examination is complete.



JAMES MURPHY visited Salvation Army, Chattanooga, Tennessee, Men's Transit Dormitory, few occasions, last such visit August 29, 1963, for one night. Limited background information and name of sister set forth. JOHN HOWARD BOWEN reported formerly Director of Campfire Council, Knoxville, Tennessee, June, 1938, to Spring, 1943. Source stated knew nothing derogatory concerning BOWEN's loyalty and stated BOWEN was [redacted] and for this reason let out of boys' work, Knoxville. BOWEN reported to be at least 80 years of age. Reported to have gone to Mexico when leaving Knoxville in 1943 and to have performed missionary work among Mixteca Indians. Knoxville newspaper articles reflect in 1953 BOWEN reported residing Laredo, Texas. According to news articles, BOWEN had served as a missionary in India prior to coming to Knoxville and active in missionary work since 1910. Photographs from newspaper morgue being obtained. Source states no known relatives or acquaintances residing Knoxville. No record Knoxville PD or Knoxville Credit Bureau. Article in Knoxville Journal, November 14, 1963, reported BOWEN left New York November 13, 1963, for speaking tour in England, Spain, Portugal, and Italy, having been invited by evangelical groups of each country.

On April 27, 1957, application for employment Olan Mills Portrait Studios was partially executed in name JAMES FREDERICK MURPHY, Social Security Number 488-42-7335, white male, date of birth June 16, 1936, 5' 10", 150 pounds, permanent address Humboldt, Tennessee. Application was for position as salesman with sales crew in State of Virginia. No indication where application was executed but had to have been filed with crew chief in Virginia. MURPHY listed mother as being deceased, did not comment on other relatives. Listed high school education but did not indicate school or date. Only employment listed was himself as salesman, no address. No other information appeared on the application.

MURPHY was employed with sales crew of Olan Mills Portrait Studios, traveling in Virginia, April 22, 1957, termination date not listed. Crew Chief was JULIA DOOLEY. MURPHY was hired January 13, 1958, sales crew in Kentucky, Crew Chief CHARLEY YOUNG, 414 Bonna Wood Drive, Hermitage, Tennessee, Sales Manager, Kentucky and Tennessee. Resigned April 7, 1958. Rehired January 12, 1959, Sales crew Kentucky and Tennessee, Crew Chief CHARLEY YOUNG. Resigned May 23, 1959. Notation, unable to get along with crew members, unsatisfactory. Rehired April 6, 1960 with sales crew Kentucky and Tennessee, crew chief CHARLEY YOUNG. Separated June 18, 1960. Rehired October 17, 1960, sales crew Kentucky, crew chief CHARLEY YOUNG. Released February 25, 1961, services unsatisfactory, would not rehire. Notation, cannot pay hotel bills.

Miss PENNY advised CHARLEY YOUNG's sales crew does not work Chattanooga, Tennessee, and from a review of the file it does not appear MURPHY ever appeared in Chattanooga, Tennessee, with this company either when filing application or for re-employment.

A letter appears in file from Local Draft Board #1, U. S. Selective Service System, Natchez, Miss., April 27, 1959, seeking location of JAMES FREDERICK MURPHY, Selective Service Number 22 136 106. Notation appears in file MURPHY told Olan Mills he was turned down by Local Draft Board due to Psychopathic Letter of Inquiry September 15, 1960, from Reverend JOHN T. MARTIN, Pastor, Sacred Heart Church, 313 Walnut Street, Hattiesburg, Mississippi, for reference since MURPHY appeared at that church for assistance in obtaining employment. During first employment MURPHY was a patient at Whitfield, Virginia, August 9 to 15, 1957, diagnosis Pyelonephritis.

As undated photograph of MURPHY was obtained which Miss PENNY believed was taken during his last employment.

During interview MURPHY advised he was single, Catholic, and his nearest relative was his sister Miss JEAN MURPHY, 1309 Bourbon Street, New Orleans, Louisiana. MURPHY had advised he was en route to Memphis, Tennessee, and had spent the previous night at Atlanta, Georgia. The files reflect he had spent one night previously at this dormitory on February 23, 1963.

Mr. HOWERTON could not recall this individual from above card but when a photograph of JAMES FREDERICK MURPHY which was taken by Olan Mills Portrait Studios, was exhibited to him, he stated he remembered the individual but could furnish no additional information.

On June 4, 1942, CHARLES M. PICKEL, Rural Route 7, Henderson Springs, Tennessee, Sevier County, advised an Agent of the FBI, Knoxville, that one J. H. BOWEN, whom he believed to be an Italian, had resided in the vicinity of Henderson Springs for the past two years. He stated that BOWEN operates a camp for boys known as the "Campfire Council". According to PICKEL, one of the boys at the camp told GEORGE SHARP of Route 7, Henderson Springs, Tennessee, that he had seen BOWEN tear down an American Flag and stomp it into the ground. PICKEL said that BOWEN had three large police dogs at his home, which were very dangerous. PICKEL complained that the boys at the camp were committing some acts of thievery and property damage in the neighborhood. PICKEL stated that BOWEN spends time traveling over the country roads in and around Henderson Springs and that he knew for a fact that BOWEN had once traveled to Mexico City.

At the request of the FBI, PAUL LILLY, Patrolman, Tennessee Highway Patrol, made an investigation of the above allegation. On August 21, 1942, Patrolman LILLY, by letter, advised the FBI, Knoxville, that he had contacted Mr. GEORGE SHARP, Mr. CHARLES M. PICKEL, and others, and all of these persons had told him that the main trouble concerning BOWEN was on account of some vicious dogs which BOWEN had at his camp. LILLY stated that the neighbors told him they were deathly afraid of these dogs and that something had to be done about them. LILLY reported that he talked to some workers at the camp and they told him they had never seen or heard of any activities that would lead them to believe that BOWEN was or had been disrespectful to the United States.

Date December 23, 1963

Mr. HAL C. STEPHENS, Executive Director, Boys' Club of Knoxville, Inc., residence address 407 Caswell Avenue, Knoxville, Tennessee, advised that he was not personally acquainted with JOHN HOWARD BOWEN but stated that he had heard a lot about BOWEN since BOWEN was formerly Director of the Campfire Council at Knoxville, Tennessee, from 1938 to the Spring of 1943. STEPHENS stated at this time the Campfire Council was abandoned and the Boys' Club was organized and BOWEN was let out of boys' work. STEPHENS stated that he knew of nothing derogatory concerning BOWEN's loyalty to the country, but it was rumored that BOWEN [redacted] and for this reason he was let out of boys' work in Knoxville. STEPHENS stated that he knew of no prosecution concerning BOWEN and, to his knowledge, no charges were ever placed. He stated that he never received any derogatory information concerning BOWEN's loyalty to the country, but that he, STEPHENS, does know that when he took over the books and inventory of the Campfire Council for the newly organized Boys' Club, items on the inventory such as boats and motors, were never accounted for.

STEPHENS related that as Director of the Campfire Council, BOWEN operated a Campfire Council Camp in Sevier County for several years. According to STEPHENS, BOWEN was single and he stated that at this time he would be at least 80 years of age. STEPHENS advised that he knew of no relatives of BOWEN residing in this area and had never heard of any close acquaintances of BOWEN residing in this area.

STEPHENS stated that when BOWEN left Knoxville he reportedly went to Mexico where he was reported to be doing missionary work among the Indians. STEPHENS stated that BOWEN reportedly had been a missionary prior to coming to Knoxville and claimed that he had been a missionary in India.

Mr. STEPHENS advised that a recent news article appeared in the Knoxville Journal on or about November 14, 1963, which read as follows:

"BOWEN leaves for overseas; JOHN H. BOWEN, organizer of Boys' Club here and missionary to the Mixteca Indians in Mexico for the past 20 years, left New York yesterday for a speaking tour in England, Spain, Portugal, and Italy."

"BOWEN organized the Campfire Council for Boys, which evolved into Boys' Club. He served as Director of Boys' Club from 1929 to 1943, when he left for missionary work in Mexico. BOWEN was invited by evangelical groups of each country."

STEPHENS stated that he wrote the Knoxville Journal a reply to the above news article in which he had informed them that BOWEN had never been a Director of the Boys' Club. He stated that he understood that BOWEN in the past had friends submit news items to the Journal for reprint.

Mr. STEPHENS advised that he had no knowledge of BOWEN's residence in Knoxville when he was with the Campfire Council and he stated BOWEN's residence in Sevier County was limited to his operation of the Campfire Council Camp. STEPHENS stated that he was sure that BOWEN has never returned to Knoxville nor resided in Knoxville since he left in 1943.

The news article referred to by HAL C. STEPHENS of the Boys' Club regarding BOWEN's reported departure for Europe appeared in the November 14, 1963, issue of the Knoxville Journal; however, an examination of the records of the morgue on December 20, 1963, did not disclose any correspondence relative to this particular article. The morgue did reflect a news article dated December 5, 1953, in the Knoxville Journal, which reported that JOHN HOWARD BOWEN resided in Laredo, Texas, and had established a missionary station and a Baptist church in Mexico. He was reported to be the first protestant missionary in the land of the Mixtecas Indians. His address was listed as Box 308, Laredo, Texas. The source of this item appeared to be a letter addressed to the Journal from BOWEN.

The newspaper file contained a postal card from BOWEN bearing an illegible postmark of Tampa (Florida?), November 2, 1954. On this postal card BOWEN advised the Knoxville Journal that he was mailing some photographs to the Journal. He stated that last Christmas he announced he was retiring but after a trip to England where he spoke at a missionary conference, he decided to return to Mexico.

The news file contained a letter dated April 7, 1958, from a Dr. MARTIN HILDAGO, Oaxaca, Oax, Mexico. He wrote that BOWEN, a missionary, had saved two school children from being struck by a truck. In dashing in front of the truck to sweep the children from the path, BOWEN was slightly injured on his left side when he came in contact with the truck. The writer stated that this was the same missionary who had saved three children from a burning hut about eight years previously.

A short article in the Knoxville Journal dated April 12, 1958, described this incident, based on the above letter.

The newspaper file also contained a letter dated September 11, 1961, from an ALBERTO OSBORNE, which was postmarked at Texmelucan, Pue, Mexico. This letter reported that BOWEN was injured when he fell on a bus between Mexico City and Puebla, and it reported that BOWEN had been doing missionary work in Mexico since he left Knoxville in April, 1943. The letter set forth that BOWEN was invited to Mexico by the late Dr. C. E. LACKY, a missionary of the Southern Baptist Convention. The letter reported that BOWEN would be 82 in January (1962), but that he could easily pass for a man in his middle 50's. This letter went on to relate that BOWEN, prior to coming to Knoxville, had served as a missionary in India and had been active in missionary work since 1910 except the time he spent in Knoxville.

The Knoxville Journal published a short news article on September 15, 1961, based on the above letter.

On December 20, 1963, Mrs. CLARA BULL, Knoxville Credit Bureau, advised that a search of her files reflected no credit record for JOHN HOWARD BOWEN.

On December 20, 1963, Mrs. CHARLES DAVIS, Records Department, Knoxville Police Department, advised that she found no arrest record in the files of her office for JOHN HOWARD BOWEN.
