The following inquiries were made by SA ROBERT M. WHOMSLEY on December 11 and 12, 1963:

Mr. P. C SPEDALE, owner, Crescent Gun and repair Company, 2401 South Claiborne Avenue, stated that in his opinion the sling described as having been on the rifle of LEE HARVEY OSWALD is undoubtedly a target sling. In this regard he stated that he had never seen a sling black and brown in color and that they are all naturally oiled leather, brown in color. He said there are no distributors in New Orleans for leather products, i.e. holsters, slings and so forth. He said that in addition to his concern, there are two other firms in New Orleans dealing almost exclusively in firearms.

Mr. ARTHUR TOTURNER, gunsmith, and Mr. LEE AGERTON, Manager, New Orleans Arms Company, Inc., 240 Chartres Street, both commented in the manner of Mr. SPEDALE.

Mr. FRANK MORENO, Manager, Security Company, 3604 South Carrollton Avenue, likewise commented in the manner of those individuals noted above.

A photograph of OSWALD was shown to those individuals indicated and all informed he is unknown to them and has never been known to have done business in their respective businesses.

The individuals named below were contacted at their respective places of business and all advised they had never seen a rifle sling of the description of that found on the rifle of LEE HARVEY OSWALD. In addition it was learned that they receive very few orders to make rifle slings to precise specifications for customers, and, in addition never made one to order for OSWALD. When shown a photograph of OSWALD, all informed he is unknown to them and was never known to be in their respective companies:
