On November 28, 1963, Captain GEORGE M. DOUGHTY of the Crime Laboratory, Dallas Police Department, turned over to me the following items which were related to the shooting of J. D. TIPPIT of the Dallas Police Department. Captain DOUGHTY stated that LEE HARVEY OSWALD was charged with this shooting on November 22, 1963.

- 1. One gray man's jacket with "M" size in collar, laundry mark 30 and 030 in collar, zipper opening, name tag ("Created in California by MAURICE HOLMAN") on lining of jacket. This jacket bore the initials of W.E.B. which is W.E. BARNES and G.M.D. which is GEORGE M. DOUGHTY, officers of the Dallas Police Department Crime Laboratory. This jacket also bore tag number D 9738 on the bottom of the jacket. Captain DOUGHTY stated this jacket was found by Captain W.R. WESTBROOK of the Dallas Police Department on an open parking lot west of Patton Street between 10th and Jefferson Streets, Dallas, Texas.
- 2. Five live .38 caliber western special shells initialled "E.B." which were found in the left front pocket of LEE HARVEY OSWALD following his arrest at the time he was searched by ELMER BOYD, a detective of the Homicide Bureau of the Dallas Police Department.
- 3. Four live .38 caliber shells found by Dallas police officer JERRY HILL at the time he was arrested by the Dallas Police Department on November 22, 1963.
- 4. Four empty .38 caliber hulls. Regarding two of these hulls, Captain DOUGHTY stated at first that an unidentified witness at the scene of the shooting of Officer TIPPIT at 400 East 10th Street, Dallas, Texas on November 22, 1963, had turned them over to Officer J. M. POE of the Dallas Police Department who delivered these two hulls to the Police Crime Laboratory at the Dallas Police Department. Captain DOUGHTY stated that subsequent information verified that one DEMINGO/BENAVIDES of 501 East Jefferson, had found these two hulls on November 22, 1963 in the block of 400 East 10th Street

near where the shooting of Officer J. D. TIPPIT occurred on that date, and that BENAVIDES was the individual, in fact, that had turned these hulls over to Dallas Police Officer POE. One of these hulls was found by BARBARA JEANNETTE DAVIS of 400 East 10th Street, Dallas, Texas, and this hull was turned over to Captain GEORGE M. DOUGHTY of the Dallas Police Crime Laboratory. This hull was found in the front yard of BARBARA JEANNETTE DAVIS of 400 East 10th Street, Dallas, Texas. The other empty hull was found by VIRGINIA DAVIS of 400 East 10th Street, who resides at that address. VIRGINIA DAVIS found this empty hull in her front yard and turned it over to Detective C. M. Captain DOUGHTY stated that at the time LEE HARVEY

JERRY HILL in the gun found on OSWALD. Two of these live .38
caliber rounds were released to U. S. Secret Service on November 26,
1963 and were at the time in custody of the U. S. Secret Service,
as far as he knew. Captain DOUGHTY stated that he wanted to
point out this fact since only four of the live .38 caliber
shells found by Dallas Police Officer JERRY HILL at the time
OSWALD was arrested by the Dallas Police Partment on November 22,
1963, were being turned over to the FBI.

DOUGHTY, Captain of Crime Laboratory of the Dallas Police Department, furnished me with a pi/Oce of wood approximately 40" long and 3/4" in width for transmittal to the FRI Laboratory. Captain DOUGHTY stated that there was a possibility that there might be fingerprints on this wood since he had obtained same from the window ledge on the 6th floor where it is believed that the assassin fired the rifle in the assassination of President JOHN F.KENNEDY on November 22, 1963.

Mr. R. S. TRULY, Superintendent, Texas School Book Depository (TSBD), advised that on approximately December 16, 1963, a room adjoining the shipping room on the first floor of the TSBD Building was being cleaned and articles in there were being removed. He said that this room has been utilized by various employees who would leave articles of clothing as well as other articles from time to time in the room. He said that some of the colored men eat lunch in this room and play dominous there. He said that in the course of this room being cleaned up a blue jacket with gray quilted lining and zipper front was located and that it was not claimed by any of the employees who have access to the room. He said that in view of this it was his thought that perhaps this jacket belonged to LEE HARVEY OSWALD who was an employee of the TSBD as of the time of the assassination of President KENNEDY in front of this building on November 22, 1963. TRULY said that he had been unable to ascertain through inquiry among employees that this was OSWALD's jacket or that anyone had specifically observed OSWALD wearing it. He stated, however, that he himself had a vague recollection of having possibly seen OSWALD wear a jacket similar to that one in the past. He pointed out that he believed the morning of November 22, 1963, was a cool enough morning that a jacket would have been desirable at the time of the morning OSWALD would have reported for work in the TSBD Building.

IV. OTHER INVESTIGATION RELATING TO LEE HARVEY OSWALD

On November 27, 1963, the Washington Field Office advised that on November 26, 1963, ROBERT D. JOHNSON, Chief-Counsel, Passport Office, Department of State, informed BA KENNETH J. HASER that a National Broadcasting Corporation Representative made telephonic inquiry that date seeking to identify from passport files one JACK LAWRENCE, of Dallas, born about 1939, an alleged associate of JACK RUEY; that passport files were negative, and no additional information had been located regarding LAWRENCE.

On November 28, 1963, TOM PETTIT, NBC Correspondent, informed SA JOSEPH B. ABERNATHY, of the Dallas FBI Office, that he was leaving for New York and stated he had recorded a lengthy interview with AL BOGARD, Salesman, Downtown Lincoln-Mercury, Commerce at Industry, Dallas. This interview concerned OSWALD's having come in to look at new cars some two weeks earlier and OSWALD's being permitted to test drive a new Comet. PETTIT quoted BOGARD as stating that JACK LAWRENCE, a former salesman for Downtown Lincoln-Mercury, had considerable additional information in this regard.

The following investigation was conducted by SA'S TOM E. CHAPOTON, JR., and ALLEN H. SMITH at Dallas, Texas:

On December 5, 1963, FRANK PIZZO, Assistant Sales Manager, Downtown Lincoln-Mercury, stated that JACK LAWRENCE was hired as a salesman on October 22, 1963. He was discharged on November 23, 1963, after another former salesman, BOB TETER, had told him that LAWRENCE had received a Bad Conduct Discharge from one of the military services, because he had tried to help FIDEL CASTRO when CASTRO first began to fight BATISTA in Cuba.

Mr. PIZZO made available an application of LAWRENCE with the Liberty Mutual Insurance Company for a bond, which had been executed in connection with his employment. The following information was taken from the application:

Mr. FIZZO said that LAWRENCE had applied as a result of an advertisement and had related he had been stranded in Dallaz when his car broke down and he had had to sell the car.

On December 6, 1963, JOE MC REE, Secretary, YMCA, Dallas, stated that JACK LAWRENCE, 1006 First Avenue, Charleston, West Virginia, checked in on October 6, 1963, and checked out on November 30, 1963, leaving forwarding address as JACK LAWRENCE, 144 10th Avenue, South Charleston, West Virginia, telephone RI 4-0857. He occupied Rocm 811 during this time. Mr. MC REE was not acquainted with LAWRENCE and knew of no one else who was.

On December 7, 1963, ROBERT D. TETER, 3737 Higgins, Apartment 222, Dallas Used Car Salesman for Eagle Lincoln-Mercury, 5211 Lemmon Avenue, stated that he had formerly been employed as a salesman for Downtown Lincoln-Mercury and had met JACK LAWRENCE during this employment, since LAWRENCE was also a salesman.

On one occasion, date not remembered, but which was prior to the assassination of the President, he and LAWRENCE had gone out together one evening and had a few drinks. He could not recall any of the details of their conversation during this evening out, but said he did remember LAWRENCE telling him he had gotten a Bad Conduct Discharge when he had tried to help FIDEL CASTRO when CASTRO first began to fight BATISTA in Cuba. He said he did not remember other statements made by LAWRENCE, but did recall LAWRENCE had been very emphatic about some of his ideas. TETER said that this had come to his attention because somebody at Downtown Lincoln-Mercury had recognized CSWALD as having been in that agency to see about a car and all the ensuing publicity about OSWALD being an admirer of CASTRO.

TETER said the last he heard LAWRENCE had gone back to West Charleston, where his wife was living, address unknown.

Mr. ALBERT GUY BOGARD, Salesman. Downtown Lincoln Mercury, Dallas, Texas, furnished the following written statement:

"Dalles, Texas December 9, 1963

"I, Albert Guy Bogard, make the following statement voluntarily to C. Ray Hall, who has identified himself to me as a Special Agent of the Federal Bureau of Investigation. No threats or promises have been made to me to get me to make this statement. I have been told that I do not have to make a statement, and that I have a right to talk with a lawyer before making any statement. I have been told that this statement may be used against me in a court of law.

"I was born December 30. 1924, at Coushatta, La., and finished the eleventh grade in school. I am now living in Dallas, Texas, and work as an automobile salesman for Downtown Lincoln-Mercury located at 118 East Commerce.

"On Saturday, November 9, 1963, at about 3:00 to 4:00 PM, a young man came in the showroom at Downtown Lincoln-Mercury, and stated he was interested in a car. This woung man was alone, and I did not see him drive up in a car. I introduced myself to this man, and asked him for his name about twice before he ever told me his name. This man said his name was lee Oswald.

"I showed the man all the cars in the showroom, then went outside with him and showed him cars we had

outside. He seemed interested in a red Comet hardtop, so I asked him if he would like to take a ride in one of our cars. It was at this time that the man said his name was Lee Oswald. I asked him if he had a trade-in, and he said he didn't, but was going to pay cash. I asked him if he meant a cash down payment, or full payment of the car in cash, and he said he had some money coming in within two or three weeks and would pay cash for the car.

"I got a car similar to the one in the showroom and I asked the man if he wanted to drive it. He said, 'Yes, I wondered if you were going to let me drive one before I bought.' This man, who had told me his name was Lee Oswald, drove out of our place and drove South on Industrial Blvd. for a short distance, then turned around and drove to Stemmons Freeway. In driving North on Stemmons Freeway, this man drove at speeds up to 75 to 85 miles per hour. He turned off on the Inwood Road exit, then crossed under the Freeway and came back on to the Freeway going Scuth. He drove South to the Colorado Street exit, where be turned off and turned back on to the Freeway going North. He then drove back to my place of business.

"After we got back, I tried to get this man to give me a down payment, and fill out an order for a new car, but he would not do so. I again tried to get the man's address and phone number, but he would not give either his address or a phone number. I do not now recall whether the man said he lived in Oak Cliff or not. I gave this man my business card, and when he would not give me his address, I wrote the

name 'Lee Oswald' on the back of one of my cards and put it back in my pocket.

"On November 22, 1963, after President Kennedy had been killed, I heard a radio broadcast about Lee Oswald being picked up as a suspect, and thought about the man being in about two weeks previously. I found the card in my pocket, that had the name Lee Oswald on it. This was sometime in the afternoon of November 22, 1963. I mentioned this name on the card to some of the other people at the place where I was working, and showed the card to them, remarking, 'He isn't a prospect any more.' I then threw the card in the waste basket.

"That night, while watching the news on television. I saw pictures of Lee Harvey Oswald, the person who was being held by the Dallas Police Dept. in connection with the death of President Kennedy. The following day, I saw photographs of this lee Harvey Oswald in the newspaper. I am positive that this Lee Harvey Oswald, who was arrested in connection with the death of President Kennedy, is the same person who came to my place of business on November 9, 1963, and gave me his name as Lee Oswald.

"The day after President Kennedy was killed, two Special Agents of the FBI, one of whom was named Clements, contacted me, and I related to them the same information as set out in this statement.

"I have read this statement which is written on this' four (4) other pages and it is true to best of my

BOGARD, Route 1, Coushatta, Louisiana. Mr. ORAN PAUL BROWN, 101 Savannah, Waxahachie, Texas, advised he was formerly employed as an autometile salesman for Downtown Lincoln Mercury, Dallas, Texas. He is presently working as a trainee at the Fina Service Station, 2681 Royal Lane in Dallas, and as soon as the Fina Service Station at Stemmons Expressway and Inwood Road is completed he will be employed as manager at that location.

While working for Downtown Lincoln Mercury, one night about a week or two before President KENNEDY was assassinated, BROWN was scheduled to be on duty that night. Another salesman, ALBERT BOGARD, came by and told him he had a prospect for the sale of a car, by the name of LEE OSWALD. BOGARD said that OSWALD had been in looking at cars, but didn't have enough money for a down payment, and was supposed to come back when he got some money. BOGARD asked BROWN to take care of OSWALD, if he came in, and they would split the commission if the car was sold. BROWN then wrote the name "LEE OSWALD" down on something, and thought he wrote the name downon the back of one of BROWN's cards. No one named OSWALD came in, and he forgot about the matter.

KENNEDY had been killed, he came to work at about 3:00 PM, and BOGARD remarked to him that LEE OSWALD had been arrested in connection with the assassimation. BOJARD then said, "OSWALD was the name of the guy I was going to sell the car to, and I gave you his name as a prospect." BOGARD also reminded BROWN that when BOGARD was talking to OSWALD at Downtown Lincoln Mercury, BROWN started to walk into the office where BOGARD and OSWALD were talking, but BROWN walked away when he noticed that BOGARD had a customer. BROWN said he thought he remembered this incident, but didn't pay any attention to the customer BOGARD was talking to, and definitely could not identify this customer. BROWN stated he has seen the photographs of LEE HARVEY OSWALD in newspapers, and on television and he could not say that he had ever seen LEE HARVEY OSWALD before. However, BROWN was positive that BOGARD gave him the name of LEE OSWALD, as a prospective customer, a week or two before President KENNEDY was assassinated.

When BROWN got home on the evening of November 22, 1963, his wife asked him what he knew about OSWALD, telling him that

she had seen the name of OSWALD on a piece of paper among his effects. He told her that this was a prospective customer, but he thought he had written the name on one of his cards. They both looked around the house, but could not find the card or a piece of paper, with the name of OSWALD on it.

On November 23, 1963, POJARD told BROWN that he was sure that the IEE HARVEY OSWALD that he had seen on television, was the same OSWALD that had been in to see him about buying a car.

Mrs. ORAN PAUL ROWN, 101 Savannah, Waxahachie, Texas, advised that her husband was formerly employed as an automobile salesman for Downtwon Lincoln Mercury, Dallas, Texas.

On the afternoon of November 22, 1963, she watched the television news concerning the assassination of President KENNEDY. When she heard that a man named LEE OSWALD had been arrested, she recalled seeing the name of OSWALD on a piece of paper that her husband had left at the house. When her husband came home late that afternoon, she asked him about it, and told him she thought she had seen the name of OSWALD on a piece of paper, about two weeks previously. Her husband than told her that one of the other salesmen where he worked, had given him the name of OSWALD as a prospective customer.

Mrs. BROWN said that she revalled the name on the piece of paper was "OSWALD," and she thinks this name was preceded by two initials, but she does not remember what the initials were.

AT DALLAS, TEXAS:

At 11:00 a.m. on November 23, 1963, SA EDWIN D. KUYKENDALL received a telephone call from one JACK LAWRENCE, residence YMCA on Ervay Street, Dallas, Texas, who stated a person he believed to have been LEE HARVEY OSWALD had recently appeared at Downtown Lincoln Mercury in Dallas, at which time he had indicated a desire to purchase an automobile. The individual stated he had no money at that time but expected to have cash in sufficient amount to purchase an automobile within "a couple of weeks."

Date _____12/13/63__

JACK A. LAWRENCE, who is presently staying at the home of his parents in law at 144 Tenth Avenue, South Charleston, W. Va., was advised that he was being contacted in connection with a phone call he had made to the Dallas, Texas, Office of the FBI the day after the assassination of President KENNEDY.

Mr. IAWRENCE was asked what he knew about JACK L. RUBY, and he said he knew nothing about this man, had never seen him and had had no contact in any way with him. He said he had heard a great deal about him, which was all second hand and which was general knowledge around Dallas. He said he had heard that RUBY was a close friend of the Sheriff of Dallas County, as well as a close friend of newspaper people, especially since he was in the office of the Dallas Morning News at the time of the assassination. He said he had also heard that RUBY knew members of the Dallas police very well. He said all this he had heard after the shootings and that none of it was first-hand knowledge to him.

Mr. IAWRENCE was asked what he knew about IEE HARVEY OSWAID, and he said he had never known or seen this man and had never heard of him until his arrest after the assassination. He said that he had called the FBI Office in Dallas, Texas, because of an incident which occurred and about which those who knew of it first hand would not report same, and he felt that all such information should be reported. He said that he called the FBI right in front of those involved; and as a result, his leaving his employment in Dallas at the Downtown Lincoln-Mercury Company was speeded up and occurred the same day he made the call.

Mr. LAWRENCE said that right after the assassination of President KENNEDY and the arrest of OSWALD the Assistant Sales Manager, PIZZO, and a salesman, AL BOGARD, talked about OSWALD being in there about ten days before. He was looking at a \$3,500 Comet Caliente Sports Car, fully equipped. He took one of these cap, a demonstrator belonging to salesman GENE WILSON, for a test drive. This drive took place along the same route taken when President KENNEDY

came to Dallas and covered the route where he was assaminated. At the same time, the salesman wrote up papers covering the sale of this car to OSWAID, but he told them he was not taking the car at that time, but he would be back in three weeks to get the car and he would pay for it in full in cash.

Mr. LAWRENCE said he knew nothing further about OSWALD but felt this should be reported to the FBI even though the others would not report it.

Mr. IAWRENCE said that in January, 1959, he was in the service and that at that time CASTRO was over throwing the government in Cuba. He said he and others in the service were very much in favor of CASTRO's actions, and they wanted to go down and help him, but he said that he was not discharged from the service until it was too late to go down and do any good. He said that now he is glad he did not help CASTRO because he no longer favors what he has done or what he stands for. He said he is opposed to what CASTRO stands for now and would not help him under any circumstances.

MARY ADDA DOWLING, 617 West Tenth, advised she is currently employed at Skillern's Drug Store No. 41, Preston Road and Forest Lane. She advised that until recently she was employed with the Dobbs House at 1221 North Beckley working during daytime hours. She said that she did not know who LEE HARVEY OSWALD was when she formerly waited on him when he ate breakfast in the morning, usually between 7:00 and 7:30 a.m., but that since OSWALD has received so much publicity in connection with the assassination of President KENNEDY on November 22, 1963, she became aware that he was the one who had been a customer at the Dobbs House. She recalled that OSWALD was in the restaurant on Wednesday morning, November 20, 1963, at about 10:00 a.m. She said that OSWALD was apparently in an ugly mood at the time and said scmething "nasty" to her using curse words regarding his order. She said she told him that if his order was not right that the Dobbs House would make it right. She said that shortly thereafter, OSWALD again used curse words in addressing her because she did not give him more coffee as soon as he thought she should. She recalled that Officer J. D. TIPPIT was in the Dobbs House at that time, apparently as a customer, and that when TIPPIT heard OSWALD making his outburst toward her, TIPPIT shot a glance at OSWALD. She said OSWALD was already getting ready to leave, and nothing was said between TIPPIT and OSWALD. She stated there was no indication that TIPPIT and OSWALD ever knew each other.

She noted that she had known Officer TIPPIT for approximately five years because he had formerly come into the Continental Bus Station in downtown Dallas in which bus station she worked in the drug store. She said that TIPPIT was usually in the Dobbs House each morning about 10:00 a.m. or shortly thereafter to drink coffee.

Regarding OSWALD, Miss DOWLING said that she

had not seen OSWALD in the Dobbs House on Thursday or Friday, November 21 or 22, 1963, and she attributed it to the possibility that OSWALD may have been angry with her because of their clash on November 20, 1963. She recalled that sometime prior to their clash on November 20, OSWALD had on one or two occasions asked her for her name, and she would not tell him her name.

Miss DOWLING stated that she had never to her recollection seen JACK RUBY prior to the time of the President's assassination on November 22, 1963, but that she did recall that the night manager at the Dobbs House, DOUGLAS LEAKE, had said after JACK RUBY shot OSWALD that RUBY had been a customer of the Dobbs House during night hours in the past.

She said she had no information of assocation between OSWALD and RUBY.

Mr. WILLIAM F KGORMAN, JR., also known as BILLY P. GORMAN, JR., 1306 North Beckley, advised that he works a shift with the U. S. Post Office in Dallas, Whereby he gets off work at midright and that before retiring, he usually stops at the Dobbs House, 1221 North Beckley, for a little to eat inasmuch as it is convenient to where he lives in the next block. He said that he had seen JACK RUBY in the Dobbs House on about three occasions. He said that on the first occasion RUBY introduced himself to him as BILLY GRAHAM, the evangelist. GORMAN stated he told RUBY he was delighted to meet him and that he himself was Bishop SHEEN. that on a second occasion when he observed RUBY in the Dobbs House there was no occasion for conversation between him and RUBY. He said that on a third occasion when he saw RUBY at the Dobbs House, RUBY did not speak to him, and he thought he might have offended RUBY on the first occasion by the response he had made to RUBY. He said that someone at the restaurant, either an employee or customer probably, had told him that this individual was named JACK and also gave his last name, but the last name did not stay with him. He said that whoever told him this had advised him that this person had a "strip-tease" place in Dallas.

GORMAN advised he never really knew RUBY's full name of JACK RUBY until after RUBY became involved in the investigation of the assassination of President KENNEDY and was given considerable publicity as a result of his having been charged with the shooting of LEE HARVEY OSWALD. GORMAN said that on the first two occasions that he saw RUBY in the Dobbs House, RUBY had in his company a quite attractive girl, a different girl each time. He said that he never saw OSWALD prior to the assassination of President KENNEDY and had no information which would reflect there was any association between OSWALD and RUBY.

Information received from DOUGLAS LEAKE, Night. Manager of the Dobbs House, 1221 North Beckley, Dallas, Texas, as received on December 5, 1963, has previously been reported.

JERRY DUNCAN, operator of an Enco Service Station, 1030 North Zangs, Dallas, advised that OSWALD lived at 1026 North Beckley just across the street from his station. Although he had no automobile, he came to the station on occasion. He secured change with which to make long distance telephone calls from DUNCAN at least twice. He believes this was approximately six weeks ago. The calls were made from a coin telephone booth located at the side of his station, telephone number WH 3-0062.

Approximately six weeks ago, OSWALD went out with one of DUNCAN's employees, JOHN L. FORD, to drink beer. So far as DUNCAN knows, they were out together only on the one occasion. FORD has left Dallas, and his whereabouts is unknown to DUNCAN. He could not supply his last Dallas address or the identity of anyone who might supply background data concerning him. He did recall that FORD's home address is Monroe, Louisiana, but could not supply a street address. He advised that FORD is a white male, age 24.

DUNCAN advised he has never observed JACK LEON RUBY in the neighborhood or associated with OSWALD.

JOHN LAURELL FORD was interviewed by Agents of the New Orleans Office and advised that his permanent residence is 218 Vernon Street, Monroe, Louisiana. He has been employed by the Redmond House Movers, Monroe, for approximately eight years except for the four-month period, July through October, 1963. In July, 1963, he went to Houston, Texas in an effort to reconcile with his second wife and he resided in Houston for approximately two months at 4731 Galveston Road until 1t was apparent that the reconciliation would fail. About the first of September, 1963, he moved to Dallas, residing with his sister, JEAN, and brother-in-law, LINDELL ALLEN, at 323 Elston, and later at 2423 Martha. He returned to Monroe, Louisiana on November 4, 1963. In Dallas, he was employed by Duncan-Humble Service Station, 1030 North Zangs, owned by Gerald DUNCAN. He does not believe that he ever met LEE HARVEY OSWALD nor had he ever heard the name ALEK HIDELL or O. H. LEE, and never knew or heard of JACK RUBY or JACK RUBENSTEIN. He did not recognize the photographs of either CSWALD or RUBY which were exhibited to him.

The records of the Sheriff's Office, Monroe, Louisiana, reflect that FORD, FBI No. 677293D, was arrested on July 8, 1957 for improper muffler and resisting arrest. He was fined \$25.00 and costs and \$100.00 and costs or 60 days. He was again arrested December 1, 1960 on a muffler violation and fined \$25.00 and costs.

He said he was presently employed by HAROLD L. WILSON, contractor, as a laborer and on November 22 he was working in North Dallas for WILSON building a church. He said he did not see the Presidential parade or the assassination of President KENNEDY and was not present when Officer TIPPIT was shot. He said that possibly his son, WILLIAM ARTHUR SMITH, age 20, observed the shooting. He said that his son was presently visiting his son-in-law who is a Mexican and works at a paper mill in Dallas, possibly Owens. He said his son-in-law has not been back to Mexico in over a year that he knew of. He advised that he cannot read or write and knew no one in New Mexico.
