R. H. SCHAEFER, Regional Sales Manager, the DeVilbiss Company, 2508 Irving Boulevard, advised that he does not know LEE HARVEY OSWALD and did not have any contact with him. He made available an undated interview record for LEE HARVEY OSWALD to which is stapled at the top a card reading "Jobco proudly introduces LEE OSWALD". On the inside of this card it reads to Mr. FRIEL, DeVilbiss Company, 2506 Irving, introducing LEE OSWALD, position shipping and receiving clerk, date October 10, time 1:30 PM, signed R. RANDUK, Counselor.

The interview record contained the following information:

LEE HARVEY OSWALD, Social Security Number 433-54-3937, address 2515 West Fifth Street, Irving, Texas, telephone BL 3-1628, a citizen of the United States, married to MARINA OSWALD, is the individual filling out this form.

OSWALD indicated that he rents, does not own an automobile, has no physical handicaps or disabilities and has never been employed by the DeVilbiss Company. He indicates that the last physician he contacted was "service physician" and describes himself as age 23, born October 18, 1939, height 5'9", weight 140, brown hair, gray eyes. He lists two dependents and indicates he can accept a position immediately.

Under education OSWALD indicates he attended "Rigley" West Grade School for nine years and Arlington Heights High School for three years taking general courses in both schools. Opposite questions as to what foreign languages he speaks and reads he placed a dash. Also opposite listing for hobbies he listed a dash. He indicated military service for the United States from 1959 to 1962 and lists his wife at the same address as shown for him as the person to contact in case of an emergency.

Under previous employment record OSWALD lists the following:

1. Lowv-R-Pak, April to September, as a stock clerk under supervision of TOM GOMEZ at rate of \$1.50 per hour doing stock inventory.

He does not give a year for this employment and gives the address of the company as 201 N.E. Vacek Street, Fort Worth, Texas.

2. Jaggars-Chiles-Stoval, October to April (no year listed), photographer under supervision of JOHN GRIEVES at \$1.50 per hour. He lists the address of this company as 522 Browder Street, Dallas, Texas, and indicates his reason for leaving was "out in work forces".
3. Military service, without specifying branch or dates.

OSWALD indicates that he has never been discharged (apparently referring to being discharged by an employer).

Under personal references OSWALD listed the following:

1. Mr. R. PAINE, 2517 West Fifth Street, Irving, Texas, a housewife known to him for one year.
2. Mr. M. ~~BLED~~SOE, Retired, 621 Marsalis Street, Dallas, Texas, known one year.
3. GEORGE DE MORENHSHILT, 602 Dickens Street, Dallas, Texas, an engineer known to him one year.

OSWALD indicated he has never been refused a fidelity bond. The interview record is signed on the back LEE H. OSWALD.

JAMES FRIEL, the Devilbiss Company, 2508 Irving Boulevard, Dallas, Texas, residence 113 South Gloucester, Irving, Texas, telephone RL 5-6456, furnished the following information:

LEE HARVEY OSWALD was referred to Devilbiss by Jobco, an employment agency, and was interviewed by FRIEL on October 10, 1963, in connection with his application for a job as shipping clerk. OSWALD filled out an interview record on the premises of Devilbiss and this interview record is in the files of Devilbiss undated. FRIEL states that he knows the interview record was filled out on October 10, 1963, because this was the same date that he interviewed BARNHILL MARION STANLEY, whom he actually hired for the position that OSWALD was applying for.

FRIEL advised that OSWALD filled out everything on the interview record with the exception of the name of his wife "MARINA" whose first name OSWALD had failed to list. FRIEL filled this in on the interview record after LEE HARVEY OSWALD told him his wife's name.

FRIEL advised that OSWALD was shabbily dressed and he was not impressed by him and did not consider him seriously for the job at any time. He stated that he is unable to definitely identify LEE HARVEY OSWALD by photograph as being at the office on October 10, 1963. He explained that there were at least five men who appeared on that date and who were interviewed by him for the job. Therefore, he is unable to recall definitely the identity of LEE HARVEY OSWALD but can identify the interview record as being that of the person interviewed by him.

Mrs. WILLIAM V. (ROBERTA) PARKER was interviewed at the Gregg Publishing Company, 411 Elm Street, Dallas, and furnished the following information:

She resides at 5916 Ellsworth, Dallas. Her husband is employed by the Southwestern Bell Telephone Company. Mrs. PARKER on November 22, 1963, left the offices of the Gregg Publishing Company and walked across the street to a small park from which vantage point she observed the Presidential Motorcade. With her at the time were DELORES KOUNAS and LLOYD R. VILES, also employees of the Gregg Publishing Company. She noted that 411 Elm Street is the address for the Texas School Book Depository building. The car in which President KENNEDY, Governor CONNALLY and their wives were riding had passed Mrs. PARKER only a short distance when she heard what she thought was a shot. From her location, she was unable to see whether the shot had hit anyone in the Presidential car. The shot sounded to her as though it had come from a cement memorial building to the north of the Texas School Book Depository on Elm Street. She looked in that direction but saw nothing that she could relate to the shot. During this time, she heard two additional shots and in looking around, glanced at the Texas School Book Depository building which was directly across Elm from her. She noted that a number of windows were open on the fifth and sixth floors of the building, but saw no one standing in any of those windows.

On seeing the photograph of LEE HARVEY OSWALD in the newspapers, she believed she recognized him as an individual she had seen on one occasion in the lunch room at the building. She did not talk to him at this time and noted that he was by himself on that occasion. She has had no contact with OSWALD and does not know him.

She advised that she has seen photographs in the news media of JACK RUBY, but to her knowledge has never seen him and knows of no connection he might have with OSWALD.

Mrs. JAMES L. (DOROTHY) ~~LOVELADY~~^{LOVELADY}, was interviewed at the Southwestern Publishing Company, 411 Elm, Dallas, where she is employed. She resides at 2717 Fairbrook, Irving, Texas, telephone BL. 5-4261. Mrs. LOVELADY advised that she was sick and therefore not at work on November 22, 1963, and had no information regarding the assassination of former President JOHN F. KENNEDY. Upon seeing the photograph of LEE HARVEY OSWALD in the local newspapers and on television, she recognized him as a person whom she had seen at the lunchroom in the building on one or possibly two occasions. She did not know him by name until he was identified to her through the news media, and had never had any contact with him. She advised that she did not know JACK RUBY and to her knowledge he had never been at the Texas School Book Depository or in touch with OSWALD.

Mrs. JOSEPH A. (VICKI) DAVIS, 684 Southeast 8th Street, Grand Prairie, Texas, telephone AN. 2-0127, was interviewed at the Southwestern Publishing Company, 411 Elm, Dallas, on December 16, 1963. Mrs. DAVIS advised that she is an employee of the Southwestern Publishing Company but was not at work on November 22, 1963 since she was sick that day. She had no information concerning the assassination of JOHN F. KENNEDY. With reference to LEE HARVEY OSWALD, she advised that after seeing his photograph on television and in the newspapers, she recognized him as a person whom she had seen on several occasions in the Texas School Book Depository Building, 411 Elm. Until she saw his name in the papers, she did not know his name and never had any conversation with him. She had no information concerning OSWALD. She advised that JACK RUBY was unknown to her and to her knowledge she had never seen him at 411 Elm, Dallas.

R. L. ADAMS, Interviewer, Texas Employment Commission (TEC), Dallas, Texas, on December 2, 1963, advised SA BARDWELL D. ODUM that a Mr. HAMILTON, Office Manager, Al Sementner Drug Depot, 2600 block South Central Expressway, called him today mentioning that OSWALD had come to see him about a job, but that he was not impressed.

ADAMS stated that he does not recall referring OSWALD to HAMILTON, but that HAMILTON indicated that he believed OSWALD had been sent by the Texas Employment Commission. ADAMS advised TEC records do not show any referral of OSWALD to the Al Sementner Drug Depot.

Date December 7, 19631

Mr. OLIN BENJAMIN HAMILTON, Route 2, Parker Road, Plano, Texas (telephone 995-3444), Treasurer and Production Manager for the AL SEMTNER Drug Depot, 2416 South Central Expressway, Dallas, Texas, was interviewed concerning a report that LEE HARVEY OSWALD had come to see him about a job but had not been hired.

Mr. HAMILTON advised that on Monday, September 23, 1963, he had made a request of the Texas Employment Commission for referral of possible job applicants for the position of warehouseman, and numbers had reported for purpose of making application. After the assassination of President KENNEDY and the appearance of LEE HARVEY OSWALD on television, HAMILTON stated that he recognized the name of LEE HARVEY OSWALD as that of an individual who had applied for employment with the company during this period, though he stated he was unable to identify photograph of OSWALD as being one that had applied.

Mr. HAMILTON described the individual whom he recalled as LEE HARVEY OSWALD as follows: white, male, American, age 27, height 5' 7" to 5' 8", slender build, dark hair. He stated that he was wearing a suit and presented a fairly good appearance. This individual stated that he had been in the U. S. Marines. Mr. HAMILTON stated the pay for warehousemen at the firm is \$1.35 per hour. This individual stated that he wouldn't take less than \$1.50 per hour as he had a wife and two children to support. He failed to make a good impression with Mr. HAMILTON who described this individual's manner as arrogant and not friendly. He said that he felt he would not mix with the other boys in the warehouse.

Mr. HAMILTON feels with some certainty that the name of the person so applying was LEE HARVEY OSWALD. He stated that he had destroyed the employment application which OSWALD had prepared.

Mr. HAMILTON was unable to supply any other information of pertinence.

LEE HARVEY OSWALD, in an application for employment dated May 9, 1963, with William B. Reilly and Company, Inc., New Orleans, Louisiana, gave as one of his references, Sergeant ROBERT HIDE~~LL~~, Active Duty, United States Marine Corps.

On November 24, 1963, Records Locator, Headquarters, United States Marine Corps, Arlington Annex, Arlington, Virginia, failed to reveal any record, past or present, for any individual having the last name HIDE~~LL~~. The records do contain the name JOHN R. HEINDELL, Marine Serial Number 154-38-55, who was assigned to Marine Corps First Wing Aircraft, August 13, 1958, to October 5, 1958, during the time LEE HARVEY OSWALD was assigned to this unit. HEINDELL has been discharged and his personnel record is located at St. Louis, Missouri.

On November 24, 1963, the records at Military Personnel Records Center, St. Louis, Missouri, indicated JOHN RENE HEINDEL, Marine Serial Number 154-38-55, who was born February 1, 1938, at New Orleans, Louisiana, was last discharged January 28, 1962. His parents, GEORGE M. and NELLIE R. HEINDEL, were listed as residing at 806 Belleville Street, New Orleans, Louisiana.

Personnel at Military Personnel Records Center, St. Louis, Missouri, made available the record for JOHN RENE HEINDEL, Serial Number 1543855, which indicated he enlisted in the U. S. Marine Corps on January 27, 1956, and entered on active duty February 15, 1956, at New Orleans, Louisiana. He was honorably released from active duty August 14, 1956, as a Private at Jacksonville, Florida, and transferred to the U. S. Marine Corps Reserve.

HEINDEL served in the U. S. Marine Corps Reserve from August 15, 1956, to July 15, 1957, at which time he was honorably discharged to re-enlist.

HEINDEL re-enlisted in the U. S. Marine Corps on July 16, 1957, and entered on active duty the same date at New Orleans, Louisiana. He was honorably released from active duty July 14, 1961, as a Corporal at New Orleans, Louisiana, and transferred to the U. S. Marine Corps Reserve.

HEINDEL served in the U. S. Marine Corps Reserve from July 15, 1961, to January 28, 1962, at which time he received an honorable discharge due to expiration of enlistment.

HEINDEL was reduced to the next inferior rank on June 23, 1961, in that he did wrongfully appear at main gate without cover on. The reduction was suspended one month unless sooner vacated.

HEINDEL's record contained a recommendation for undesirable discharge dated January 7, 1957, for fraudulent enlistment - failed to reveal he was married at time of enlistment. This recommendation was waived and he was retained in the U. S. Marine Corps.

He was awarded the Good Conduct Medal and the China Service Medal.

HEINDEL's address was listed as 806 Belleville Street, New Orleans, Louisiana.

The following investigation was conducted at Ennis, Texas, by SA JOHN V. ALMON:

JAMES T. MC LEMORE, 702 West Tyler Street, advised that he was not acquainted with MICHAEL R. PAINE or LEE HARVEY and MARINA OSWALD.

Mrs. JAMES T. (JOAN) MC LEMORE advised that during March, 1963, her sister, who resides in Irving, Texas, Mrs. JASPER (LILLY) LELINE, 414 Lilac Street, called to inquire about renting the residence next door. Mrs. MC LEMORE stated that her sister, who does not have a telephone, remarked during the conversation that she was using the phone of a neighbor. Mrs. MC LEMORE stated that she is not acquainted with either the PAINE or OSWALD family.

The following investigation, in the neighborhood of 214 West Neeley, Dallas, Texas, was conducted by SAS JOHN T. MC MURRER and LOUIS M. KELLEY:

Mrs. W. R. WILLIAMS, 220 West Neeley, advised on December 2, 1963, she had resided at this address since March 1, 1963. She said she did not know any of the neighbors and has had no contacts with any of them. She viewed photographs of LEE HARVEY OSWALD and JACK RUBY and since she had never seen either man, she was unable to recall anyone who had lived in the house at 214 West Neeley, which is located across the alley from her apartment.

Date December 13, 19631

MARINA OSWALD was interviewed at 11611 Farrar Street.

She stated that immediately prior to early November, 1962, her husband, LEE OSWALD, had been residing in the YMCA in Dallas, Texas. She was residing in Fort Worth. She recalls she had a dental appointment in Dallas and Mr. GARY TAYLOR, the then son-in-law of Mr. GEORGE DE MOHRENSCHILDT, picked her up in Fort Worth in his car and took her to her dental appointment. While she was at the dentist's, another appointment was made, and Mrs. TAYLOR requested that MARINA stay with the TAYLORS until the next dental appointment, which was three or four days away. She said she lived with the TAYLORS for a few days and that LEE OSWALD had visited her at the TAYLOR house, although he did not sleep there. He continued to stay at the YMCA. She said she cannot recall the address of the TAYLOR house, but LEE OSWALD had it in his telephone book. She said the first place that she and OSWALD had a place together in Dallas after this was when they lived on Elsbeth Street. They moved into the Elsbeth Street address in Dallas in early November, 1962.

MARY ANN STUDDARD, Secretary, American Life Insurance Company, Life Building, Dallas, was advised of the identity of the interviewers as Special Agents of the Federal Bureau of Investigation. She furnished the following information:

For approximately two or three months around the first part of 1961 she and her former husband, DYAL CURRIN QUARLES, lived in an apartment house at 612 Hurley Street, Fort Worth, Texas. Mrs. MARGUERITE OSWALD lived in an upstairs apartment at the same address. While the QUARLESes lived at this address, Mrs. OSWALD moved away saying she was going to work in Wichita Falls, Texas. She had previously been employed in Fort Worth for a cleaning establishment close to the Hurley Street address.

Miss STUDDARD recalled that while Mrs. OSWALD lived at 612 Hurley, Miss STUDDARD's sister, PAULA, came to visit the QUARLESes for a short period of time.

Miss STUDDARD recalled that while residing at 612 Hurley, Mrs. OSWALD had told the QUARLESes that she had a son whom she had not heard from for about six months concerning whom she was quite worried, stating that she did not know where he was but believed he was in Russia. On one occasion Mrs. OSWALD expressed concern that possibly her son had been killed.

Miss STUDDARD stated that she and her husband visited Mrs. OSWALD infrequently and Mrs. OSWALD on occasion returned the visits. Mrs. OSWALD never had any other company to Miss STUDDARD's knowledge.

Miss STUDDARD recalled that the man who owned the apartment house at 612 Hurley ran a jewelry store on Eighth Avenue, Fort Worth, in the close vicinity of Hurley Street.

Miss STUDDARD believes that Mrs. OSWALD resided at this address for approximately one month before she moved

to Wichita Falls, Texas. Miss STUDDARD could not recall Mrs. OSWALD's having mentioned having any other children other than the son that she believes was in Russia.

Miss STUDDARD could not recall Mrs. OSWALD having an automobile although she believes she might have had one. She stated, further, that she did not know of Mrs. OSWALD having a boyfriend.

1Date December 12, 1963

PAULA STUDDARD, Receptionist, Belden Associates, Suite 3000, Southland Life Building, Dallas, Texas, furnished the following information:

In May and June, 1961, **PAULA STUDDARD** visited her sister, the then Mrs. **DYAL CURRIN QUARLES**, at the **QUARLES** residence, 612 Hurley Street, Fort Worth, Texas. During this period, Mrs. **MARGUERITE OSWALD** resided in an upstairs apartment at the same address. Mrs. **OSWALD** would occasionally drop down and visit the **QUARLES**es and in this way Miss **STUDDARD** became acquainted with her.

On one occasion, Mrs. **OSWALD** mentioned that she had a son whom she had not heard from since 1959, stating that she did not know whether her son, who Miss **STUDDARD** believes was **LEE OSWALD**, was alive or dead. Mrs. **OSWALD** advised that she thought **LEE** was in Russia.

Mrs. **OSWALD** also stated that she had another son, who was living in Fort Worth, Texas.

During the time that she lived at 612 Hurley, Fort Worth, Mrs. **OSWALD** was employed in a cleaning establishment nearby. During the period that **PAULA STUDDARD** was staying with her sister and brother-in-law on Hurley Street, Mrs. **OSWALD** left this address stating that she was going to Wichita Falls, Texas, to be a companion to a woman in that city.

PAULA STUDDARD could not recall whether Mrs. **OSWALD** had a car at this time and she further could not recall if Mrs. **OSWALD** had any associates or acquaintances who visited her.

DYAL CURRIN QUARLES was advised of the identity of the interviewers as Special Agents of the Federal Bureau of Investigation. He furnished the following information:

In the latter part of 1960 or early 1961 when he was residing in the vicinity of Eighth and Hurley Streets, Fort Worth, Texas, with his then wife MARY ANN, he was acquainted with Mrs. MARGUERITE OSWALD, who resided in the same apartment building in an upstairs apartment.

QUARLES stated that although he could not recall the exact address of this apartment building he did recall that it was in a building with three apartments, two downstairs, and one upstairs. The landlord was an individual who operated a combination jewelry and antique store, as well as a watch repair shop located in a shopping center in the close proximity of the apartment building. QUARLES could not recall the name of this man.

Mrs. MARGUERITE OSWALD visited in QUARLES' apartment from time to time and QUARLES and his wife returned the visits to Mrs. OSWALD's apartment occasionally. QUARLES recalled that Mrs. OSWALD worked in a dry cleaning establishment nearby on Eighth Avenue where she was employed as a seamstress and also waited on customers.

Mrs. OSWALD advised QUARLES that she had a son named LEE who had gone to Russia approximately six months before and whom she had not heard from for some time. Mrs. OSWALD frequently referred to her son LEE, stating that the United States officials in Washington, D. C., with whom she had been in touch knew more about her son's location than she did. She indicated that she had contacted the United States State Department and a Congressman, however, they would tell her nothing concerning her son's residence in Russia. QUARLES recalled that he asked Mrs. OSWALD why her son went to Russia and she replied that she did not know why he had gone.

Mrs. OSWALD on one occasion advised QUARLES that

she had two other sons in addition to LEE, one of whom QUARLES believes was in the U. S. Army at the time.

QUARLES recalled that during the time that Mrs. OSWALD resided in the upstairs apartment at the address in Fort Worth, she was visited from time to time by an individual who was unknown to QUARLES, however, who was described by QUARLES as being a white male in his early 40's, dark complexion, and usually wearing dark glasses and a hat. He was dressed neatly to QUARLES' best recollection. Mrs. OSWALD advised QUARLES that this individual was her boyfriend.

On one occasion Mrs. OSWALD came to QUARLES' apartment to ask QUARLES if he would give her some advice relative to her dismissal from the dry cleaning establishment where she had been fired. She asked QUARLES if he would accompany her to this dry cleaning establishment, with which request QUARLES complied. On this occasion, Mrs. OSWALD went to the dry cleaning establishment and engaged in a bitter argument with the owner of the dry cleaning establishment relative to her dismissal.

Mrs. OSWALD moved from the apartment building advising QUARLES and his wife that she was going to West Texas to obtain work as a maid or cook with a wealthy family. QUARLES did not know the name of the city where she went to live. He recalled that at the time he knew her, she was driving a 1954 Buick and he believes she drove this car when she moved out of the upstairs apartment.

During the time that QUARLES knew Mrs. OSWALD she informed him she had previously resided in Louisiana and that she had lived some time in New Orleans. She also indicated that she had moved around from city to city in the United States quite a lot.

Mrs. TAYLOR stated that a few weeks after the OSWALDs moved into the apartment, ROBERT married and moved away from this address. She stated that LEE was 16 years of age and about three months after they moved into the apartment, he became 17 and at that time he quit school and enlisted in the United States Marines. He was attending Arlington Heights High School at the time he quit school. She stated that she never did see LEE OSWALD after he enlisted in the United States Marines. She also stated that she has never seen Mrs. OSWALD or ROBERT since the mother moved out of this apartment on June 1, 1957.

During the time Mrs. OSWALD resided at her apartment, Mrs. OSWALD was engaged in selling ladies' hose in a shoe store in Fort Worth. She stated the store was Paul's Shoe Store. On one occasion, Mrs. OSWALD told her that she had been fired from a job because she refused to do some chore which the manager requested.

He thought that on one occasion he saw OSWALD having coffee at a restaurant, but he was not certain. WATSON said if he did, it would have had to be the restaurant at the Clifton Hotel, the Beckley Cafe, or the El Fenix as these were the only restaurants WATSON frequented while residing on Beckley.

WATSON said he never saw OSWALD talk to anyone at the rooming house, but on occasion OSWALD would be in the "television room" and if anyone else came in, OSWALD would return to his room. OSWALD was usually dressed in white or light trousers, a T-shirt, or a sweater. Outside of this, WATSON claimed he could furnish no information about OSWALD because OSWALD actually never talked to him and WATSON never saw him talk with anyone at the rooming house.

LEE OSWALD, 7408 Ewing, Fort Worth, Texas, was born October 18, 1939. Parents were listed as Mrs. MARGUERITE OSWALD - mother, and EDWIN EKDAHL - step-father. Mrs. MERRETT advised LEE OSWALD entered the Lily B. Clayton School, Fort Worth, Texas, as a first grade student on January 27, 1947, while residing at 1505 Eighth Avenue, and was passed to the second grade at the conclusion of the school year on May 30, 1947. Mrs. MERRETT advised the records do not indicate where LEE OSWALD attended the second grade. OSWALD completed his third year of elementary school while in attendance at Arlington Heights Elementary School, Fort Worth, during period September 8, 1948, through June 3, 1949. Mrs. GREEN stated she had called because she recalled seeing OSWALD's picture in the "Fort Worth Star Telegram", she believed in the Summer of 1962. She stated she desired to make this known to the FBI if they had not checked the old editions of the "Fort Worth Star Telegram."

Mrs. GREEN stated also that she had been contacted by a representative of the "New York Times" and also of the "Fort Worth Press", and she had told them what little she recalled about LEE HARVEY OSWALD. Mrs. GREEN stated she had given a sixth grade class picture to "Life" magazine which group picture included a photograph of LEE HARVEY OSWALD.
