FRANK M. MIJARES, JR., 7234 Eagle Pass Street, Houston, Texas, was interviewed at the United States Public Health Service Hospital, New Orleans, Louisiana, where he was receiving treatment as an outpatient.

He advised that he is presently a crew member of the SS Leslie Lykes and during Voyage 110 of the SS Marion Lykes in September - October of 1959 had served on that vessel as bedroom steward.

After examining a photograph of LEE HARVEY OSWALD, MIJARES said that he recalled OSWALD as a passenger on the SS Marion Lykes in the fall of 1959. MIJARES stated that OSWALD was not inclined to do much talking and at no time told him the reason for his making the trip to France or talked about himself. MIJARES said he recalled that after the first and second days, subsequent to sailing from New Orleans, OSWALD had instructed him to leave the cabin, which he shared with another young man, alone and for this reason he assumed that OSWALD was sea sick during this period. He also recalled that OSWALD subsequently reprimanded him for not having mopped the floor of his cabin to his satisfaction. According to MIJARES, when OSWALD got off the SS Marion Lykes he did not say goodbye and did not leave a tip.



NY T-1 advised Secret Service that he had contacted BRACKEN on November 24, 1963, at which time BRACKEN was alleged to have made the following comments regarding the assassination of President KENNEDY:

"It was not an isolated thing, that sort of thing exists in the minds of a group on the west coast. This group has spoken of a revolution and has unlimited financial support."

On January 8, 1964, Mr. SIGBERT BORG, Livingston Hall, Columbia University, 116th Street and Broadway, New York City, made available to SA FRANCIS J. O'BRIEN the records of Columbia University. A review of same disclosed that the building located at 431 Riverside Drive is known as Woodbridge Hall and is occupied by students attending Columbia University. The records failed to reflect any information concerning one ALEXIS H. DAVISON at 431 Riverside Drive, New York City.

Mr. BORG stated that he was personally acquainted with Captain PETER H. DAVISON, who resided with his wife at 431 Riverside Drive from September 1, 1962 until August 31, 1963. BORG stated that Captain DAVISON was in the United States Air Force and while at Columbia University had attended the Russian Institute. BORG stated that Captain DAVISON, prior to his departure from Columbia University, had been raised to the rank of Major in the United States Air Force and after his year of study he returned to the United States Air Force Academy at Colorado Springs, Colorado. BORG advised that Major DAVISON was originally from Atlanta, Georgia, and that his parents still reside there. BORG commented that, at one time, Major DAVISON had been assigned as an Air Attache to the United States Embassy in Bonn, Germany. Enclosed for each the Portland and Albuquerque offices is a copy of a letter written by one David C. Glass, Camp 9, Beatty, Oregon, to the Attorney General. Copy also enclosed for Dallas.

The Portland Office should immediately identify Glass, check indices concerning him and thereafter conduct interview of him for purpose of obtaining any information in his possession pertinent to subject or to the assassination of the late President Kennedy. The Albuquerque Office should promptly identify Rosa Doerfer and One Jane Murphy and check indices concerning these individuals. Thereafter, both women should be interviewed concerning their knowledge of David C. Glass. In addition, each should be questioned concerning any information they may possess bearing on the assassination of the late President Kennedy or their knowledge of Lee Harvey Oswald.

Handle immediately and set forth results of investigation in report form suitable for dissemination.

DETAILS:

On January 15, 1964, SF T-1 advised that she had received the information set forth below from a neighbor, Miss BARRIE MILLMAN, who is a student at the University of California, Berkeley, California.

MILLMAN is reportedly engaged to a graduate law student at the University of Mexico in Mexico City. SF T-1 did not know this individual's name at the time she initially contacted this Office.

BARRIE MILLMAN visited her fiance in Mexico City during Christmas time, 1963, at which time he told her that he had met LEE HARVEY OSWALD during OSWALD's "last trip to Mexico".

Elaborating further, SF T-1 related that MILLMAN explained that at the Friends Service Center, Mexico City, her fiance met an American, name unknown, who wanted to go to Cuba and make a first-hand report on the situation there. Later Miss MILLMAN's fiance again met this unknown American at Sanfords Restaurant, Mexico City, and on this occasion, the unknown

American was accompanied by a person MILLMAN's fiance later realized was LEE HARVEY OSWALD. On the occasion of this meeting the unknown American and OSWALD reportedly told MILLMAN's fiance that they were working together to get visas for travel to Cuba and that they planned to go to Cuba together.

On January 16, 1964, SF T-1 advised that she had just learned the identity of Miss MILLMAN's fiance, who is studying at the University of Mexico Law School. She identified this individual as one AMO ALGOZAK and indicated that he is due to graduate from the University of Mexico Law School sometime during February, 1964, and has a grant for study in France.

Miss BERNARD said that she telephoned DUFF's uncle, WILLIAM McEWAN, at South San Gabriel, California, at which time she was told that DUFF was a pathological liar. McEWAN told her that DUFF had never worked for Boeing at Seattle and that he had sent DUFF money to take the bus from Seattle to the Los Angeles area.

Miss BERNARD advised that DUFF's British Passport, No. G.213108, indicated that he was a British subject; however, this passport expired 10-19-61 but she has it in her possession since he left it with some of his possessions after he was "thrown out". In this passport book, Miss BERNARD advised there was a photograph of WILLIAM M. DUFF, AF No. 19607309, indicating previous service in the U. S. Air Force. She said there was also a stub for shoe repair, No. 8622, Family Shoe Service, 505 West Lancaster Boulevard, Lancaster, California. However, on the back of this stub was printed the name "MARGARET FAIRCHILD, Box 109, Monte Vista, Colorado."

Miss BERNARD advised that she did not know the significance of this woman's name, but assumed that it was another one of DUFF's girl friends. She also said that it was possible he would contact his uncle, WILLIAM McEWAN, at South San Gabriel, California for money, since he had done this in the past.

On 1-12-64, Mr. DON MAY, General Clerk, Identification Bureau, Dallas Police Department, advised that Dallas PD Record 52495 for WILLIAM McEWAN DUFF, 4919 San Jacinto, Dallas, indicated that he was arrested 4-18-63 for investigation of swindle and released 4-18-63. DUFF's FBI Number is 483264E. He was also arrested by the Sheriff's Office, Los Angeles, California, on 12-11-60 for drunk driving under Sheriff's Office No. B743533.
